(A). Broad outline

Following is submitted:

A.1). Had my son or Daughter being at the helm of affair in India (like Prime minister) myself would have asked them to do all the requisite work (conceptualizing, planning, documenting, disseminating it to the masses, discussing and the implementing alongwith mechanism for feedback and correction) needed to sort out this menace of severe

pollution in Delhi and other places of India without any fear or fervor or noise and that to without attaching any extra motive in the situation (i.e. searching opportunity in this emergency – आपदा में अवसर) like issuing ill-conceived, half cooked and unsustainable order of switching to Odd and Even formula (i.e. indirectly promoting sale of vehicles) or order of discarding ten year old Diesel vehicle and fifteen year old petrol vehicles or promotion of battery operated Vehicles (EV) or going with the advice of so called scientific community suggesting graded response system and artificial rain or even using 24×7 sprinklers near the pollution data monitoring station to misrepresent the data and befool the self and public rather concentrating on what is the need of the country and its citizen, on how to contain explosion of Population and vehicles, and on searching/finding the optimums of population, vehicles, houses, forest and tree cover and all that is needed to ensure all kind of cleanliness and hygiene (land, air, and water, physical, mental, and religious/spiritual).

Had my Son/daughter being at the helm of affair in India (like Prime minister) than this letter would not have required but since they are hence myself left with no other option to submit it to the common people of India who makes or breaks the government and through them to the officiating prime minister (and other dignitaries including her excellency the president of India) to do the following which are submitted below with proper reasoning, logic and roadmap:

- (v). PricewaterhouseCoopers (PwC) India: PwC is one of the Big Four consultants with strong government advisory work. According to RTI-based reporting, PwC has won many government assignments. They are listed in government-approved consulting firms for e-governance projects.
- (vi). Deloitte India: [Deloitte (India) is included in the list of Tier-I consultants for government / e-governance in official government vendor lists. They have a Government & Public Policy consulting practice.]
- (vii). Ernst & Young (EY) India: [EY is often hired by government bodies. For example, NITI Aayog has used EY for various projects. Their consulting services cover risk, technology, operations, and public-sector strategy.

Viewing at the number of foreign consultants engaged [by NITI (National institute for transforming India) Aayog, PMO, different ministries and other government entities] their ever increasing business turnover from India, it can safely be said that the entire think tank, entire bureaucracy, and entire political class (in power or in opposition) of the country collectively have failed to deliver a healthy and happy life to the citizen of India and its genuine guests.

On the other hand Saints and Sages who are supposed to do this job (of giving consultancy to the government and guiding the classes as well as the masses, found to be busy in either parroting the sermons from old testament or holy scriptures or conducting Bhagwat katha to the unconcerned people who are hardly related with any policy decisions and thus found to be involved in creating environment of frustration, hopelessness and helplessness in the country. The PM reminded citizens that India's strength lies in its people, innovation, and commitment to self-reliance, urging every Indian to contribute to nation-building, whether by buying India-made products or participating in scientific, technological, and entrepreneurial ventures to

ii). Statement of Mr. Mukesh Ambani-CMD RIL (dated 29.08.2025, AGM of RIL)

ensure a prosperous, powerful, and developed Bharat-India."

It has been my privilege to serve your company since its inception and to attend every single AGM of Reliance for the past 48 years. This has given me the opportunity to watch and participate in every phase of Reliance's evolution.

I have also witnessed India's incredible journey in these five decades from a third world country to one now on the threshold of becoming a first world power. The most important lesson this journey has taught us is that there is no substitute for economic strength.

This lesson is reinforced by recent geopolitical developments. India must gain greater economic strength and do so with a sense of urgency. iii). Statement of Mr. Gautam Adani (Adani group): Adani Group chairman, Mr. Gautam Adani at IIT Kharagpur's on Aug 19, 2025,

"The world was moving from conventional wars to technology-driven wars of power, and our ability to prepare would decide our future. The wars today are fought in server farms, the weapons are algorithms and empires are built in data centres. The armies are botnets," Adani said. Pointing out that 90% of the country's semiconductors were imported and that one disruption or sanction could freeze our digital economy, Adani said, "We import 85% of our oil. A geopolitical incident can restrict our growth. When our data crosses India's borders, every bit of it becomes raw material for foreign algorithms, creating foreign wealth. Many of our military critical systems are imported, binding national security to political will. We must fight for the freedom of self-reliance,"Adani said."

Mr. Gautam Adani at IIM Lucknow on 7 Aug 2025, said that "The future belongs to those who maximise possibility, and maximizing possibility means stepping into an unknown territory," he said. Mr Adani advised the students to trust their instincts when "data runs dry". "That is how the future is saved, not through corporations but through courage," he said. He also said that it was the "bold path – the one filled with risk and resistance – that shapes leaders the world remembers".

(A.1.2). Note on the views of the Prime minister of India, Chairman RIL and Chairman Adani group: It is quite natural that every Indian will admire such a sentiment of positivity toward their country becoming self-reliant and as such we do also admire the same, however In the

circumstance wherein entire Indian government appeared to be guided by the multinational firms (which do not appears to be keeping basic tenets of Dharma as their founding principle) and wherein almost all the Saints, sadhus and fakir are found to be diverted toward lesser needed ritualistic discourses, we thought it proper of requesting directly to the people of India (including NRI's), and requesting them to approach the large and mid-level business entities of India, or the firm whose majority of board of director can appreciate "Bhartiya concept of Dharma, Artha (economy), kaam (work), Rajniti (Politics), Rajya (Country and governance), and Moksha (Freedom)" to 'venture into the necessary national and international consultancy work' and took part in building the nation and guide the world.

This is (consultancy firms whose majority of board of directors understand basic tenets of Dharma and appreciate Bhartiya concept of Dharma, Artha (economy), kaam (work), Rajniti (Politics), Rajya (Country and governance), and Moksha (Freedom)") required because it is where from the shift begins. Currently what is happening is people need Aata (wheat flour – food grains) but the government is talking of providing cheap Data (for mobile) and is devoting its time and energy on the creation of framework for Data centres and its support services – an unfortunate act.

Amongst the wise ones of old it is a broader agreement that for the best results ratio of Indian to foreign consultants firms (and number of individuals in such firms) has to be approximately seventy five percent (75%) to twenty five percent (25%) which have to have the blessing. A.2.1). Short-Term and Emergency Measures

- I. Vehicular Restrictions: Implementing odd-even schemes for private cars, banning the entry of non-essential trucks and older diesel vehicles (BS-III and BS-IV) into Delhi.
- II. **Halt Construction**: Suspending all non-essential construction and demolition (C&D) activities to control dust, with strict enforcement of dust control measures at allowed sites.
- III. **Waste Burning Ban**: Strictly prohibiting the burning of municipal solid waste, leaves, and biomass, with night patrolling to enforce the ban.
- IV. Water Sprinkling/Anti-Smog Guns: Deploying water sprinklers and anti-smog guns, especially in high-traffic and construction zones, to suppress dust.
- V. **School Closures/Work From Home**: Temporarily closing schools or shifting to online learning, and issuing work-from-home directives for government and private offices to reduce commuting.
- VI. Artificial Rain: Exploring and piloting technological interventions like cloud seeding to induce artificial rain and wash away pollutants, although effectiveness is debated and weather dependent.

A.2.2). Short-Term and Emergency Measures Long-Term Policy and Infrastructure Solutions

Sustainable improvement relies on systemic changes addressing root causes.

- I. Improve Public Transport: Augmenting the public transportation system with more buses and metro frequency, improving last-mile connectivity, and regulating auto-rickshaw fares to disincentivize private vehicle use.
- II. **Promote Electric Mobility**: Shifting public and commercial transport to electric vehicles (EVs) or CNG, offering subsidies and incentives for EV purchases, and developing charging infrastructure.
- III. Industrial Transition: Relocating polluting industries from residential areas, forcing all industries to use cleaner fuels like PNG (Piped Natural Gas) or biomass, and converting brick kilns to less polluting "zig-zag" technology.
- IV. **Stubble Burning Alternatives**: Providing subsidies and machinery (like Happy Seeders) to farmers in neighboring states to manage crop residue without burning, and developing a supply chain for using the residue for energy production or composting.
- V. **Waste Management**: Ensuring net-zero waste to landfill through comprehensive waste segregation, door-to-door collection, and waste-to-energy initiatives to eliminate open burning.
- VI. **Urban Greening**: Substantially increasing green cover by planting more trees and developing green belts to naturally filter the air.

A.2.3). Short-Term and Emergency Measures Individual and Community Actions

Citizen involvement and awareness are crucial for success.

I. Reduce Vehicle Use: Opt for public transport, carpool, walk, or cycle whenever possible.

- II. **Conserve Energy**: Use energy-efficient appliances and turn off lights and electronics when not in use to reduce demand on power plants.
- III. **Avoid Burning**: Do not burn garbage, leaves, or wood for heating.
- IV. **Protect Yourself**: Wear high-quality masks (e.g., N99) when outdoors on high pollution days and use indoor air purifiers if possible.
- V. **Report Violations**: Use government apps, like the Green Delhi app, to report pollution sources like waste burning or construction violations

A.2.4). Note on the views of Google (AI): Following is submitted

In such a bizarre situation wherein most of the people in and around Delhi suffers of SMOG except that of people live in the vicinity of Delhi's only reserved forest of 3100 acres it can easily be concluded that the difference is only of the forest and tree cover, which inter-alia suggest

that we should plant more and more tree and have large forest cover spread across the country. .

:

A.3.1). Without entering into much of the history, any blame game, causes and conspiracies, it is submitted that the forest and tree cover which used to be 59% (fifty nine percent) before the enactment 1860 forest law by Britishers found to be approximately 33% (thirty three percent when Britishers left India in 1947. This area of 33% was reduced to 19% (nineteen percent) after the green revolution (during green revolution in place of planting more trees forest was cut to pave the way to the farmers in the name of ensuring food security to exponentially increasing population) which currently has gone up to 21% by one set of information and gone down to 14% (forest and tree cover of India is just fourteen percent) by another set of data and information.

Looking at the above mentioned dire situation of pollution and forests and tree cover in India following submission is made so that the forest and tree cover can be made up to its optimum level of 37% (thirty seven percent forest and tree cover is said to be optimum as per the scriptures which is equated forest and tree cover to that of hair and capillus in the humans (Man/woman).

A.3.1.1).Submission:

i). India has recently issued (on November 19, 2025) 21st installment of the PM-KISAN scheme to over 9 crore farmers, which indicates that there exists nine crore farmers, records of which are available with the government. My submission to the government of India is that that we can entrust these nine crore farmers with the afforestation scheme wherein every of these nine crore farmers will plant 100 trees (hundred tree) in their agriculture land and raise it for two years after which they can sell it to government for which each farmer will receive plantation

cum maintenance allowance of rupees one per tree per day (that is each farmer will receive 73000 thousand after handling over two year old hundred plants and planting them to site suggested by local member of parliament. Further to implement this scheme an advance amount of rupees ten thousand to each of the farmer (as a seeding amount) can be issued and after every six month and uploading of the photograph of plants (on the site of Forest and environment ministry, or agriculture ministry) installments of rupees ten thousand can be issued and a full final payment can be issued after the relocation of the plant at the suggested site by the local member of parliament. It is submitted that the entire scheme must be handled by the government of India through its elected member of parliament in Loksabha. It is also submitted that the government can fine tune the scheme and announce its implementation at an earliest convenience.

ii).
