

This invocation is specially being done to those who at time feels that the system should be just, uncomplicated, natural and based on nature, are already working in this direction and do feel the need for interlinking of such groups to ensure

Social security (social security means security of Fresh air, drinkable water, eatable food, wearable cloths, livable shelter, facility of Health, Justice and Education on payment as per once grace and gratitude, space for once creative pursuit etc.) to everyone in the society at a faster pace, and as such it invites warriors, leaders, politicians, Professionals, teachers, professors and laureates, cooperatives and corporates to come forward and join hands for the creation of an orderly system of natural laws, of dharma and to have healthy happy holy societal environment. After witnessing Pahalgam terror attack and the overall scenario which has unfolded after this, it become quite clear that providence of physical safety (24 \times 7 at every nook and corner of the country) cannot be left out at the national government alone and society itself has to wake up and take up the task of providence of physical safety to each of its member in its own hand. As the situation is alarming hence it is an opinion of the elders in the society and masters in the area that at least fifty percent of total deployment i.e. four crore security personnel must be recruited and deputed by the society within one year time (that is June -2026) and balance four crore by the year 2029, and then maintain number of security personnel deputed in the field at the optimum level of six percent of total population.

It can be said that we all are a thoroughly selfish persons and from every quarter we all wants goodness for self but at time most of us come across such a weird and horrific situations that every one of us do feels that system should be just, uncomplicated, natural and as per the dharma (basic religion) for everyone on the earth.

We all feel occurred/weird/hurt/pain when beggars, in the form of handicapped, children, men and women ask for alms at traffic signals and at places of worship. And of course we all get hurt whenever we have to submit to the people even for small favour even if we do not feel pain when people submits to us for very small favour and this is true for every one of us irrespective of what brand of concurrent

religion (Hindu, Jews, Buddha, Jain, Christian and Muslim etc.) we are born into or converted to or even like/loves).

All the concurrent religions appear to have failed and are becoming irrelevant, because, when one has a problem and he/she goes to a religious place, he/she receives only sermons, sermons from priests either of his/her own creation or excerpts from some holy texts and matters end there, without any real and visible support. All these Temples-Mosques, Monasteries and Churches which have witnessed closure and put under lock and key basically sent in a message that these center of worship and its preacher has become irrelevant and have put serious question mark not only on sanctity and continuity of all these centers but also in the continuance of these centers as well as mundane rituals these centers use to perform. In such a situation, it is useless and senseless of any one claiming himself to be its contractor and saying that his religion is best and risking their life or taking others life in its name. Further in such a situation will it not be prudent for all of us to divulge on the issue with an open mind and big heart and decide whether such centers deserve to be abandoned or permanently closed or respectfully exterminated or let out for other purposes including museums for history and tourism.

It may also be noted that maybe because of this severity of situation that founders of various religion put together must have envisioned that the twentieth century (concurrent time) will be critical, and as per founders of different religion it will be either the time of doomsday, or incarnation of new Messiah, or rebirth of Buddha or coming of new messenger of god or a great churning or just a time of transition to new era?

Subject: Terror attack-Pahalgam, India: 'A Call for National Awakening - Restoring Security, Reviving Dharma, and Reuniting Bharat with Pakistan and Bangladesh '- Regarding.

Respected Excellency Smt. Droupadi Murmu

Following is submitted: is barbaric, allowing barbaric to take centre stage to create more barbarism, it needs thorough discussion and deserves bold implementation, in India and the world.

What happened in Pahalgam on 22.04.25 is barbaric, allowing such barbarism to take centre stage will only lead to witnessing more barbarism. This incident deserves thorough discussion and bold implementation of solutions, both in India and across the world.

The impact of this act will not end with condemnation, prayers for the departed souls, or financial aid to the victims' families. Nor will the root issue be solved by attacking POK, acquiring it, or even taking over the whole of Pakistan and Bangladesh.

Religious killings of this nature were also witnessed in Punjab during the nineteen-eighties. These incidents raise a few important questions that nobody seems to be asking:

(I). Why is the entire society being debarred from securing itself, left solely to the mercy of police and army personnel, who constitute less than one percent of the total population? How can 1% protect the remaining 100%?

According to traditional standards—derived from tribal systems and the fundamentals of Dharma the Sanatana — 6% of the population between the ages of 25 to 50 should be actively involved in the direct security of society.

(II). During the COVID emergency, all religious centers were forced to shut down—at a time when people arguably needed them the most. This act clearly exposed the redundancy of these existing religions, rendering them null and void, like dead entities.

If this is so, should we not be discussing the Resurrection of Dharma (the basic religion) rather than engaging in verbal or real conflicts, clashes, fights and wars over those religions that have already failed to offer ray of hope during the global lockdown and collapsed before viruses, bacteria, and administrative authorities?

(III). Does it not appear a game plan to drag India to enter into conflict, to buy more and more arms and arsenal, or even dragging India in a continuous conflict like that of Russia and Ukraine, or Israel and Hamas, becoming more and more dependent on these so-called self-declared big bosses of the world?

(IV). The basis for the formation of Pakistan was religion and manipulation by the British. Now that both factors have faded—one immediately after independence, and the other during COVID (when religion itself lost its relevance/significance)—there remains no logical reason for Pakistan to continue to remain as a separate entity.

It would be beneficial for both Pakistan and Bangladesh to hold a general referendum in their area and consider merging with the remaining part to become one Bharat.

-The solution does not seem to lie with the current political leadership or religious streams of India, Pakistan, or Bangladesh. This issue requires urgent national and regional dialogue.

In continuation of my posts dated 24.04 and 26.04.2025 in the social media and submissions by emails to the dignitaries mentioned herein, following is further submitted:

Submission in this letter is made after thorough observation (since the year 2003) of the process of governance, communication with the top political leadership of country (congress and BJP), interaction with large number of leaders in social, economic and religious sectors, interactions with the Fakir and Saints (acknowledgement letters to such effects can be seen in personal profile in LinkedIn and Facebook) and spending some time in solitude and as such can say to deserve proper attention, response and deemed actions of fellow citizens of India.

Brief of earlier two letters on the issue (dated 24.04 and 26.04.2025):

1. Brief of letter dated 24.04.2025

(A). What happened in Pahalgam on 22.04.25, is barbaric, allowing barbarity to take centre stage to create more barbarism, it needs thorough discussion and deserves bold implementation, in India and world.

The impact of this act won't end with condemnation and prayers for the departed soul, financial help to the family of victims and neither will it solve the basic issue by attacking POK and acquiring POK or even entire Pakistan.

This type of religious killing used to happen in Punjab also in the eighties.

- **(B).** This incident raises few important questions which nobody appears to be asking:
- i. Why is the entire society being debarred from securing themselves leaving them on the mercy of the security of the police and army (which is even less one percent of total population). How 1% people will be able to secure 100% of the population.

As per standard (derived from tribal and basics of Dharma the Sanatana) six percent of the population between the age group of 25 to 50 (that is eight crores plus in India's considering current population of India to be of 130 crores plus in which four crore female providing internal security and four crore males trained to tackle external security) must be deployed in direct security of the society.

- ii. COVID by forcing all religious centres to shut during an emergency when people wanted it more, has clearly and boldly declared all these concurrent religions as null and void, like a dead entity. If it is so then should we not discuss the resurrection of dharma (basic religion) rather than indulging in verbal or real clash, fight or even war on those religions which couldn't give a ray of hope during worldwide lockdown and succumb to virus, bacteria and administrative agencies?
- iii. Does it not appear a game plan to drag India into conflict, to buy more and more arms and arsenal, or even dragging India in a conflict like that of Russia and Ukraine, or Israel and Hamas, becoming more and more dependent on self-declared big bosses of the world.
- iv. Basis of the formation of Pakistan was said to be religion and manipulation of Britishers. Now when both the reasons for formation have vanished, one immediately after the declaration of freedom and another during Covid (when

religion itself becomes irrelevant) there remains no point for Pakistan to remain separated. It will be good for Pakistan (and Bangladesh) to have a general referendum in their country and merge with its left over part and become one Bharat.

v. The solution doesn't appear to be available with concurrent leading political class and religious streams of India and also with that of Pakistan and Bangladeshi. Citizens of India, Pakistan and Bangladesh are requested to do the deemed and avert any future mishap.

(2). Brief of letter dated 26.04.2025

(A). Probable game plan of terror attack in Pahalgam-India indicates that the 'terror attack in Pahalgam was a staged act (cold-blooded and barbaric act appears to have been conceived with a proper planning, then staged in a barbaric way and in a cold-blooded manner) and appears to have been conceived aiming a larger fallout.

In the spiritual circle it is being said that the terror attack in Pahalgam- India dated 22.04.2025, was staged by the following multinationals companies:

- i). Mining multinationals which are eying mainly fifty eight lakh tones of lithium reserves in Jammu and Kashmir. It is being discussed that modus operandi of these lithium miners appears is to first create social rift and strong sentiments against Pakistan and when the war broke out create fire in the forest of these mineral rich area (like the fire which recently had been created in the forest of Amazon, Australia, Myanmar (Rakhine area-Rohingya), Los-Angel and other part of USA so that a clean slate is made available for mining.
- ii). Multinational companies who earn from tourism in Switzerland.
- iii). Multinational companies which earn from supplying dynamites and bombs, arms and arsenals, fighter jets, submarines and also earn by arranging and managing war between countries after countries like that of currently between Russia and Ukraine, Israel and Hamas.
- iv). Multinational companies which earn through their hospitals and Pharmaceutical business.
- v). Multinational companies which earn through their business of narcotics. This terror attack is planned to create scenarios in Kashmir like that of Punjab and Manipur in India and Columbia and Afghanistan in the World. These Multinationals are said to be getting all the support from CIA (cocaine importing agency or

cannabis importing Agency), OIC (Opium importing Organisations and WEF (Weeds exporting forum) to carry out their mischievous acts.

(B).Regarding how to counter these and how to avenge the barbarism committed enough is given in the book Alternate economy (for free download: resurrectionofdharma.com).

Section -B,

- (1). Discussion amongst the wise one's of old on the on-going situation especially which emerged after the terror attack in Pahalgam on 22.04.2025:
- (1.1). It is being said in the spiritual circle that the killing in Pahalgam and making our daughters and sister widow or orphaned is equally or more grave than the Kidnapping of mother Sita by Ravan, hence it is obvious that the elimination of perpetrator [that is its, planner and financer, story writers and directors, logistics providers and media handlers, actor (executors) and support staff] and advantage seekers in the aftermath of barbaric killing is round the corner.

As per quite a few Astrologers elimination of perpetrators will begin latest by December 2026 and will be completed by 2031 which will be followed by the establishment of good governance, which will to a large extent be completed by 2036.

It is being said in the spiritual circle that by the year 2031, the term Hindu, Jews, Buddha, Jain, Christian, Muslim and Sikhs will disappear and largely give way to the term Dharma and the term which will be used Dharma of Parents, Children's, Sister, Brother and Dharma related to service like that of Teacher, Student so on and so forth (there are more than forty term is being narrated in Wikipedia itself).

Further, it is being said that by the year 2031, Gold will lose its status, Share Market will vanish, Forced prostitution and pornography will be eliminated along with it, will eliminate the business of Lawyer, Teacher and Doctors, business.

By 2031 the providence of complete social security (that is physical security to live and that of Food, water, air, cloth, shelter, entertainment, health, education and Justice alongwith avenues for employment to all and probable support in one's creative pursuit) by the society itself will start functioning from Dharma Sansthan (religious institution or a centre of the Local government) and will be managed by proper and logical distribution of work and income/yield.

- (1.2). It is for everybody surprise that so called Satan's and Saints appearing to be in agreement when they are pointing toward future but it is said in spiritual circle that when Satan's and Saints come in distant agreement and point toward the same destination/future, the situation can really be said to be alarming/dangerous/turbulent.
- (i). The so-called Satan's, say that the situation on earth has become unlivable and earth cannot sustain the burden of a seven hundred crores plus of human population and if we wants earth to sustain than at least ninety percent of the human population must be terminated,
- (ii). While elaborating on present turmoil, the Saints while comforting masses are saying in a pleasing manner and merrier tone that the era of truth (Satyug) is coming, wherein everybody will lead a healthy, happy and holy life. In Satyug there will be a total of thirty-three crores of people on the earth and everybody will be like a deity, with plentiful resources at their disposal.
- (iii). If we compare versions of Satan's and Saints, then it will be surprising to note that saints are pointing toward a more horrific turn of events in coming days.

In such a situation what can society do? What is the solution? In the spiritual circle, resurrection of Dharma and Dharma Sansthan (Religion and religious institutions) is being suggested as a viable alternative over and above the forecasts/plans of Saints and Satan's.

In the spiritual circle it is being said that neither the older wisdom can claim a happy future without the Google, you tube, Wikipedia etc. and nor these Neo classics, technologies and gadgets can claim a happy future without the stories of parents and grandparents, masters and Gurus, a Hence, It is being said that the wider churning is necessary in the society so that the poison mingled in the system can be removed and nectar/essence can be shared, so that the society can sustain.

(2). On terrorism and War

(2.1). Terrorism:

Terrorism is like any other 'ism' (e.g. communism, communalism, regionalism and even religionism or rather born out of these ism's, and terrorism will end up only when all other of these ism's vanishes/disappear ends.

(i). Gandhi Ji was killed (in the year 1948) and the entire R.S.S. was made responsible and scores of people sympathizing with the RSS got arrested, across India (which include my father as well from Jhansi) Ms. Indira Gandhi was killed (in the year 1984) and the entire Sikh community was branded as killer and scores of Sikhs were mercilessly got killed. 9/11 (in the year 2001) happened in America and the many democratic people branded entire Muslims brethren as terrorists, and cooperated in the attacks on Afghanistan, (calling Taliban's as the main culprits), and started maintaining constant vigil on all countries with large Muslim populations. Along with it we must not forget how the Jews were being branded as main culprits of restraining growth of German were being killed in masses.

Surprisingly, from 15 August 2021, America itself allowed Taliban to take over the reign in Afghanistan, India itself made the Sikh as its prime minister, allowed RSS to be a main ideological front of India's concurrent ruling disposition and how entire wests cooperate with Jews.

Can branding of people of an entire organization, community holds and can holding of such views be appreciated? It is expected from the people of Jews community, Muslims community, people belonging to Sikh community and members of RSS who themselves being sufferer will not do anything which can fuel such branding or rather will do everything in their capacity to contain/restrict such branding if it is already been fuelled by some local or remote advantage seeker.

- (ii). Terrorist attacks in Mumbai and in parliament of India have been succeeded by purchase of arms of thousands of crores. Question does arise: can terrorist activity be not infiltrated upon by spending two-three percent of money and for validating arms from such field trials.
- (iii). Many of the multinational firms who deal with fuel oil reserves, mineral reserves, sales of arms and ammunition do want terrorism and terrorists should continue and serve their interest. It is an open secret that such firms not only promote hate, enmity between people on each and every pretext possible but also fund to organise clashes, fight and war and even world war.
- iv). Myself had witnessed the Bhopal gas tragedy (2nd December 1984) and seen many people taking various advantages of that crisis. My observation of last forty year will categorically be able to say that those who took advantage of the silent mass murders or didn't discharge their duties as is supposed to be done during that crisis, did not had normal death, whether they are Priests, Preachers, Politician, Doctors, Lawyers, Businessman and even Commoner, hence it is

personally submitted to the entire populace of the world please do not even try to take advantage (in any way) of the terror attack in Pahalgam, which made many of our sisters and daughters widowed or orphaned.

It is more often than not that these terrorist activities bring right-minded and kind hearted people together to work hard for harmony. Let's pray that these people understand the lesson of courage, freedom, and love and take the centre stage.

(2.2). War:

What people of (India) should do to Pakistan, if India listens to its few groups of people who (without properly ascertaining the involvement singularly of Pakistan in this terror attack) are feverishly and fiercely advocating attacking the Pakistan and finishing the very existence of Pakistan? Will India after attacking and finishing Pakistan, leave that geography for others to plunder and loot or will India acquire it and merge in India?

- (i). Wise ones among old asks, if the large section of the current Bangladeshis and Pakistani themselves repenting their mistake of separation and wanted to reunite with India, should India still go for war, or make effort and facilitate people in Pakistan and Bangladesh to have referendums in their respective country and allow them to reunite with India with proper welcome note and on equal footing.
- (ii). All Indians appear to be having deep memories of two great wars that are between Ram and Ravan, and the second of Dharma Yuddh Mahabharata. It may be noted that during the entire period of war even the Ravan and Dhritarashtra (Duryodhana) didn't block the supply chain of essential commodities to its adversaries that is Ram and Pandava, what to talk of things in reverse.

Affecting any supply chain of essential commodity (Water, food, air, electricity, medicine) and restriction in prayers or performance of last rite is against the nature hence not to be thought of and if done unknowingly than must immediately be reversed in a dignified way.

(iii). It is being in the discussion amongst the wise ones of old that if the blood of the current generation is boiling for to have a war, then why should India not go for a war with the Britain, whose credentials of being an enemy and mass murderer in Jaliyan bala bagh is clear, it may be possible that Pakistan and Bangladesh will also join us (forgetting all our mutual enmity of last fifty to seventy–five year and that too being manipulated and fueled by Britain). Maybe it will solve many of our other problems and that of people of many other countries.

(3). Basic definition Dharma (basic religion), Dharma Sansthan (religious institution to take care of basics) and Rajniti (governance with ethics):

(3.1). Dharma (Religion) – that which encompasses is Dharma, or Dharma is an essence of the entire earth (धार्यते इति धर्मः, धरा का मर्म धर्म है,), In Sanskrit they say, for Sansar (World-entire earth-Dhara) it is the Sanatana Dharma, whereas religion is the regional manifestation of dharma, 'Like; for Hindustan it is Hindu, for Judah it is Judaism (Jerusalem for Jews). Buddha, Jain and Sikhs are the main offbeat of Hindu whereas Christian, Muslims and Baha'i are the main offbeat of Jews (धर्म सम्पूर्ण धरा का और रिलिजन रीजन का).

Dharma stands by the virtue of freedom and virtue of love in all its magnanimity it offers and not because of inculcation of fear of ghosts and hell or by bullying in open and Punishment in jail among the masses which many religions are doing. Dharma is wholesome and provides holistic approach toward all transactions which life offers, it neither involves itself in business nor to support/favour business entities at the same time it does not become henchman, propagandists or frontal organisation of political or ruler or expansionists. Dharma never asks anyone to wear this uniform or have that haircut, 'read this and see that', 'listen to parroting of sermons while doing exercise (yogic or aerobic)' dharma basically engrossed in making life healthy and holy in a sustainable manner.

Dharma never asks anybody to sacrifice humans or its substitutes such as coconut or goat, buffalo, Sheep's, camel etc. in order to please the god. Dharma never asks anyone to castrate Bull and Buffalo or for male circumcision or mutilation of girl's genitalia for one reason or the other including forcing them to become celibate, or to safeguard them (boy and girls) from complete sacrifice by making and declaring them an entity which has already been symbolically sacrificed to the almighty.

Dharma also does not ask anybody to restrict growth of anybody be it human or tree and make them Dwarf and Bonsai. Dharma simply asks us to celebrate life and allow others to celebrate and eat that which maintains sanity of your mood and drink that which maintains sobriety of voice. Dharma never asks anybody to worship nor does dharma restricts anybody to worship in any way or any form (idol) or formless or even get yourself worshipped, dharma simply asks to follow the dictates of innate faith/consciousness and continue doing one's work-karma (one can also say; work is religion and work is worship). There is no exact word for Dharma in English; hence the word Dharma is used.

Entire world is one but a large family is the most basic understanding of Dharma, which hitherto many religions found to be reluctant to agree at first place unless they saw people of all creed and colour accept their version of religion. Now, an outbreak of disease and worldwide lockdown has proven beyond doubt that the world is one, had the world been not one, how come one disease could have possibly been able to affect the entire fraternity on the earth.

(3.2). Dharma-Sansthan (Religious institutions): Dharma-Sansthan is an institution which caters to the needs of the entire society in its entirety in a self-sustainable manner without any bias and prejudice. Such self-sustainable Dharma-Sansthan (Religious institutions) had been kept on working continuously (perennially) for ages. In fact, because of the perpetual working of this system, this system itself has been assigned the name Sanatana. Further, because the working of these Sansthan is observed to be performed with full Dharmikta (with full religiousness) hence this has been nicknamed as Sanatana Dharma. However, few say it is the other way round that because of the basic understanding of perpetuity these Sansthan could perform in a sustained manner.

Dharma Sansthan can said to be an institution which will offer food to hungry, water to thirsty, shelter to destitute, treatment to diseased, advice and justice to needy, help to helpless, employment to youth and respectable engagement to lonely and elders beside providing physical, financial, emotional security to all the individuals in its vicinity in a non-exploitable environment, so that there remains no destitution, forced begging and forced prostitution.

Due to obvious complacency which generally appears after a long term successful operation of institution and idiotic desire to improve upon even the perfection, society contributions in its own such institutions reduced thereby slowly and slowly, such institutes found to have become non-existent in the last three thousand years. These all religion—Hindus, Zoroastrians, Judaism, Buddhism, Jainism, Christian, Islam, Sikhism, Baha'i how so ever holistic each one claims it to be but the fact remains that none of these religion has been able to provide healthy and happy life style even to its disciples at equitable platform in a sustainable manner, hence resurrection of Dharma Sansthan can be said to be the only option so that the life on earth can find itself rejuvenated once again.

(3.3). Rajniti-Politics: Rajniti is an ethics of governance and also government functioning on the basis of ethics, whereas ethics is that which emanates from earth and its environment (नीति नियामक से आती है).

As the environment keeps on changing with the passage of time so the environment can say to a dynamic entity. Earth in comparison to the environment can be said to be a static entity. As Rajniti is firmly footed with Earth hence Rajniti can be said to be static but as Rajniti also reverberates with the environment hence Rajniti also becomes a dynamic.

In view of this mix, Rajniti is said to be an experience and its expression which is firmly footed yet flexible enough. In view of this definition it can be construed that Rajniti is not a Job/Profession but an engagement toward society for the collective good of society and its surrounding environment. Such Rajniti can be said to be performed by the persons whose basic family needs doesn't require his time and money i.e. at a time when his/her children got married, and involvement in such Rajniti can be continued till his/her children become available to take his/her place. This means the age for an active Rajniti (Voting as well as contesting an election) can be from fifty years to seventy-five years approx. After the age of seventy-five years such respected personalities generally would like to enter into educating and training the newcomers.

Politics is a profession and politicians are professional which definitely deserves equal treatment vis. a vis. other professions which hitherto required for smooth functioning of country and society. Politics is basically policing on set rules and regulation devised in Scriptures of religion and/or Constitution of country. As the Constitution of the country is static (remains more or less same even with the change of scenario and time) hence the constitution is generally found to be inept in dealing with the issues which appear at different times. There is no exact word for Rajniti in English; hence the word Rajniti is used.

- **(4).** Discussion amongst the wise one's of old on the on-going on Hindu dharma, Sanatana dharma and Sikhs:
- **(4.1).** The most talked about term during the dastardly/ghastly/ barbaric act of terror in Pahalgam and thereafter comes out to be is of Hindu Dharma, which scores of people including leaders in all walks of life are pointing towards that Hindu Dharma is singly being targeted and is in danger and must take recourse.

In this regard, myself feels sorry to say that in my endeavour in the last twentythree years plus failed to find a single literature, even a single paragraph, poem or sloka in the entire revered text including that of Ramayana (Balmiki) and Gita which states something about the brand- "Hindu Dharma or Sikh Dharma or even the Sanatana Dharma", like we find about the religions: Jews, Buddha, Jain, Christian, Islam and Baha'i.

(4.1). Supreme Court of India in its judgment on Hindu Dharma could only say that the Hindu Dharma is a way of life but couldn't elaborate what that way of life is.

They say (that the Hindu Dharma is the oldest known dharma whose dates and wherewithal is not known and can say to be that Hindu Dharma is Perennial, Perpetual (in English), Sanatana or eternal (in Sanskrit), Javed or Dwami (in Urdu) and so on in different language differently. Oldest and known literature suggest that the practice which people used or started to follow near the Hill/ Mountain Judah named as Judaism (Jews religion) and that practice which people used to follow between Hindukush Mountain and Hind Mahasagar (Indian Ocean) given the name of Hindu, Hindus, Hinduism, Hindu religion or Hindu Dharma.

Regarding the religion being narrated as brand Sanatana Dharma, it can be said that 'Sanatana' is a characteristics/quality and not a noun hence neither the Veda's, nor the Manu Smriti, nor the Ramayana nor Gita have any single line which points towards any such brand of dharma like Sanatana Dharma, for example a famous sloka of Gita reproduced below use the term Dharma only and not that Of Hindu Dharma or that of Sanatana dharma:

"यदा यदा हि धर्मस्य ग्लानिर्भवति भारत। अभ्युत्थानमधर्मस्य तदात्मानं सृजाम्यहम् परित्राणाय साधूनां विनाशाय च दुष्कृताम्। धर्मसंस्थापनार्थाय सम्भवामि युगे युगे।। ॥४-८॥"

"Yada yada hi dharmasya glanir bhavati Bharat, Abhyutthanam dharmasya tadatmanam srijamayam 11 4-7, Paritranaya Sadhunam Vinashaya cha Duskritam. Dharma-samsthapanarthaya, Sambhavami yuge-yuge 11 4-8

[Which means: O' Bharat (Arjuna, the wise, the enlightened, entire world), whenever there is a ग्लानि (guilt/deterioration/melancholy/remorse) of Dharma, I recreate myself for the restoration of dharma, for the protection of the sadhus (gentlemen), for the destruction of the wicked/evil doers and makes the establishment of religious institutions possible in ages. The word Bharat has been referred for, Arjuna, the wise, the enlightened, and the descendant of great Bharat the Earth". The word Bharat has not been used here (in Gita) for this piece of land which is now referred also as India–Hindustan.]

- * Note: There should not be iota of doubt in the mind of any one, who so ever he/she is with respect to the authenticity of statements presented above that, if we are witnessing large-scale deterioration (in our day to day conduct with the self, with others and with the nature) then one can be assured that the churning in the world is already in process and large scale changes are about to come.*
- (ii). Sanatana means Shashwat in Sanskrit, Perpetual or Perennial or eternal in English, and Javed or Dwami in Urdu etc. Whenever and wherever scripture referred to the quality/characteristics of Dharma they described the same by using the term Dharma the Sanatana, whether it is Manu Smriti or any other prominent text. For more details on Dharma, one can also refer Wikipedia, wherein one will appreciate that Dharma (there is no equivalent word in English or in any other language) have numerous meanings and their interpretations covering all the aspects of life.
- (iii). Further, we also try to explain numerous meaning and interpretation of dharma in our two books, 'Dharyate iti Dharma (a revisit of Tao Te Ching by Lao Tzu) and 'Alternate economy (Topic no. 16, Management of economy from religious institutions)', which can be seen by freely downloading the book from website: resurrectionofdharma.com,
- (4.2). In recent time Guru Granth Sahib can said to be one scripture which answers many question people asked about the dharma but in reality revival of basic dharma which started by the Nanak and carried forward upto the tenth Guru (master) The Guru-Govind Singh got installed when the eldest child which was prepared, developed and given to serve the dharma, in most of the families in Punjab and few other parts of India made their own group forgetting the very purpose for which they were being raised.

This group of eldest son in each family made their own kitty and branded it as Sikh, stopped getting blessings of their parents and support by from their younger brothers and sister, hence even after having sufficient wealth found to be keep on infighting and prone to all kind of intoxicant (excluding cigarette, bidi) and become addicted to these. All the brothers branding themselves as Sikhs need to revisit the basic saying of Guru Gobind Singh ji and other gurus.

(5). Actions toward solution - series of referendum's,

Solutions to many of our problems In India which is discussed above and also given below can easily be initiated and manifested through referendum (like BREXIT in UK) for which we have to collectively come forward and do our bit and thus enlighten our life. Following three referendums can mark the way:

(5.1). "One nation – One election – One institution (People house of representation i.e. Loksabha)", and by abolishing all other constitutional power centres like State governments, house of representation of state (Rajyasabha), Municipalities, Panchayat, Mandi etc. By adapting to institution and process of "One nation–One election–One institution", country will be able to minimise wastages, reduce hatred and clashes, streamline governance, optimize taxation, become able to provide complete social security (e.g. of physical, of food, water, fresh air, shelter, clothing, health, education, justice, employment, entertainment etc.) and opportunities to foray into one's creative pursuits to all its citizens.

The following is submitted on the subject:

- (i). The term, "One nation- One election One institution" conceptually appears to be one medicine and medication by which most of the diseases that India is currently inheriting and because of which Indian people are facing immense problems will cease to exist. Implementation of this can easily be done by a similar referendum as the United Kingdom (UK) has recently done in the case of BREXIT through ballot paper only.
- (ii). Adoption of the norms of One nation-One election One Institution will pave the way for logical distribution of income/yield/resources and work/responsibilities amongst children (Son and daughter), self (husband and wife), parents(mother and father) and society (local and national government) in an equitable level of 12.5% or 1/8 which will eradicate gender inequality, indiscrimination, unemployment and injustice at one end and will provide all kind of social security (physical, financial, emotional and spiritual) to all of its citizens, it's genuine visitors, and will be able to take care of its flora and fauna, birds, animal and fisheries in a sustainable way leading to perpetuity.

This system of distribution of income and connected responsibility do suggest that two child (girl and/or boy) norm, monogamy (one unit of husband-wife i.e. two numbers), one unit of parent (one unit mother and father i.e. two numbers/bodies) and one unit of governance (local and national i.e. two numbers/bodies) can say to be the best way to lead a harmonious life.

And at the same time this system of distribution of income do indicate that with each increase in number of Children, matrimonial partners and governing unit share in the income of one or the other gets sacrificed and lead toward making disharmony in the family, society and country and as such suggests us to follow the norm.

Here one may individually disagree to follow the norm/trait on the number of children one has and number of matrimonial relationships one has sighting infringement of one's freedom and at a broader level it can be argued and also agreed upon but collectively what system we have, must be such which does not jeopardize one's right at the cost of other and as such suggest to have one unit of governance (local and national i.e., two numbers/bodies) only. This suggests that we need to abandon all the twenty-eight state governments, Rajyasabha, Panchayat etc., and go for "One nation- One election - One institution" (Loksabha) and local government under the leadership of member of Parliament with the help of local team of experts selected for the same period.

(5.2). One nation – one future – one culture: the social-economic-religious-political position on the production of cow meat (beef), its consumption and export, and the so-called rhetoric on the Cow — that Cow, River Ganga, Earth, and females who feed infants apart from one's biological parent are mothers and deserve equal status and respect as that of our biological mother, if India wants to live healthy and happy.

The following is submitted on the subject:

(5.2.1). They say that until the ill-treatment of the cow clan (many of these people regard Cow, a mother, equal to that female who breastfeeds and nurtures an infant baby in the absence of his/her biological mother, like Yashoda was for Lord Krishna and many other examples like that of King Akbar) — for any reasons like not providing proper food, water, shelter to the cow clan; daily injecting cow with oxytocin so that her nipple and milk-providing part becomes loose (which is generally used for ease in delivering the baby); or using automatic milk-milking machines; making cow pregnant with artificial methods of insemination; depriving cow to properly feed her calf; not providing proper food to male calves and leaving them in the open in the winter to die in the cold (since they become useless after the introduction of tractors); or castrating calves for them to become oxen instead of bulls — and finally, when the cow stops giving milk, then kicking it out to live in the open and survive by eating garbage, or being taken by some butcher to kill it either manually or in automatic meat/beef production centres and selling its flesh for eating in India or a foreign country, its skin to be used as leather shoes or garments after treating it mostly in tanneries (situated mostly near rivers, which pollute rivers including Mother Ganga), and its horns and bones in pharmacy, toothpaste and utensils (China clay) making industries for further consumption by humans.

Atrocities and crimes which humans have perpetrated on the cow clan have led to multiple secondary and tertiary damages, viz.:

(i). Frequent and regular injecting of oxytocin into cows for the ease of milking converted their bodies so poisonous that when a cow died in the open and vultures (the natural scavengers) ate it, they too died because of the poisonous body of the cow, which led to the complete extinction of vultures. Thus, natural scavenging stopped.

Further, because of knowingly installing tanneries on the banks of rivers Ganga and Yamuna (mainly to belittle and subdue the Indians who regard River Ganga as their mother), and allowing chemically mixed wastewater to flow into the river Ganga, the entire breed of Ganga dolphins became extinct.

- (ii). The introduction of tea and coffee mixed with milk in Indian elites first, then among the commoners, caused unthinkable reduction in forest land (to meet growing demand of grass for cows, buffalo, sugar, tea leaves, coffee seeds, cardamom, ginger etc., required for tea and coffee mixed with milk), which has made extinct or is causing extinction of most of the birds, animals, and reptiles found in forests.
- (iii). After the inventions in the grey market that Ghee the much-respected Cow Ghee can also be made by mixing certain chemicals while processing the flesh of cows in local boilers (which can equally be used in lighting lamps during prayers and preparing the prasadam, i.e., sweets like laddoos in Tirupati Balaji etc.), what is becoming extinct is the emotional and religious quotient of the people of India.
- (iv). The opening of milk dispensing centres as Mother Dairy is making mockery and fun of atrocities committed on the cow clan, whereas so-called success stories of Amul, Sudha, Paras, Parag and Mother Dairy are crime stories on cows. The establishment of the Dairy Development Board, having ministries of dairy development, funding on research to enhance milk (thus beef) production, giving soft loans to Gaushalas (dairies), and subsidy or free grass to cows can be said to be a hidden contribution in the crime against the cow clan by the government. Whereas allowing the export of beef and live cattle feed is a blatant display of crime on the cow clan by the government.

Atrocities and crimes against the clan by humans, and in reverse, the curse of the clan of cows and all other birds, animals, reptiles, and fisheries that horrifyingly died and became extinct — that any brave step cannot be expected neither from

Dharma Sansad, nor from Political Sansad (Parliament), nor from the Supreme Court of India. Except for special prayers by the awakened soul, and then referendum in the country, nothing can alter the condition of the Cow and restore our pride attached to the Cow, Ganga, Earth, our biological mother, and the one who takes care of a baby from infant stage to grown-up stage.

(5.2.2). Why is it so that the Cow is not only regarded but appreciated as Mother, then Ganga as Mother, Earth as Mother, and the lady other than the biological mother who breastfeeds the infant baby and takes his/her care?

The title or position of Mother and Father can neither be demanded nor acquired, nor commanded by self or conferred by others. Rather, the title or position of Mother and Father is a providence of God to those who allow or help in the journey of a soul to take place without modifying the individual's natural virtues at the infant stage of the given soul. Since the milk of the Cow does not alter the natural virtue of any infant (be it human, dog, goat, cat, horse, lion, elephant etc.), the water of River Ganga and fruits and vegetables grown on the Earth also do not alter any natural virtue of any being — hence these are also being provided with the status of Mother, along with the biological mother.

Watching the continuance of atrocities and crimes on Mother Cow, Ganga, Earth, and womenfolk, and even adding to the same by individuals, the government, and society at large in India (and the world), may be an act of ignorance, cowardice, or of lust to earn foreign exchange and placate so-called masters among beefeaters. But the continuance of such an act (atrocities and crimes even after knowing the above facts) is bound to bring doom to India sooner than later.

Regarding the course of action for correction (resurrection) referendum in the country is the way.

(5.3). 'One nation – one destiny – one system': the issue of cleanliness and hygiene (physical, mental and emotional) in our home, in our locality, society, country and in our world at large in all its perspectives that is socially, economically, religiously and politically, can be said to be the basis of any healthy survival and happily living, which necessitates one system across the country and world.

Following is submitted on this issue:

(i). we need to consolidate the concurrent status of dirt which has accumulated around us(physical as filth and garbage, emotional as psychological puss and pornographic stuff, religious as verbal abuse and hate mongering, political as

making and breaking law with impunity and non-adherence to commitment and timely fulfilling them) and then unhygienic conditions prevalent (which can be appreciate by presence of large numbers of beggars, Prostitutes, then by the number of people lined up to receive monthly free ration(As per government of India, it is eighty crore that is more than fifty percent of India's population), then by number of educated and uneducated lined up for seeking employment, number of aged people suffering from loneliness, then by the numbers of people defaulted to pay their dues/loan then by the number of police cases registered and court cases pending, then by the size of crowd in the sermons/speeches of motivational, religious preachers seeking solace then by the increase in the number of patients in the hospitals of the Country).

After consolidation of concurrent status of dirt we need to discuss wherewithal like how we will maintain cleanliness, what will be the parameters which defines dirt and filth vis. a vis. cleanliness and hygiene, then how it will be done and who will do it and what will be its overall modus operandi, and how providence of this cleanliness and hygiene will ensure complete social security (e.g. of physical, of food, water, fresh air, shelter, clothing, health, education, justice, employment, entertainment etc. to all its citizens.

(5.3.1). Divergent issues concerning cleanliness and hygiene:

1. It is quite obvious to appreciate that when toddlers and young children play at home they will make some noise, mash up many things, through some papers here and there, may leave unfinished eatable in dining space and leave utensils as it is or at the most in sink to clean that is in short children are bound to create some mesh some chaos by the evening or may be by the night when they get exhausted and rushing towards bed for sleep. Next day and day after day, these young children do the same play and exercise and create an equal amount of dirt, filth and garbage without bothering who will do the cleaning and what all goes in, in the process of cleaning and maintaining of hygiene needed for the young baby. Obviously at home above cleanliness and maintaining of hygiene can say to be the responsibility of parents and other elders living in the same premises. But just think, what all will happen if the home/house is not getting routinely cleaned and maintained hygienically?

Similarly, when we (adults and elders) play/work at factories, offices, farm-houses, shops, stores etc. we do make some noise, mash up many things, through some papers here and there, leave unfinished eatable in the open and leave or through paper and plastics utensils as it is or at the most in dustbin to clean. That is in

short we are bound to create some mesh some chaos by the evening or may be by the night when we get exhausted and rushing towards our home/house for rest. Next day and day after day, we do the same play and exercise and create an equal amount of dirt, filth and garbage without bothering who will do the cleaning, why he/she will do it, what they will get in return, and then what all goes in, in the process of cleaning and maintaining of hygiene in the city which is needed by us. Obviously in cities above cleanliness and maintaining of hygiene can say to be the responsibility of parents of the society and other elders living in the same city. But just think, what all will happen if the city is not getting routinely cleaned and maintained hygienically on regular basis?

- (i). Howsoever big United Nations may talk about better cleanliness, but the rising trend in the sale of mosquito repellent, mosquito protection cream, mosquito-net, face masks and sanitizers, in the sale of air and water purifiers, in the bills of medicine, doctors, laboratories and hospitals, consequently increase in the number of chronic and mental patients, speaks much more against any claim whatsoever with respect to better cleanliness and hygiene.
- (i.i). Cleanliness which can easily be sorted at family and society level had become an international issue which can be appreciated by the fact that United Nation in recent past (The year 2013 onward) had taken a very big program on cleanliness and hygiene titled as "Take Poo to the Loo" that is take toilet to the toilets", and funded many a country for construction of toilets and abrogation of defecation in open (by humans). This has resulted in construction of crores of toilets and scores of advertisements which criticized open defecation.

Even after this flagship program we had witnessed wave after waves of Viruses and bacteria hovering across the globe which inter-alia reflects that this program has not only failed miserably but generated more dirt/filth/garbage and unhygienic conditions in the world which has resulted in hovering of more Viruses and bacteria and consequently rising of epidemics and pandemics.

*Failure of this collective body (united nation) to contain, control and eliminate spreading of Viruses and consequent epidemic and pandemic (one after the other in last two-three years) reflects inability of this institution and leaders associated with it to lead the world and asks us to have a fresh approach, fresh thinking and collective effort to provide a pragmatic way forward to address the issue of cleanliness and hygiene.

It is said that if we wish to have cleanliness and hygiene then it is necessary that we clean not only the Dirt/filth/garbage but also get freedom from the people with dirty mind-set and resurrect the perpetual laws on cleanliness and hygiene.

(ii). If we look at the state of affairs of our education centres, which are supposed to be teaching the lesson of cleanliness and hygiene to all the students and depicting the same in Alma-matter to showcase its importance in each walks of life then it is sure that at present we will be getting disappointed?

In fact, in most of the education centres, the job of cleaning is relegated to a lowly paid employee or to the worker on a contract. These employee or worker do clean the floor, wipe out the floor, clean the toilet daily once but rarely clean the four walls of the rooms, its ceiling and roof top, doors and windows, ceiling fans and air-conditioners, lighting accessories, insides of table- chairs, waste buckets etc. thus leaving much more undone.

Further dust from the files and other records, from the books in the library and articles in store are rarely being cleaned other than what to talk of showering or sprinkling water on the leaves of the plants and trees in the garden of the institute to showcase the larger cleanliness.

If the situation of physical cleaning (which is visible and somewhat easy to do) in educational institutes (and that of Hospital, Court, office of administrators and temple/Mosque) itself is not proper, then what can be said about the level of secondary cleaning and tertiary cleaning (that is of mind and heart) which these institutions are supposed to be imparting?

(iii). It may be a surprises to everyone that no religion from Hindus (which currently being practiced) to Jews, from Buddhist to Jains, from Christians to Muslims, from Sikhs to Baha'i has talked about or talking about cleaning of common area and its wherewithal like, who will do the cleaning in society, and why he/she will do it, at what age he or she will be able to perform such task and how he/she will be treated, respected and rewarded.

Further, almost all religion do not specify what will be ones right and responsibility, share and contribution toward other animals, birds and fisheries, trees and plant, environment and nature at least with respect to maintain clean and hygienic environment, and as such kept its own disciple handicapped, in awe.

(iii.i). It is argued that faith and procreation is innate in every being and is deep rooted and central to every living being including humans, hence if we are witnessing dirt/filth/scavenge all around then it is certain that the faith of a very large section of people (cutting across religion and region) must have been shaken. It can also be said that all these religions might have lost their energy and their time period of influence is over, consequently have lost their relevance and are unable to contain, control and guide its followers.

These asks us to raise a very basic question, are all these religions competent enough to cater to all the basic and local requirements of the community including cleanliness and hygiene and lead us forward or do we have to collectively revisit basic dharma/religion itself?

(iv). It is an irony that over the period of the last three thousand years, society has relegated/delegated most of the important work to kingdom/government which in turn offloaded this work to hired workforce named as government officials/servants and thus society and its people become prisoners of its own doing. It is surprising that government officials/servants (police personnel and army) are allowed to carry the arms and dictate terms and conditions including passage of judgments but the owner which is the Public got debarred to carry the arms and safeguard themselves in case of even adversity and thus become a hapless lot.

All politicians except the Prime-minister/President/King-Queen (in England) lack power and currently it looks that government servants are the owners (enjoying all the pay, perks, pension, bribe and even extortion) of the country. It appears that because of the overall mismanagement in the country, the real owner 'the Public' has become pauper which now looks like a puppet born to serve the country head (Prime-minister/President/King-Queen) and these government servants. Can the continuance of such a scenario be appreciated?

(v). Current situation of the world at large appears to be precarious. If one looks deeper than occasional out-worst by youth and consequential destruction of public property, Religious rivalry, Blind mechanisation (its associated diseases viz. Massive unemployment among youths and loneliness amongst elders, malnutrition and obesity, psychological disorders, loneliness), Human trafficking (and its associated disease of forced begging, prostitutions, pornography, drugs and narcotics), Unavailability of almost all types of social security, Utter disregard to basic ethics, and etiquette even by leaders and media

personnel do indicates that the situation is leading toward total collapse or toward an apocalypse.

Few others say that what we are witnessing is systematic failure of the system over the period of the last three thousand years wherein kingdoms after kingdom and government after government in democratic and independent countries failed to deliver even the basics to its rightful owner-the citizen.

(5.3.2). Paradigm of sustainable Solution:

God resides in the heart of a clean and hygienic person, family, society, country is true but a half statement, another half is-goodness keeps on abandoning, avoiding and escaping dirty and unhygienic surroundings, whether it is an individual, family, country and society.

So, if one got fade up with the richness, luxuries, comforts of the life, one can start discarding cleanliness and hygiene at personal level and accord cleanliness and hygiene a low key affair in the family and its surrounding, then diseases, discomfort followed by poverty and even slavery need not to be tried for but will automatically arrive.

Conversely if one wants to live healthily, happily and luxuriously in proximity of nature, then one has to abandon hypocrisy (that is keep on parroting or chanting sermons from some holy book or other regarding cleanliness and hygiene) and start doing act of cleaning himself/herself at personal level and accord priority to arrange/provide facilities and cooperate with others in the family neighbourhood and in society so that the cleanliness and hygiene gets maintained.

Healing the healer, by respecting five elements, i.e. space, water, air, fire and earth, can be our basis of interaction with environment and ecology. Hence, (for an example) when we are drying out cloth, our prayer can be" Let the river water go into the river and our clothes dry.

(5.3.3). If we look amongst Tribals (the आदिवासी-aboriginals-those who are here since origin, from the beginning) than one will appreciate that each and every member of Tribe is being trained to take care of all the aspects men and women can encounter in their entire life, be it safety and security, business transaction, administration, priesthood, judiciary, or doing support jobs.

It is said that Tribal-aboriginals/aborigines) are the original and civilized world is a superstructure built on it or built taking lead from these originals. So when the superstructure appeared to be getting dilapidated it remains the only option to revisit the original-aboriginal -and once again take the clues/lead/direction from these that how these (tribes) have taken care of basic securities (physical security, food security and of shelter) and carry-out their administration, justice and maintain their clan, taking care of basic health, education, entertainment and environment protection along with doing their prayer which makes them perfect to sustain themselves from the ages.

Should we wait for some magic and miracle to happen or for some new god to descend from the sky and solve our problem? Or should we rise to the occasion and start working for the resurrection?

(5.4). Avenues of large number of employment to maintain Physical, mental and emotional cleanliness in the society (Details can be seen from the website in the book Alternate economy-Topic no. 11: Avenues of remunerative employment and respectable engagement):

Industrialisation for the sake of Industrialisation has ruined many a country and deprived the humans from their basic activities and made them jobless and lonely at the lower bracket of society, whereas too many machines had rendered people unhealthy, crippled and quarantined people at the higher income bracket of society.

There needs to be some basic and firm demarcation at country and society level regarding use of machines. For example, all the grinding, cutting, slicing and its distribution can be restricted for machines. By conscious and collective decision in selective restriction in the use of electrically and gasoline operated machineries we can create a large number of employment for youth and avenues for respectable engagement for people suffering with loneliness, by reopening the sectors for traditional methods.

It is said that the Primary work has to be physical, secondary work has to be semi/partly mechanized, tertiary work has to be technologically driven and other advance stage to be automatic (e.g. Agriculture and thread making for clothing is to be physical, processing of food to be semi mechanical, packing is to be technologically driven, whereas any specialized and advanced testing (e.g. soil testing), extraction, mixing, communication can be automated.

(i). If we abandon or completely ban the use of electrically/gasoline operated, grinding and polishing machines of food articles such as of Rice, Pulses and Wheat along with sale of such produce even imported, then as per rough calculation (as per data's, September 2022) this exercise will be able to provide employment/engagement to two crores plus people with a remuneration of Rupees seven thousand per month minimum in grinding wheat flour only in India. Further, if we act judiciously in using the machine vis. a vis. physical work in every sector then this effort will provide employment to at least six percent population i.e. to approx. eight crore people.

Besides employment/engagement this exercise will providers, this switching over grinding of wheat from electrically/gasoline operated flour mills to manual grinding will also provide other health advantages to the doer as well as to the eater.

As the manually operated wheat flour mill (Chakki) is a low RPM (revolution per minute) cold grinding device hence produce of flour will not lose any of the minerals and vitamins in the process of grinding as against high RPM electrically operated flour mills.

It is said that grinding of wheat flour mill causes pancreas to remain active, hence this running of Atta Chakki found to be suitable work-in for those who are suffering from diabetes.

Further, It is quite obvious that these people who will be involved in providing wheat and other flour, would like to store some quantity of raw material as well as that of finished product, which will result in lessening the burden of the national government in respect of buying, storing and selling of such products and as such this act will lead toward self-reliance of people and of the country.

Besides above, operation of large number of these hand operated Chakki will also generate business to few lakh people to manufacture it and maintain it.

(ii). As per the chapter on "Economics of war, (Book: Alternate economy)", and as per the chapter on "Work distribution for a sustainable working of an economy" one fourth of India's population of one hundred thirty crores plus that is approximately thirty-two point five crore people must be attached with various facades of safety and security, like: (a). Acquiring classroom education or field training, (b). doing field duty or getting involved in special assignments

concerning safety and security, (c). Arrangement of necessities and proper management, monitoring of intelligence and its analysis and overall administration of system, (d). Imparting education, training and Special skills, being Jury in disputes concerning safety and security, coordination of research and development etc.

If we take average age of humans in a healthy and happy environment to be of hundred years, then in demarcation like above up to the age twenty five year one can be involved in growing physically, taking education and training, then from twenty five to fifty working on the ground, then from fifty to seventy five management and then from seventy five to hundred years of age administration, imparting training and deliverance of Justice).

If we look at this distribution then actual personnel to be deputed in the field for security needs to be one by sixteen of the population i.e. 130 crore population/16=8.125 crores people.

As this deployment of 8.125 crores people in security has to be arranged and maintained by the society hence it will be feasible, financially viable and morally superb.

(iii). As per the Book – Alternate economy, chapter– Economy of media and management of economy by media, elaborates in its point no.5A. that to provide rightful information and sharing of knowledge in the society will require a minimum of one man and one woman per hundred i.e., two percent people to offer effective and round the clock rightful and quality information and sincere advice along with possible help to the resident and non–resident Indian as well as to the guests and visitors. Hence, this act of providence of rightful information and sharing of knowledge will provide direct employment/engagement to approx. two crore fifty lakh people by the society.

(iii.i). Further as per point number (5.B): Providence of entertainment Security will provide employment/engagement to at least six percent of the population e.g. in India entertainment can be estimated to provide direct engagement/employment to approx. eight crore people.

It is said that "an entertainment in the evening will bring good vibes in the next morning hence entertainment security is most important a society and nation can have and provide to its citizens.

- (iv). As per the chapter on "Economics of eco-system, Solar (fire), air, water, earth and space", Point number 4 Paradigm of solution—"operational and management side of afforestation", if one person can cater to the entire need of an approx. two hundred trees then afforestation will provide employment/engagement to ten thousand people per district which comes out to the employment to seventy fifty lakhs plus people (in India as per population in the year–2022), in the total seven hundred seventy–three districts which India have. It can be done by closing concurrent set up of the forest department and handing it over to the society. This is the only way to we can assure sustainability of India.
- (v). As per the chapter on "Clean and hygienic economy and economics of cleanliness and hygiene" point number (4), Paradigm of Solution,
- (a). Collection of pre-cooked food waste and that of cooked waste at least two times a day will solve the problem of garbage to a very large extent, further it will reduce the requirement of grass for cow clan and supplementary food for birds, fisheries and other pet animals.

This activity will generate approx. ten lakh jobs in the country (calculating that one person will be able to cater a population of one thousand approx. so ten lakh people will be required if we start collecting the food waste pre-cooked and cooked in the evening/after dinner as well).

(b). There is a real problem to female to find suitable urinal which can be sorted out by opening of, multilevel toilets and bathrooms at public places like – busy market, City-centres, Colleges and Universities, religious place, bathing Ghats at the Pond, and River, Bus stands, Railway Station and Airport terminals, which may have facility of clock room, separate facility for boys and girls, ladies and gents, for aged and folks.

These places can have mini plants of ammonia extraction, bio gas and water treatment and shops to buy toiletries, drinking water etc. This area will generate sufficient employment and business opportunities.

Above is an example that we can generate the requisite number of job within the society and managed by societies itself.

6. Why Bharat can be a better place to initiate above activities:

Generally, it is observed that Preachers/Priest of every religious alienate himself/herself from the class of terrorists, thieves, robbers, cheats, looters and so called Satanic forces and their activities but observed to be keeps on doing

unreligious act like, of mongering of fear and breeding of hate and enmity in the society.

In stark contrast with these forces, Saints and Sadhus keep on doing good work but alienate themselves from taking credits. Though every country has its own share of Satan and Saints but since time immemorial Bharat has been regarded as an abode to Saints and Sadhus. Because of the very presence of saints and Sadhu's, this piece of land known as India-Bharat is lucky enough to continue to sustain its full religiosity in-spite of all the adversities it faced for centuries together.

During my last twenty years of observation of south east Asian region it has been noted that a very large section of the current Bangladeshis and Pakistani themselves repenting their mistake of separation and wanted to reunite with India, and in such circumstances India is expected to be magnanimous enough to offer a proper welcome and allow them to reunite with India on equal footing.

With the full sincerity following is submitted on the above:

When we look up at the ground report of a terror attack then following points emerge even on a cursory analysis, which we definitely like to address some on an immediate basis, more on a short term basis and most on a long term basis.

(3.1). Following is the ground report collected by us from the open domain:

- (3.1.1.vi). The murderers disappeared into the jungle without mentioning their identity and where they came from without facing any resistance from any quarter.
- (3.1.2) Pahalgam is a hilly area mostly inhabited by local population, army personnel and tourists.

- (3.1.5) Entire Kashmir and especially this spot in Pahalgam offered better scenic beauty than that of Switzerland or for that matter any other part of the world.
- (3.1.6) This area (entire Kashmir) is considered to be an abode of wise ones, saints, sadhus and seekers, a store house of wisdom and head of Bharat. It is said that if this area is cool calm than not only India but entire world will be healthy, happy and holy and in an another way if one (satanic person) wishes to earn name, fame, money and power then he/she can easily do so by injecting imbalance in this area, like by creating divide and terror in this region etc..
- (3.1.7) Main line media and Social media immediately became active and without properly assessing the ground report started mongering of panic, fear hate, enmity, revenge and cry for war etc..
- (3.2). Cause of major concern for the society its reasons and remedy: There seems to have been no resistance from the men while others were being murdered, and surprisingly, there was also no retaliation from the women folks even when their husband, brother, or father was killed in front of them at point-blank range, which speaks of very sorry state of mental strength of whole of the society and not just that of Indians and more so of so called Hindu male and females population.
- (2.1). Reasons for such a sorry state of physical security in the society: main reason of this sorry state of affair can said to be ill effects of the understanding of the great Acharya Chanakya who has supposedly shaped the administration of not only of India but of the world at large:

:Acharya Chanakya says:

सुखस्य मूलं धर्म:। धर्मस्य मूलं अर्थ:। अर्थस्य मूलं राज्स्य। राज्स्य मूलं इन्द्रियजय:

राज्य का मूल है, इन्द्रियों पर विजय।

[The basis of true pleasure is dharma (religion), basis of dharma is Arth (Arth means, money/wealth and its process), basis of Arth is Rajya/State, and the basis of the State lies in control over the indriya (sense faculties) of the king/Queen/ President/Prime minister.]

However, sentiments reflected in this verse have not found to be corroborating with the dharma the Sanatana and the same is also not found to be reflected in any of the sacred text. As per the sacred text, Dharma itself is the base and the basis.

(2.1.1). What happened because of this verse, that the Rajya/country and its premier (King, President, Prime minister) have gathered the feeling that they are at the center of all the activities of the state/country, its economy and even of Dharma/Religion, even if they have not won over their senses.

Though there is no direct mechanism to check whether King or Prime leader of the country has won over his/her senses but this verse has certainly set in precedence that it is their prerogative to take care of all the activity of the state whereas facts remains that in the last twenty five hundred years we barely had anyone as head of the state who has won over his/her senses.

God has not created the king/Queen, Prime minister, President etc. as the owner of a farm house called country and for their play created the public. This verse undermines the very freedom of individual and that of society and also questions the collective wisdom of society, whereas the fact remains that it's the people, who forms the society, and it is society which forms the state in the first place and not vice versa.

We can appreciate that above narrative put forward by Chanakya (Writer of the Arth Shastra and the founder of Magadha empire, can say to be the biggest in its length and breadth) are one of the main reasons why king/Queen/President/Prime minister keeps on acting as per their whims and fancies and majority of people (the owner) have become cannon fodder or a goat on the sacrificial altar.

It is said that a convergence of great masters which appeared approx. twenty five hundred years ago, like that of respected Chanakya, Confucius, Plato, Socrates etc. whose writ found to be still running have lived it's life and it is clear that after the two world wars, worldwide lock down, concurrent economic upheavals and ongoing wars we needs proper revisit of the basics where from very civilizations has emerged.

(2.2). Remedy for such a sorry state of physical security in the society:

it is said that Tribal-aboriginals/aborigines) are the original and civilized world is a superstructure built on it or built taking lead from these originals. So when the superstructure appeared to be getting dilapidated it remains the only option to visit the original-aboriginal-and once again take the clues/lead/direction from these that how these (tribes) have taken care of basic securities (physical security, food security and of shelter) and carry-out their administration, justice and maintain their clan, taking care of basic health, education, entertainment and environment protection along with doing their prayer which makes them perfect to sustain themselves from the ages.

At the onset of settlement-civilisation it was thought that society would have to take care of all the jobs which generally every tribesman does and also new jobs which might come-up because of the settlement/civilization.

It is said that after a lot of churning it became quite evident that to sustain the settlement/society/civilisation entire work which any society can encounter at any point of given time, place/space and energy can broadly be divided in four major parts that too at equal footing:

The following is submitted: this submission is in continuation of the previous post, dated 24.05.2025, and contains the (1). Broader view on the terror attack and targeted killing (2). Divergent views on the concurrent situation (3). Brief views on the applicability of the so-called 'New world order', (4). What Bharat can do in this scenario which is as per dharma, for reversal from this downturn?

(5). Action plan with brief details on how physical security can be ensured in a village with a population of 2,000 people, a town with a population of 2 lakh people, etc.

(1). Broader view on the terror attack and targeted killing:

As mentioned previously that whatever people say but the facts remains that the terror attack in Pahalgam was meticulously planned by multiple multinationals, few so called great personalities and their organization which are tirelessly working for arranging world war-III and IV (which appears to be in the final phase of preparation), finding and finalizing a new sacrificial scapegoat (maybe Hindu's-like Jews in world war-II), for the same.

Surprisingly for these so called great personalities (which include one person surround by world's top notch Riches, Royals and Religious head for whom President, Prime ministers of many a leading country is just a pawn in their hand)

this terror attack in Pahalgam can say to be last experiment before proceeding for world war and then after eliminating most of the population in the war install the so called new world order. A 'New world order' wherein this person surrounded by this triangle (which is they call it iron triangle) of top notch Riches, Royals and Religious head, can enjoy full control on the earth, wherein most of the human population [is get fitted with electronic chip, and controlled by radio frequency (Covid vaccine are said to be Radio frequency compatible device) which will work like an animal's working in the farm house (as mentioned in the book 'Animal Farm' by Indian born British writer George Orwell).

(1.1). This terror was specifically perpetrated to witness the behaviour of concurrent Hindu woman folks, the Hindu woman's who is generally portrayed as a helpless backward lady but do become like Mother Durga or Mother Kali, or Like Mother Sita or Sister Draupadi (who are considered to be ferocious and doesn't leave the culprits alive).

Savitri Vrata or Vat Savitri Amavasya or Vat Purnima) to seek blessings Lord Shiva and Goddess Parvati for their husbands' long life, health, and happiness, in which Vat Savitri Vrata is said to be observed to commemorate the pious act of Savitri who rescued her husband, Satyavan, from the god of death (Yama) and for seeking blessing that if situation warrants they can also do so (that is not leaving even the god of death what to talk of mercenaries of death). As there are no such rituals which are performed by the women folks of the Jews, Christians, Muslims, Buddhists, and Jains religions, hence in such a situation, the women folks of the Hindu can say to be considered the obvious choice of the perpetrators.

To appreciate the above, everyone is requested to check the swiftness with which the global scenario is changing after the terror attack in Pahalgam-India dated-22.04.2025.

(2). Divergent views on the concurrent situation:

In spiritual circles, it is said that as soon as the Mahabharata ended, the Power of the Gandiv (bow and arrows of Arjuna) too has ended, and as soon as the lord Krishna left, darkness started descending, and the Dark-Age or black-age or Kala Yug or Machine-age (kal-purja age) or Kalyug or era of kal-kali began. With the onset of Kalyug, all the sages put back their feet and confided in their solitude and prayer.

It is said that, with the onset of Dark(black) age all the Nighty-Owls, Batman, Spiderman, hunters, robbers, thieves, seductress, magician, operator of dark web, masters of cunning arts, black magic and pseudo-science, and other creatures and preachers who generally work in the dark got active and started their activities.

Common people under the influence of darkness and devoid of proper protection and guidance from saints and sages got themselves easily attracted to the masters of cunning arts and black magic.

First effect of dark age appeared when people, devoid of day to day blessings, blinded by Dark-Age, intoxicated by wines prepared from rotten fruits and cereals, became unaffectionate, disrespectful and weakened that they could not afford to maintain the respectfulness and dutifulness towards the elders, woman, birds and animal, flora and fauna, fishes and aquatics consequentially got debarred of mutual cooperation from these, hence got disappointed.

Disappointed so, people instead of self-correction and remained rooted to the ground, instead of accepting the holy and rejecting the folly, took this incident of non-cooperation in their day-to-day work as an attack on their so-called supremacy.

Then there comes the Satan in the dress of saint who advised people to tame the pets, to take control of the pets and other people by somehow or anyhow even if it calls for killing them, castrating them or making them handicapped, physically, mentally, emotionally and even spiritually, by giving regular punishment to rebels and keeping them in captivity and confinement.

These foes in the dress of friends further advise people to treat and use these as a useful item to its fullest and further advised people that it is a sign of strength to have animals, slaves and gold in one's custody, to use the earth and its environment for one's advantage, and whoever has more of these at their disposal will be the powerful one. All these have brought in a basic shift in peoples thought process and consequential changes in behaviour and action.

With this basic thought, mainly three civilizations got developed in the Kalyuga: -

(2.i) The Mayan and Inca civilizations (while the exact dates and durations of the Kali-Yuga is debated, the general understanding is that the Maya and Inca

civilizations, with their complex societies and cultures, developed within the time frame of Kali-Yuga). (2.ii). Concurrent and so-called modern civilisation.

(2.i). Typical features of Kali-Yuga in Maya civilisation and the reasons for the collapse of Maya and Inca civilisation:

Master of cunning art and pseudo-science and so called power mongers during the Mayan Civilization made few people to believe that once the night set in, and the sun went down, it would only come back up again if they offered human sacrifices to the sun, and to ensure that the sun came back up the next day, Mayans started sacrificing a human every day to please the God of Sun and in this way these Master of cunning art and pseudo-science got control on the entire Maya civilisation. They used to paint the person to be sacrificed in blue, cut open his ribs, and take out a still-beating heart as a mode of sacrifice. It is said that during the initial period, thousands of normal people in the Mayan civilisation were killed and this continued intermittently after these masters of black magic gained major control over the whole of the civilisation..

Reasons for collapse of Maya and Inca civilisation: More than eighty different theories are being given to explain the collapse of Classic Maya and Inca civilisation, from climate change to deforestation, to severe drought, to internal warfare, to foreign intrusion, from widespread outbreaks of disease to a dangerous dependence on mono-cropping, to collapse of trade and trade route to lack of action by leaders, however people in spiritual circle says that the collapse of Maya and Inca civilisation was due to a failure in the social control systems of religion and political authority, due to increasing socioeconomic complexity that overwhelmed the power of traditional rituals and the king's authority to compel obedience.

(2.ii). Typical features of Kali-Yuga in the concurrent and so-called modern civilisation and reasons to worry about it not meeting the same fate as that of Maya and Inca civilisation:

Master of cunning art and pseudo-science (and so called power mongers during the concurrent and so called modern civilisation in a bid to take control on the whole of the civilisation made few people to believe that once the sun went down and the night set in, if they offered human sacrifices to the their god/goddess they and their clan will alive the next day and if they continue to sacrifice human they will become chosen one of the goddess and thus will enjoy life's luxuries to its fullest and may even become immortal.

In order to ensure that life and its power remain the next day, such people started sacrificing a human every day to please their god/Goddess and tried every way to get control of the psyche of the entire population. They bathed the person to be sacrificed, cut open his throat, and took out hot blood as a mode of sacrifice. It is said that during the initial period, thousands of normal people in the concurrent civilisation were killed in this way and this practice is still continuing (as these masters of black magic in their way couldn't get control of the entire world).

[It is said that The Ravan slit his own head for ten times and offered to the lord Shiva to show his conviction and dedication toward him and in a way please the lord Shiva. As in Kalyuga these Master of cunning art and pseudo-science and so-called power mongers do not supposed to be having so much courage and conviction as that of Ravan (or maybe these feels themselves to be more smarter than Ravan) so these have settled for slitting the heads of other humans.]

Few of these masters of cunning art and pseudo-science say that the Sacrifice (Bali/Qurbani) is a feast from goddess/Allah to her/his chosen ones. Bali/Qurbani is a means of earning reward, drawing closer to [the pleasure of goddess/Allah and a shield against calamities.

To offer Sacrifice (Bali/Qurbani) is a sacrifice in the path of goddess/Allah and a way of gratitude for the blessings of goddess/Allah, and supposedly can be said to get ordained for religious, moral, and social reasons and matters.

(2.ii.i). Those who knows about the human body, its anatomy, its physiology, its energy centres [(mainly the seven Chakras, that is from root chakra (sex centre), death centre (naval), solar centre (stomach), central centre (heart), throat centre, third eye (pineal gland) and Crown Chakra (top of the head)] will agree that humans can only behave in a normal way, if he/she is Anatomically, Physiologically in the normal working condition and whose energy centres are not got disturbed. It is said that only such person can live and behave in a normal healthy, happy and holy manner and will neither have inferiority complex nor have a superiority complex, will neither try to overpower other nor get over powered by others, however if the anatomy, physiology and energy centres of a person get disturbed they can easily be manipulated.

This understanding of making humans (man/woman) miserable and usable even by slightly disturbing their energy centres and humans can permanently be used, abused, manipulated if their energy centre is disturbed/damaged permanently, made the job of these Master of cunning art and pseudo-science a bit easier and this lead to reduction in number of human sacrifices

These Master of cunning art and pseudo-science first created the havoc of sacrificing of humans (and especially young ones) in the society and then they from the back door spread the message that only a wholesome person is suitable for the sacrifice, and because of this message few society took a decision of circumcision among the male and mutilation of genitalia among the females so that they can save their children from being sacrificed at any point of time in future. The havoc of human sacrifice created was so deep that children as young as that of seven days were circumcised or got their genitalia mutilated (as a gods commandment). It is said that at least twenty crore females can said to be victims of FGM (female genitalia mutilation).

(2.ii.ii). Further, to control over the population which did not resorted to circumcision or FGM, these Master of cunning art and pseudo-science applied different methods like: creating the noise (by promoting use of loudspeakers, making construction of houses which necessitates use of ceiling fan Air conditioning etc.) to disturb the heart and head, contaminating the water and food to disturb the stomach (senses centre) and throat (speech centre), suggesting the use of western commode to disturb the digestion (stomach and even the entire body) and now these are trying to permanently damage the pineal gland (it is said that the presence of Aluminum and sodium glycol if triggered with certain frequency will cause permanent damage to pineal gland and then humans can be used like an animal (efforts of which can say to be in the final phase of implementation and various vaccinations are being designed to speed up the process).

(2.ii.iii). Still further, as against the practice of entire management of entire society by Dharma Sansthan (be it social security, administration, governance, business) as was supposed to be prevalent during Ram Rajya, Dharma Rajya Satyug and even during the onset of Kalyug), these Master of cunning art and pseudoscience' become successful in managing the society through media and through three sections they created (taken lead from the human requirement/psyche) in which Religion through its priests/Pundit/Maulvies controls the heart of people, Rajya (state/country) through its King/ Prime minister/President/officials controls the head of people and Riches through its shopkeepers/businessman's controls the stomach of the masses.

In such a scenario, the entire society appears to have become prisoners of these Masters of cunning art and pseudo-science and now appears to be getting ready

to submit fully to these to get sacrificed or get chips installed in their body and work like an animal in the farm house.

(2.ii.iv). It is said in the spiritual circle that whatever power these so-called Masters of cunning art and pseudo-science might have accumulated but facts remain that these get fearful even by witnessing few photos of goddesses bearing a garland of human heads. It is said that the terror attack in Pahalgam and killing of male Hindu in front of their wife, daughter and sister was arranged by these so that they can overcome their fear and move ahead to organise world war followed by creation of new world order.

(3) Brief views on the applicability of so called 'New world order':

New world order (in a way control of one or few people in the entire world) is not possible as it is against nature. It was previously tried two times one by The Rama himself (after winning the war with Ravan and eliminating him) and another by The Yudhister (after the Mahabharata war) and both were challenged and thwarted, one by the Son of Rama himself and another by the next generation of clan of Pandava and Krishna and as such was abandoned By Rama and Yudhister both. Currently these so-called proponents of 'New world order' have not even won the war either, which obviously they cannot [(just because of them being against the Dharma (basic religion)] hence whatever talks we are hearing of the new world order can say to be a good storyline for the idle banterers.

(4). What Bharat can do in this scenario which is as per dharma, for reversal from this downturn?

In spiritual circles they say that the above can be said to be a mirage, a myriad or an effect of Maya; otherwise, such an act of masters of cunning Art and Pseudo science could not have succeeded for so long.

Those which are in spiritual circle say that the dawn is about to come and this a time of prayer, self-correction, correction in one's drink and food, correction in our behaviour toward the nature and then getting prepared so that the all that is folly can be rejected and all that is valuable can be accepted for our collective wellbeing. Looking at the above it can be said that a reversal from this appearing to be an unending downturn is possible and the same can start with the simple correction in the food we eat and the liquid we drink.

(5). Action plan with brief details on how physical security can be ensured in a village with a population of two thousand people, which can be extended in a similar fashion in the town, cities and Metro's.

Without going into any detail about the serious security lapses at Pahalgam on the fateful day and about the people and the agencies who raised their volume, pointed fingers, mongered fear, hate and cried for revenge and war, and then who quickly agreed for ceasefire and then immediately backed again in their as usual activities/businesses, showing/giving no concern, that how an overall security of people and respect of womanhood can be assured to a level wherein anybody alone or along with their companions can freely roam around at any point of time and at any place in the country without bothering a bit.

It can be said that once again women folks have to rise from their slumber and take matters into their own hands to punish the perpetrator and assure not only their own security but of their husband, son and daughter, mother and father and those of near and dear in the vicinity. Women folk need to take a lead and have to ensure that proper mental makeup towards need and providence of safety and security is inculcated at home, proper education and training is given in the education centre and proper arrangement are made in the society so that neither the neglect is being done nor hype is being created.

As mentioned in the point number three of trailing post (attached below) that to ensure physical security minimum six person per hundred (six-6%) is dedicatedly required for the providence of physical security in the society, that is eight crore plus (8.125 crore) people out of India's population of one hundred thirty crore needs to be given responsibility of ensuring of physical security. (Details in this regard is given in the book- "Alternate economy", Chapters on 'Economics of war', 'Governance, administration and its optimization for a sustainable economy' and management of economy from Dharma Sansthan' which is available for free download at: resurrectionofdharma.com).

If we see the details, then we will appreciate that this effort of employment to 8 crore security personnel will not only provide safety and security but will also evaporate the demand for employment. Financially, this is viable and morally, it is superb. Providing this type of security with such a large contingent will definitely provide a 24-hour safe and secure environment to children, to aged, flora and

fauna, birds, animals and aquatic life and will also be of help in any unforeseen disaster.

[An example: A village with a population of two thousand can have one hundred and twenty personnel (sixty male and sixty female) working in three shifts with a suitable and comfortable 'Shift Rota' (like three days night, three days morning, three days evening and off after each changeover i.e. having four groups of thirty personal each) can be entrusted with the task of providing physical security which may include the following: 1) Crop protection, 2) Pet protection, 3) Forest protection, 4) Protection from kidnappers, 5) Protection from alcoholics, 6) protection from domestic violence, eve teasers 7) Prevention of theft, 8) Prevention of any arbitrary behaviour (goons, miscreants or any particular person), 9) Providing security during social functions and special programs, etc.

Further, management of this service can be handled from any concurrent religious premises (Temple, Mosque, Gurudwara etc. having enough space) in the village. Basic salary and perks (say ten to fifteen thousand per month (as per calculation of May 2025 rate), uniforms and other necessities and facilities as per the geography can easily be discussed/arranged and set aside by the management committee of the village albeit in consultation with the district committee. Similarly, security can be made in towns, cities and Metro's.

Let's open up with a time frame that within one year we will arrange four crore security personnel and within three years (that is by 2029) we will complete the arrangement of requisite eight crore (50% male and 50% female) security personnel in the society (with a minimum salary at current standard Rupees Ten thousand to fifteen thousand depending on the location).

(5.1). It can be said that if we are able to do this than we will not require multiple constitutional bodies or rather if we want to do this than we have to abandon all the state government and all other constitutional bodies except Loksabha so that chaos created by these institutions and massive expenditure incurred in these bodies, can be eliminated and money so saved can be utilised in the providence of physical and social security and salary payment to the people employed/associated in the security. It can fairly be said that creation of a large number of employment, providence of physical and social security and simultaneously keeping all these institutions is not possible at all.

Bihar is the first state to go for election hence it is people of this region have the first option to decide whether they wants, state government, its MLA, MLC and Rajyasabha MP's., it's elections, its nuisance or people wants employment to

minimum Forty lakh youth by June 2026 and another forty lack by 2029 that is total of eighty lack with a minimum salary between ten to fifteen thousand per month in the region of Bihar. If the youth of Bihar want employment, then they need to come out and make this their own agenda and see that it gets manifested.

If we see at the national level, then also we have to open up with a time frame that within one year we will arrange four crore security personnel and within three years (that is by 2029) we will complete the arrangement of requisite eight crore (50% male and 50% female) people engaged as security personnel in the society (with a minimum salary at current standard Rupees Ten thousand to fifteen thousand depending on the location).

Above submission is made after thorough observation (since the year 2003) of process of governance, communication with the top leadership of country (congress and BJP), interaction with large number of leaders in social, economic and religious sectors, satsang with the fakir and saints (acknowledgement letters to such effects can be seen in personal profile in LinkedIn and Facebook) and spending some time in solitude and as such can say to deserve proper attention, response and deemed actions of fellow citizens of India.

are doing more mimicry than giving real message, news and views besides exposing many flaws in strategizing war and ceasefire. This war has also brought out clearly how fragile/futile/dangerous it is to be involved internally in the hate mongering, divisive politics, war of words and showcasing unity and integrity externally.

2. Terror attack dated 22.04.2025 at Pahalgam which saw cold blooded and leisurely killing of twenty-six (26) male after properly verifying their identity that they are Hindu's can say to have happened at a reasonably famous global tourist place which under the security of Army and under the direct control of national government, and as such one cannot think better proposition with regard to providence of security in any place in India.

In spite of the so-called best form of governance and providence of such a level of security which an Indian can think of, the Pahalgam terror attack happened.

Beside the hue and cry for revenge of Pahalgam terror attack the government of India also admitted of serious security lapse revealing that Baisaran Valley had been opened to tourists two months ahead of schedule without notifying security forces, a factor which facilitated the attack, however nobody have taken responsibility and nobody hold responsible and punished for this serious security lapses neither from planning side (NITI Aayog) nor from executive side and also not from legistors side.

This scenario reflects a status of a country where incompetence, stupidity, non-seriousness, pettiness is prevalent in the entire country. where mediocrity is celebrated. Where narratives like, what is the need, why to do it, how it makes a difference, rules the general sentiments. Which inter-alia, brought this land and people to the verge where questions like, what does it matter whether these lives or die. In such circumstances sometimes, husbands get killed in front of wife, father get killed in front of son/daughter, brother get killed in front of sister (or vice versa), and normal citizens get killed/die in front of crowds and so does a civilization collapses.

This scenario also reflects that leadership has becoming irresponsible, short tempered and in a way mentally bankrupt or being hijacked by multinational and if that lobby/caucus of Riches, Royals and religious head which is said to be

working towards bringing remotely controlled all inclusive, all pervasive and powerful new world order on the earth.

3. What is most surprising and shameful for any society, country and even the world is that there was no retaliation from any of the dead or their companions or other tourists or from the regular vendors present there and selling food and other items to the tourists. Everybody present in the scene appeared to have surrendered to the dictates of the producers (a Satan and their representatives: planners, financiers, directors, facilitators and executors) of the terror attack.

Situations like this can be said to be very scary which signals that people of Indian society have lost basic strength to safeguard himself/herself and that of the similar species (other human beings in the same situation and present their (which is ingrained in every living being and is known as swa-dharma (religion for self) beside other features of Dharma (basic religion) like fearlessness and fighting spirit.

This is entirely not a comfortable proposition for any family, society, country and even the world and people who consider themself to be responsible (and not those who are sitting at responsible positions and do not feel concerned or those who cede crocodile tears amid big sloganeering and leave society to crumble) need to come forward and resurrect the basic dharma and all that is requisite in the providence of safe and secure environment for each and everyone in the society. All the old and wise need to come forward and guide the society that how society from its own resources can provide complete social security to each and every one of its members and show them how everyone can have a healthy, happy and holy life.

3.1. Wise ones say that the terror attack could become so severe because of our own fault and our narratives by which we raise children at home and humans in the society. In India (and most parts of the world) a child is warned by the mother that if you do this or do that a ghost will catch you, and by the father that I will slap you, similarly society/religion terrify him/her of hell and government that of prison.

One will see an extension of these terrifying scenarios in the confession chambers, witness boxes, lawyer's argument, and judgments of courts. It can be said that in such a scenario how one can expect that people will stand against the terrorists, thieves, robbers, hooligans, bullies, eve teasers, and other monsters? Societies having such a scenario are bound to witness and bear the brunt of ghastly terror

attacks not once but one after the other and maybe more severe in nature and application.

What is needed from the wise one of old to demonstrate in the society that why 'good is good' and how children are at home and peoples in the society can be raised on the premises of goodness and without the fear of ghosts and slapping, hell and jail/prisons.

3.2. In India the preaching of non-violence to an impracticable level by The Buddha The Mahavir and more recently by Mr. M. K. Gandhi did cause an unaccountable loss to the basic psyche of Indian and made them fearful somewhere even to the level of coward that non retaliation at Pahalgam type terror attack does not appear strange.

All these (The Buddha, The Mahavir and Mr. Gandhi) have gone even one step further that they didn't only preach non-violence but also ridiculed the war by Ram and that of Mahabharata against the evil forces and somewhere they declare these as myth and whole history(religious scriptures) as mythology. What can one expect in such a background and scenario?

If we want to live in the atmosphere of safety and security then wise ones have to come forward and reestablish the dharma – the basic religion.

4. in the follow up of the terror attack in Pahalgam, it was brought to notice of common people of India and the world that terror activity was perpetrated by terrorists operating from Pakistan and apparently trained and supported by the government of Pakistan) and as such these terrorists, their well—wishers sitting in the Pakistan supported by the government of Pakistan deserves to be taught lesson. To highlight the requirement of war and press the demand to have the concurrence and all out cooperation from every citizen of India all the channels of Media were used and all the important leaders made their presence felt seeking support and participation of citizens of India to start the war and as such common people of India did come out in support of full–fledged war with Pakistan to punish the perpetrator of terror attack and then to live peacefully.

The war did take place but the manner in which the ceasefire took place and the follow up international news poured in and shook the faith of citizens of India from its own government. Common people feel that the government considers them cannon fodder or a guinea pig or an entity to be used and abused with impunity whenever people in government feel like doing as per their whims and fancy. This has caused enough resentment amongst the common people of India and raised enough concern amongst the wise one for the future of India and Indian people. In this entire incident i.e. of terror attack, war, ceasefire, buying deals of arms and armaments what is more worrisome to note that people in the leadership though get power from the common people of India (even if elections process and consequently its results are doubted) but found to be submitting to various power and business lobbies many of which are not even from the India).

5. Things become scary to note when one keenly observes that, there may be suspicion about the origin of the Corona virus and its spread as the COVID, that the Virus is god sent or this country or that country was involved in its making/developing in their labs and it's leak in the open domain and can say to be open to debate but the manner in which world-wide lockdown followed due to Covid certainly speaks that it was not the god send but meticulously planned and perpetrated simultaneously in all the countries, whether it was privileged top five countries i.e. America, China, Russia, England, France, Germany, India, Japan, Brazil, other countries of European union, Eurasia, African Union, Arab world, Australia and other countries in Latin America and Asia.

This suggests that not any particular country or a group of countries but a group of powerful people was involved in making the lockdown successful and showing their strength to the world.

It is in open domain that only a group comprising of people which are having deep say amongst the Richest, Royals (kingdom of Britain etc.) and Religious head (Vatican etc.) was behind the World war I and world war II, making and breaking of USSR, Czechoslovakia, creation of Pakistan and Israel, freedom of China and its economic boost and many other war and bringing Tsunami.

However in spiritual circle it is being said that since the beginning of this era (Kalyuga) there exists a group having deep knowledge of cunning art and dark science, who wishes to rule the world is behind all the atrocities being committed on humans, birds, animals and fisheries, tree and plant, earth, mountains and

water bodies which ultimately making this earth unlivable. It is also being said in the spiritual circle that spread of COVID and world wide lockdown was their final show of strength and Terror attack in Pahalgam is a beginning to firmly establish new world order i.e. their rule on the entire world.

In coming days it is quite possible that to provide moral sanctity this group of people will bring in some electrical extravaganza and showcase the descending of a new god from sky/heaven and hide all their activities towards bringing in new world order under shadow of this new god and speed up their effort declaring it as a magic of this new god.

6. Situations like above are very scary and cannot be appreciated to continue and ask us to make such an effort that the vulnerability of security which we are currently going through not only vanishes but provides such a solution which lasts long (I.e. a solution towards ensuring availability of physical and other social security which is like eternal - Sanatana). In this regard point number - 5 of letter dated 30.05.(available in Facebook /Linkedin and website) brought out clearly a system of providence of physical security derived from Tribal (aboriginals/aborigines) which day that minimum of six percent population (male, female both in equal numbers) of the society must be attached in the work of assurance of security to the family, society, it's land, water, sky and country, managed jointly by society and national government, with proper sharing of arms and ammunition, education and training on safety and security, operation and maintenance, storing and upkeep of arms and ammunition, instruments and equipments along with other accessories in a properly defined roles and responsibility (between society and government). Individual ownership of arms and ammunition as is prevalent in few countries can bring lawlessness and anarchy and is not appreciated for the providence of physical security in the society and country.

Physical security is first and foremost hence after ensuring physical security we can think of providence of all other social security (food, water, shelter, justice, health, education, entertainment and avenues for self-expression etc.) to every member of the society and its genuine guests.

Three and half days of war India had with Pakistan in May 2025, exposed the world that no country can be counted on for full-fledged support and as such India has to go solo. In particular this situation and when we are witnessing many a war

across the world than it will be not only prudent but necessary to fasten the process of streamlining providence of physical security.

7. Indian freedom and freedom to its children can say to be the first and foremost and which cannot be maintained until be put extra effort for the same, change rules and regulations, abandoned or clean out all the institution which are hindrance in the providence of physical security be it too many constitutional posts and institution, current system of maintenance of law and order and providence of justice, system of distribution of income and work etc.

The power centres of the world after witnessing complete lockdown in India during Covid, terror attack at Pahalgam, it's three and half day capacity to be at war appears to have developed the feeling that complete India can at any time be overtaken at the most within two month time. This is an alarming situation.

Further, with more than eighty crore of people surviving on the free ration and spiraling jobless, India can be said to be resting on the volcano which can erupt at any time.

In such a scenario it is of paramount importance for the national government of India to mend and amend its way and work toward providence of physical and social security [which will require immediate imposition of new form of President rule in country (wherein only Loksabha will continue to operate), and employment on urgent basis to six percent of its population i.e. eight crore youth (male and female equally) in the providence of security to be managed jointly by society and national government (as detailed out in the letter, dated 30.05.2025 and in the book Alternate economy (Topic: Economics of war, economy because of war and economic warfare)]. It is expected that better sense will prevail upon the current national government of India,
