(1). Broader outline

It is said that:

“Negative via variables turns into positive,

Unconsciousness via subconscious turns into consciousness

Darkness/black/night via variables turns into Brightness/white/day,

Dis-Organisation via variables turns into an Organisation which further via Organisation via variables brings organizational development,

Today's rascal via variables can be turned into tomorrow gentleman",

If we think on the above statements then it can plainly be said that whatever negativities, darkness, mismanagement we are currently observing in the societies world over, by different combinations of strategies can easily be converted into positivity. As Dharma is the foundational principle of cosmic order, righteousness, and rightful conduct hence if in line with above if we think of resurrecting the Dharma, and establishing the Dharma Sansthan we will be able to restore harmony, truth, and evolution of life.

It is said: “धर्म एव हतो हन्ति, धर्मो रक्षति रक्षित (Dharma eva hato hanti, dharma rakshati rakshitah)” – One who destroys Dharma is destroyed by it. One who protects Dharma is protected by it. Dharma is not religion—it is the universal principle of rightful living. It is the very framework of existence: when upheld, it sustains; when violated, it collapses.

History of different era (Yuga) exemplifies that progress without dharma is self-destructive, but when dharma guides, truth and harmony flourish at all levels, hence it can be said that to counter all the negativities which are going on in the air, the resurrection of Dharma can say to be of the only alternative left with the world.

(2). what all we will achieve by Resurrection of Dharma and establishment of Dharma Sansthan:

Following will be the basic achievement

2.i. It can be said that by the resurrection of Dharma and establishing Dharma Sansthan, we as individual (including our legitimate guest and visitors) will

achieve full social security (that is security/guarantee of physical safety, food, water, shelter, clothing, education, health, justice, opportunity to work (employment), personal space and support for one's creative pursuits, entertainment, physical exercise cum playground, avenues of suitable employment and respectable engagement to all the needy seekers, proper information and guidance centre besides place for cremation/burial etc. in a respectable environment managed jointly by the society and national government, through the income received by the society as its share from the income of an individual due as per Dharma.

2.ii. It can be noted that by resurrection of Dharma and establishment of Dharma Sansthan, we can completely eliminate/eradicate/evaporate the problem of loneliness in developed countries and unemployment in all other countries; we will be able to maintain cleanliness and hygiene (physical, mental and emotional). Further by establishing Dharma Sansthan we will be able to improve upon the quality of food we eat, water we drink and air we inhale, that is by Resurrection of Dharma and establishment of Dharma Sansthan we will be able to improve upon the happiness ratio of each individual as well as that of our society, our country and the whole world.

2.iii. It can be noted that in the process of resurrection of Dharma we will be able to assimilate different religions and unite the countries divided on this accord, like; India, Pakistan, Bangladesh. Further whatever animosity we currently are witnessing between different castes, sects, religion will vanish in its own accord.

2.iv. Further by ensuring logical distribution of income/yield among family members across three generations (mother-father, husband-wife, and daughter-son) and between society (local government) and the national government, each receiving an equal share of 12.5%. This will ensure gender equality, will promote two child norms thus optimize population, and will promote monogamy.

2.v. Further, because of equal share of income between society (local government) and the national government, at one hand responsible behaviour

by institutions will increase and on the other hand the need for multiple agencies and other intermediary institutions like state government will vanish.

2.vi. It can be noted that by resurrection of Dharma and establishment of Dharma Sansthan we will be able to restore forest and tree cover to its optimum level of thirty seven percent (as per the scientific logic given in the scriptures) which will be a key point in restoring balance in the ecosystem.

2.vii. Will be able to ensure logical balance between manual and mechanical labor on a continuous basis, which besides saving electricity thus reducing pollution or space requirement for power generation, will improve overall physical health of the society and will help in managing issues of loneliness in the society.

2.viii. It can be noted that by resurrection of Dharma and establishment of Dharma Sansthan settlement of normal court cases will fall under the joint preview of Dharma Sansthan and national government hence pendency will reduce to naught except that of cases of constitutional court. Further, education and healthcare will also fall in the preview of Dharma Sansthan and national government hence facilities of Health and education can be made on post payment basis through funds collected via grace and gratitude and contribution by society..

2.ix. It can be noted that by resurrection of Dharma and establishment of Dharma Sansthan, society will be able to encourage people to adopt a healthy, happy, and holy lifestyle by following a simple rule: 'Pray, Play, and Party Pray' (Pray in private; Play with players in designated places; Party with partners in public).

2.x. Increment in the happiness ratio of individuals, family, society, country and the entire world, etc.

(3). what will be the reference or baseline taken care in the resurrection of dharma through which we can affect complete social security, division of labour and that of income as narrated in point no.2 above?:

It is said that business (of trading items, services or of trading in life) is nothing but a photocopying, and whenever business gets diluted it is time to look at the original and correct oneself or the process or both. In humans it can be said that Tribal–aboriginals/aborigines) are the original and civilized world is a superstructure built on it taking lead from these originals. So, whenever the superstructure appeared to be getting dilapidated (that is when we feel there is a civilizational problem) it remains only option with mankind to visit the original–aboriginal the tribes–and once again take the clues/lead/direction from these original/Tribes that how these (tribes) have taken care of basic securities (physical security, food security and that of shelter) and carry–out their administration, justice and maintain their clan, taking care of basic health, education, entertainment and environment protection along with doing their prayer which made them perfect to sustain themselves from the ages.

(3.1). It is said that at the onset of settlement–civilisation it was thought that society would have to take care of all the jobs which generally every tribesman does and also new jobs which might come–up because of the settlement/civilization.

It is said that after a lot of churning it became quite evident that to sustain the settlement/society/civilisation entire work which any society can encounter at any point of given time, place/space and energy can broadly be divided in four

major parts at equal footing: (a). Basic safety and security, (b). Education, planning and strategy, making of rules and regulations, (c). Collection of material, storing of material and its distribution in the society, (d). All other support services to the society e.g. health services, engineering service, maintenance of cleanliness and hygiene, providence of entertainment etc.

***For example:** As per demarcation placed above one fourth of India's population of one hundred thirty crores plus that is approximately thirty-two-point five crore people must be attached with various facades of safety and security as per their interest, experience and age, be it:

- (a). Acquiring classroom education, field training and special skill,
- (b). Doing field duty or getting involved in special assignments
- (c). Management and monitoring of inputs from intelligence and spy's
- (d). Imparting education, training, special skills and disputes resolution,

If we take average age of humans in a healthy and happy environment to be of hundred years, then in demarcation like above up to the age twenty-five-year one can be involved in growing physically, taking education and training, then from twenty-five to fifty working on the ground, then from fifty to seventy-five management and then from seventy-five to hundred years of age administration, imparting training and deliverance of Justice). If we look at this distribution, then actual personnel to be deputed in the field for security need to be one by sixteen of the population i.e. $130 \text{ crore population} / 16 = 8.125$ crores people. Further as these services are to be managed by the society hence in the beginning all the security personnel can be given a minimum salary of ten-fifteen thousand rupees per month which can be revised depending on the revenue received by the society. In such a precarious situation which India is passing through that it should recruit above number of youth for the providence of physical safety in which equal participation of men and women are ensured. If we see the details (in the "topic-7 Economics of war, economy because of war and economic warfare" in the book alternate economy mentioned above), then we will appreciate that this financing for this eight (8) crore plus security personnel can easily be managed by the society itself (from the share of money (12. 5%) which society will receive from the income of all its members).

It is said that the Physical security is first and foremost hence we (India) must give topmost priority for the induction of eight crore plus security personnel guarding every nook and corner of the country from external agencies as well as from the internal miscreants, hooligan, scoundrel, thugs, rogue etc. These efforts of employment to eight crore plus security personnel will not only provide safety and security but will also evaporate the demand for employment.

It may be noted that, it is only after ensuring the physical safety and fast and proper justice delivery system is ensured that we can think of providence of all other social security (food, water, shelter, justice, health, education, entertainment and avenues for self-expression etc.) to every member of the society and its genuine guests.

(3.2). It can be said that most important feature of the resurrection of dharma and established of dharma Sansthan is to ensure proper and logical distribution of income amongst the member of family, country and society, which suggests that out of every earning of hundred(Rupees etc.) one earns:

- (i). Twenty-five percent should be marked for debt repayment to one's parents (that is to the old generation equally between mother and father),
- (ii). Twenty-five percent should be marked for loan to his own children's (to the future generation as is being done by his parents and to continue the tradition in the society) equally between son and daughter,
- (iii). Twenty-five percent should be marked for Self and Spouse (that is current generation equally between Self and Spouse),
- (iv). Twenty-five percent should be marked for dharma and government equally between dharma Sansthan (i.e. society the local government) and national government.

It can easily be seen that with this division/distribution of income we will be able to bring in "the gender equality, equal respect to the older generation as well as to next/future generations, society/Dharma/local governance as well as to Kingdom/national government.

Further, it can also be seen if the constituents in any category be more, then either their share will reduce or they will end up eating share of others and as

such will add in disharmonizing family, society and country, hence it can be said that with this division/distribution of income we will be able to emphasize in the society for to have with the two children norm, one marriage norm (depreciation of polygamy/polyandry) and optimization of governing bodies that is to have only one government that is national government (discarding multiple governing bodies like state governments in India).

It can also be noted that when this distribution pattern of income/resources/yield combined with the distribution of work/responsibilities then this system will be able to answer all the questions which can be put with regard to management of family, society and country and as such resurrection of dharma and establishment of Dharma can say to be the one remedy and only remedy for all the ills we are witnessing right now at individual level, in the family, in society, in country and at the international level.

(4). When we talk of resurrection of dharma and establishment of dharma Sansthan, what is the basic definitions of the term: Resurrection, “Adharma – Adharmi, Dharma, Dharma Sansthan, Rajniti (Politics)”, one will take into account?

Following is submitted:

(4.1). Resurrection: i. bringing back something that has not existed or not been used for a long time.

ii. The act of bringing something that had disappeared or ended back into use or existence.

In Sanskrit resurrection is being taken as (पुनरुत्थान, अभ्युथान) which means **Revival and/or Ablution**,

i. the act of becoming or making something strong or popular again,

ii. To revive, restore, or salvage something. The word can be used to describe improving the condition of someone, something, or something else or bringing it back to a previous state.

iii. The act of washing yourself clean,

iv. The rise or beginning or advancement of a particular event, acts

(4.2). Adharma–Adharmi:

It is the Dharma of nature that it provides everyone without any discrimination air, water, fire, physical materials, and land to live and sky to stand and for life to continue, nature has created day and night. In this, falling sick, accepting the experience of others, trusting someone in a mutual debate and getting mediation done from him, getting justice, exchanging general thoughts and news, respecting each other, trusting and walking on the faith of tested and tasted (experienced) experience in nature is considered a natural process and it is also called natural Dharma. If someone gambles on the belief of this natural religion, then he knows that there can be any possibility of winning or losing and thus gambling will be considered a natural process. But if in this gambling someone changes the dice in between or cheats with the cards, then it becomes adharma and the one who does it is adharma.

Similarly, falling sick is a natural process and when one falls sick, one goes to a doctor or vaidya and gets treated by him, pays the doctor, this is also considered a natural process. Apart from this, the doctor-vaidya should pray to God every morning that our work may continue, which means that the sick keep coming to us, keep getting treated by us, keep giving us money, and keep bearing our expenses. This is also a natural prayer. But if the doctor, the medicine seller, the medicine manufacturer, starts creating obstacles for the people, starts giving wrong advice due to which they fall sick and keep falling sick, or releases such germs among the public due to which people fall sick and get troubled, then publicizes the same disease, creates fear of it, uses the news media for it, gets it discussed among doctors and creates such an environment that whether people fall sick or not, the society and the government buy lots of medicines as a preventive measure, this is an unrighteous process and those who do this can be called unrighteous or devilish. In the last hundred years, some diseases like Spanish Flu, SARS, Chikungunya, Swine Flu, Zika, Ebola, Corona Virus were released among us and diabetes, heart disease, cancer were publicized excessively, which shows the extent of devilishness.

Similarly, if a person from the underworld takes a contract to kill someone, it is considered a natural process of the underworld, but if a person from the underworld starts creating such an environment that people give him a contract

to kill someone every day, then this process goes against the accepted rules of the underworld and it is called hooliganism or devilishness.

Today, when such an environment has been created in the field of health, education, justice and communication, then we can easily guess the gravity of the situation that now life has become difficult. All this comes under Adharma – and it can be said that those who do this have become unnatural – unrighteous. If we put it in even simpler terms, then if someone does the work of making shrouds, coffins, selling wood at the cremation grounds, which is necessary and natural, and along with that, if a person doing such work prays to God to run and expand his business, then it may seem strange, but it is still justified. But if such businessmen start planning to kill people or get them killed, then what will we say? They have lost their senses and have become irreligious and devilish.

It is believed that whoever strays from the accepted rules, transgresses them, his end is certain. In this way, the end of adharma and the irreligious is certain, what remain to be seen is when it happens, how it happens and who all does it.

(4.3). Dharma (Religion) is that which encompasses is Dharma, or Dharma is an essence of the entire earth (धार्यते इति धर्मः, धरा का मर्म धर्म है,), In Sanskrit they say, for Sansar (World–entire earth–Dhara) it is the Sanatana Dharma, whereas religion is the regional manifestation of dharma, 'Like; for Hindustan it is Hindu, for Judah it is Judaism (Jerusalem for Jews). Buddha, Jain and Sikhs are the main offbeat of Hindu whereas Christian, Muslims and Baha'i are the main offbeat of Jews (धर्म सम्पूर्ण धरा का और रिलिजन रीजन का).

Dharma stands by the virtue of freedom and virtue of love in all its magnanimity it offers and not because of inculcation of fear of ghosts and hell or by bullying in open and Punishment in jail among the masses which many religions are doing. Dharma is wholesome and provides holistic approach toward all transactions which life offers, it neither involves itself in business nor to support/favour business entities at the same time it does not become henchman, propagandists or frontal Organisation of political or ruler or expansionists. Dharma never asks anyone to wear this uniform or have that

haircut, 'read this and see that', 'listen to parroting of sermons while doing exercise (yogic or aerobic)' dharma basically engrossed in making life healthy and holy in a sustainable manner.

Dharma never asks anybody to sacrifice humans or its substitutes such as coconut or goat, buffalo, Sheep's, camel etc. in order to please the god. Dharma never asks anyone to castrate Bull and Buffalo or for male circumcision or mutilation of girl's genitalia for one reason or the other including forcing them to become celibate, or to safeguard them (boy and girls) from complete sacrifice by making and declaring them an entity which has already been symbolically sacrificed to the almighty.

Dharma also does not ask anybody to restrict growth of anybody be it human or tree and make them Dwarf and Bonsai. Dharma simply asks us to celebrate life and allow others to celebrate and eat that which maintains sanity of your mood and drink that which maintains sobriety of voice. Dharma never asks anybody to worship nor does dharma restricts anybody to worship in any way or any form (idol) or formless or even get yourself worshipped, dharma simply asks to follow the dictates of innate faith/consciousness and continue doing one's work-karma (one can also say; work is religion and work is worship). There is no exact word for Dharma in English; hence the word Dharma is used.

Entire world is one but a large family is the most basic understanding of Dharma, which hitherto many religions found to be reluctant to agree at first place unless they saw people of all creed and colour accept their version of religion. Now, an outbreak of disease and worldwide lockdown has proven beyond doubt that the world is one, had the world been not one, how come one disease could have possibly been able to affect the entire fraternity on the earth.

(4.4). Dharma-Sansthan (Religious institutions): Dharma-Sansthan is an institution which caters to the needs of the entire society in its entirety in a self-sustainable manner without any bias and prejudice. Such self-sustainable Dharma-Sansthan (Religious institutions) had been kept on working continuously (perennially) for ages. In fact, because of the perpetual working of

this system, this system itself has been assigned the name Sanatana. Further, because the working of these Sansthan is observed to be performed with full Dharmikta (with full religiousness) hence this has been nicknamed as Sanatana Dharma. However, few say it is the other way round that because of the basic understanding of perpetuity these Sansthan could perform in a sustained manner.

Dharma Sansthan can said to be an institution which will offer food to hungry, water to thirsty, shelter to destitute, treatment to diseased, advice and justice to needy, help to helpless, employment to youth and respectable engagement to lonely and elders beside providing physical, financial, emotional security to all the individuals in its vicinity in a non-exploitable environment, so that there remains no destitution, forced begging and forced prostitution.

Due to obvious complacency which generally appears after a long term successful operation of institution and idiotic desire to improve upon even the perfection, society contributions in its own such institutions reduced thereby slowly and slowly, such institutes found to have become non-existent in the last three thousand years. These all religion- Hindus, Zoroastrians, Judaism, Buddhism, Jainism, Christian, Islam, Sikhism, Baha'i how so ever holistic each one claims it to be but the fact remains that none of these religion has been able to provide healthy and happy life style even to its disciples at equitable platform in a sustainable manner, hence resurrection of Dharma Sansthan can be said to be the only option so that the life on earth can find itself rejuvenated once again.

(4.5). Rajniti-Politics: Rajniti is an ethics of governance and also government functioning on the basis of ethics, whereas ethics is that which emanates from earth and its environment (नीति नियामक से आती है).

As the environment keeps on changing with the passage of time so the environment can say to a dynamic entity. Earth in comparison to the environment can be said to be a static entity. As Rajniti is firmly footed with Earth hence Rajniti can be said to be static but as Rajniti also reverberates with the environment hence Rajniti also becomes a dynamic.

In view of this mix, Rajniti is said to be an experience and its expression which is firmly footed yet flexible enough. In view of this definition it can be construed that Rajniti is not a Job/Profession but an engagement toward society for the collective good of society and its surrounding environment. Such Rajniti can be said to be performed by the persons whose basic family needs doesn't require his time and money i.e. at a time when his/her children got married, and involvement in such Rajniti can be continued till his/her children become available to take his/her place. This means the age for an active Rajniti (Voting as well as contesting an election) can be from fifty years to seventy-five years approx. After the age of seventy-five years such respected personalities generally would like to enter into educating and training the newcomers.

There is no exact word for Rajniti in English; hence the word Rajniti is to be used.

(5.1). Discussion with the wise amongst the common public

The basic question arises that how we in India and the world can have healthy and happy life and life style and what we individually and collectively needs to do in such a sorry state wherein every problem (from pollution, population, poverty, health, education justice, entertainment, employment, unavailability of rightful help and advice along with forceful interjections of many a dishes and unnecessary and even dangerous devices, genetics robotics, and artificial intelligence are looming large?

That how we in India and the world can survive happily wherein the concurrent leadership of India as well as of the world appears to be clueless, religions in

place of providing solutions to mankind, itself had submitted to the corona and shut its door during worldwide lockdown, became defunct and declared them as null and void?

Can a handful of businessmen/women and their puppet politicians, paid propagandist religious preachers and a few corrupt bureaucrats continue to dictate the terms and conditions of living in India and also in the world?

Can Nandi (bull) continue to be castrated and cow clan continue to be slaughtered and sloganeering of Cow being mother be allowed even in a country like India (which itself claims to be following Hindu dharma which prohibits any and all such acts which can be referred to as cruel to cows).

Can pendency of court cases continue to be allowed to increase to an unimaginable limit and lawlessness be allowed to be continued? Can unusual rises in the price of commodities, metals and currencies be justified and allowed to be dictated by few? Question is how long will the so-called Iron triangle (nexus of Riches, Royals and religious heads) be allowed to nullify nature and rule the world through their sheer hypocrisy projecting them to be savior of humanity through the cowardly, multifaceted and hypocrite's leaders? Can happiness prevail in our civilization?

Can there be a worse situation for society than the unavailability of at least a hope? Medical data confirms that the diseases are increasing at a very alarming rate which clearly point out that the agencies (religious institutions) supposed to provide hope in the society are miserably failing in generating hope among their followers.

It may be because of this severity of situation which founders of various religion put together envisioned that the current time (twentieth century) to be the time of either doomsday, or incarnation of new Messiah, or rebirth of Buddha or coming of new messenger of god or it is just a time of transition to new era?

Can in such a situation "resurrection of Dharma (basic religion) and establishment of Dharma Sansthan" perpetually working toward upholding

rightful and logical distribution of income/resources/yield and corresponding responsibility (work distribution) amongst the members of family, society and government is a workable solution? Do we also need to undertake the process of elimination of evils and elevation of gentlemen and women along with the resurrection of dharma and establishment of dharma Sansthan?

In such a scenario masters do gives rays of hope and quote two excerpts as below and say that there should not be iota of doubt in the mind of any one, who so ever he/she is with respect to the authenticity of statements presented below and resurrection will take place sooner. They say – “If we are witnessing large-scale deterioration (in our day to day conduct with the self, with others and with nature) then one can be assured that large-scale churning/changes are about to come”.

O' Bharat (Arjuna, the wise, the enlightened, entire world), whenever there is a ग्लानि (guilt/deterioration/melancholy/lassitude/remorse) of Dharma, I recreate myself for the restoration of dharma, for the protection of the sadhus (gentlemen), for the destruction of the wicked/evil doers and makes the establishment of religious institutions possible in ages. The word Bharat has been referred for, Arjuna, the wise, the enlightened, and the descendant of great Bharat the Earth”. The word Bharat has not been used here (in Gita) for this piece of land which is now referred also as India-Hindustan

Note: in both the excerpts quoted above only the word -Dharma is used, without any prefix or suffix and this should be noted by at least who revered these scriptures.

The above subject of this letter has been selected on the backdrop of above questions.

(5.2). Discussion with the intellectual people:

When we discuss the above issues with the intellectual people following emerges:

The systems have become corrupt, and these corrupt systems have become rotten to the core, and this has been going on for a long time. As a result, the public has accepted them, and somewhere along the line, the public has also become corrupt.

The world today stands at the crossroads, confronting itself many times with no one else but its own belief on one hand and reality on the other. "Democracy is the cure of all ills, we suffer from and once we embrace it, we will realise a society which will be free, fair and enabling for all" is a popular belief, it's a loud declaration from the west, yet its success is questionable, not in terms of its survival through the difficult world wars, cold wars and civil wars but in terms of delivering what it intended to be-freedom, equality and realisation of self.

When voting, democracy is described as government of the people, by the people, and for the people, but after this, democracy appears as, "government of the government employees, by the government employees, and for the government employees," or "government of the riches, by the riches, and for the riches," in which the elected leaders, Member of parliament's (MP) appear to be an extra and unnecessary obstacle? If the public has voted for MPs then they ought to come to him for all types of work, where is the need for people to go to the government servant whether they are in administration or in judiciary? Further, there are so many elections and so many leaders in the country that those officials who really want to work don't know who to listen to and who not to listen to?

Sixty to seventy percent of people's earnings are spent on education, health, justice, and transportation and are becoming not only expensive year by year but exploitative services as well. The money of the poor is looted through banks' credit cards, while the rich benefit; the behavior of private moneylenders is also deplorable. The situation is dire due to air, water, and land pollution. and the condition of water, forests, land, and wild animals has become deplorable; the environment has been ruined.

Casteism persists, and the problems compounded by religious conflicts and riots. Sisters and daughters are not safe, and Justice is not being served, injustice is increasing, poverty is rising, the gap between rich and poor is widening, the country's currency is depreciating, and the number of beggars , kidnapping and human trafficking is increasing and the receiving cooperation for good deeds has reduced to almost naught. In all, the public has lost faith in this democratic system and the promises of the leaders that now they demand direct money or goods from the leaders while casting their votes.

The system of democracy has been designed (very shrewdly by the masters of cunning art) like a lollipop so that those who are at the helm of affairs can continue to suck the common people. The framework/structure of democracy in England (which is now prevalent throughout the world) was created in such a way that the following three pillars of the state creates an Iron Triangle which is sustained (remains unbreakable irrespective of which party won the election and who becomes their leader and Prime minister) at least for the last nine hundred year (from the time democracy was invented and implemented).:

(i). The media (the means of communication) – The media receives daily information from the police and hospitals – ensuring that fear prevails in society), to create an atmosphere, to suppress dissenting voices, to spread despair, to create chaos, and to elevate the state while demeaning the public (the media never mocks the judiciary, the administration, the army, or the King/President; it only mocks political leaders, even the prime minister – thus mocking the public.

(ii). the administrative system – officials, employees, police and Army.

(iii). the judicial system – always remaining far above the reach of the public and under the control of the state King/President/Head of State),

Further, this iron triangle that exists among the general public is a product of the iron triangle formed between the monarchy, the aristocracy, and the religious leaders in England. This upper iron triangle operates at the world level and the lower iron triangle which operates at country level has spread throughout the world and is now wreaking havoc.

The situation is extremely serious – and to distract from it, the government and some large multinational corporations promote alcohol, smoking, drugs, and pornography on the one hand, profiting from them, and on the other hand, they spend a portion of these profits on campaigns against these very vices and on promoting morality – thereby increasing public discontent and driving people back to addiction to forget their troubles, thus perpetuating this vicious cycle.

So, what is the way forward? To continue living like this, suffocating and dying, or is there another option? Will we ever be able to properly arrange for basic necessities, education, healthcare, justice, and security? This requires comprehensive efforts that cannot be achieved simply by changes in political power at the central or state level, or in district administrations – many systemic changes will be necessary and for the same people to have to come out from their den, work and cooperate and bring overall changes that is to do resurrection of the basics/dharma.

5.3). Versions of the so called Saints and Satan's

(5.3.i). Those who believe in God say that the present time is a period of transition. The vessel of sin is almost full and is about to burst and after which the Satya Yuga (the age of truth) will come. In such discourses, one can easily hear that the vessel of sin bursts whereas a new sapling grows in a pot of virtue.

Saints while comforting masses can be heard saying in a pleasing manner and merrier tone that the era of truth (Satyug) is about to come, wherein everybody will lead a healthy, happy and holy life. They say that in the Satyug there will be

a total of thirty-three crores of people on the earth wherein everybody will be like a deity having plenty of power and resources at their disposal.

Further, Saints can be heard saying that current time is that of exposition and elimination of evil forces, and appearance and elevation of good, and the score/things are going to be sorted out sooner than expected, hence those who are good at heart and in their conduct need not to bother much and all that is needed from the public is to continue doing their work and submit their prayer to almighty and wait for thou blessings to descend.

(5.3.ii). On the other hand, those members of the underworld who trust their own power, say that God does exist, but God is only with those who have strength, power ,wealth (money, resources), and who control the forms of wealth (media, money, markets, banks). These members of the inner circle call saints and sadhu's a group of useless fools. Currently its common discussion among these that the Earth cannot bear the burden of such a large population, that this population, growing like carrots and radishes, has created so much of filth and nonsense and burden on the depleting natural resources that it has become difficult to live comfortably and as such it will be in the common interest of every one of us to eliminate a large chunk (approx. eighty to ninety percent) from this rapidly growing concurrent seven-eight billion of this population so that the rest of the population can at least survive.

In this inner circle, people say that if humans had not eaten chickens, eggs, goats, and fish, then all of these would have covered the entire Earth. In nature, one living being is food for another (जीव-जीवस्य भोजनम्-life feeds on life), but humans have elevated themselves above phenomenon and no body found to be eating humans which is why the human population has increased so much. If this human species had any intelligence, it would have controlled its population, but most of them are crazy—their religions and religious leaders are all crazy; they keep increasing their population. Because this species of crazy people is not going to improve, hence if the Earth is to be saved, then these crazy people should be eliminated. You can easily hear and see such discussions in the news, media, social media, and films.

From such discussions among the powerful, one can draw a general conclusion that only those who have money, who are capable and powerful, are entitled to survive; everyone else should die or deserve to be killed like insects, mosquitoes, fish, or chickens. Increment in the number of earthquakes, volcanoes, storms, cyclones, floods and drought then spread of disease like Saar's, Corona etc. which can be considered as few of the efforts in this direction.

Note

The situation can be considered serious when two opposing factions of the underworld point toward the almost same type of future. Surprisingly, this thought process is matching with the prophecies going round amongst various religion, like; 'two messengers will arrive after fourteen hundred years of Paggamber sahib, and will establish peace in the world', or that this is a period of transition, or that this religion will last for twenty-five hundred years (Buddhism), or that the apocalypse will come after two thousand years (Christians), or that this is the last generation (Jews), or this is the time of transition or the end of Kalyuga and that of arrival new era and as such causes more worries?

(5.4). Discussion with the master's

When we discuss the above issues with the Master's following emerges;

(5.4.i). There are said to be seven happiness in a person's life – first happiness is a healthy body, second happiness is Maya near, third happiness is a good wife, fourth happiness is an obedient son, fifth happiness is that the cow lives in the house, sixth happiness is to live with a gentleman; seventh happiness is a happy death. On the contrary, it is said that if the body is sick, there is no money, the wife is naughty, the son does not obey, there is no source of income in the house, there are no good people in the neighbourhood and there is difficulty in death. If we look at the whole world today, the first, sixth and seventh happiness have become endangered, the rest of the happiness is also seen in pieces – and then when it is difficult to find such a person in the whole world, it can be said that the situation is terrible.

(5.4.ii). That the current era is a Kali Yuga, people refer to the present age as Kali Yuga. Some call it the age of darkness, some call it the age of machines (parts and components), and some call it the age of Kali or the goddess Kali – and they say that black color predominates in this age – such as the black robes in the ceremonial halls of justice and education, printing of books, documents and articles in black colour, promotion of study during darkness or blackness of night. Few others say in Kalyug people always talk of either yesterday or tomorrow (of past or future) in Sanskrit and Hindi both are interpreted as (कल-
Kal) but not of today the present (they say that this age is preoccupied with the past or the future); some say this is the age of time or death, and of Mahakaal – of Shiva – of Kali.

It is being said that in Kalyuga, merchants, businessman, and industrialists will have an edge over other class (such as Brahmins, Priests, intellectual, researchers, Politicians, Police and army, professional and service providers) and will be allowed to lead the society and whenever this merchant class become weak or dubious servants of the kingdom/government will fill the gap or will have the edge.

It is said that the Kali-Yuga (being considered as an era of night, blackness or darkness) use of drug and narco substance, theft and robbery, prostitution and pornography, and all other immoral which can be thought of have started taking place e.g. media manipulation and arms supply to terrorists, spreading of diseases through viruses, setting up the forests ablaze and killing crores of animals and birds and inciting conflict by manipulation of emotions through microwaves.

In this situation, not only has the balance of nature been disrupted, but life on Earth is becoming increasingly difficult and hellish. This indicates that the situation has become dire and the time for a change of era has arrived. Though, in such a situation turnaround is inevitable but the question arises, who will lead and oppose the lobby of concurrent mafia's of banking, media, the oil, coal and nuclear energy, arms and ammunition, automobiles, industries or controllers of seas and space, and bring around requisite changes.

Amongst people there is curiosity to know, whether God will transforms people's intellect, or the god brings in great flood or war or will inspires people to engage in dialogue, churning of ideas, leading to improvements and happiness, wherein all that is essence is preserved and all that is the inessential gets discarded.

(5.5). Discussion with Spiritual people

When we discuss the above issues with the Spiritual people following two points emerges; (5.5.i). **Story of how the downfall happened in the Kalyuga, (5.5.ii). Necessity of restoring the respect of 'Bull (Nandi)-Cow', while putting effort toward resurrection of dharma;**

(5.5.i). Story of how the downfall happened in the Kalyuga,

In spiritual circles it is said as soon as the Mahabharata ended the Power of the Gandiv (bow and arrows of Arjuna) too has ended, and as soon as the lord Krishna left darkness start descending and Dark-Age or black-age or Kala Yug or Machine-age (kal-purja age) or Kalyug or era of kal-kali begin. With the onset of Kalyug all the sages put back their feet and confided themselves in their solitude and prayer.

It is said that, with the onset of Dark(black) age all the Nighty-Owls, Batman, Spiderman, hunters, robbers, thieves, seductress, magician, operator of dark web, masters of cunning arts, black magic and pseudo-science, and other creatures and preachers who generally work in the dark got active and started their activities and with this begins the decline in the people observance of Dharma consequently deterioration in the stature of Dharma Sansthan.

Common people under the influence of darkness and devoid of proper protection and guidance from saints and sages got themselves easily attracted to the masters of cunning arts and black magic.

First effect of dark age appeared when people, devoid of day to day blessings, blinded by Dark-Age, intoxicated by wines prepared from rotten fruits and cereals made became unaffectionate, disrespectful and weakened that they

could not afford to maintain the respectful and dutiful towards the elders, birds and animal, flora and fauna, fishes and aquatics consequentially got debarred of mutual cooperation from these hence got disappointed.

Disappointed so people instead of self-correction and remained rooted to the ground, instead of accepting the holy and rejecting the folly took this incident of non-cooperation in their day to day work specially agriculture as an attack on their so called supremacy.

Then there comes the Satan in the dress of saint who advised people to tame the pets, to take control of the pets by somehow or anyhow even if it calls for killing the calf or castrating the bull, by piercing their nose and putting thread/rope in it, by putting permanent weight on rebels and keeping them in captivity and confinement. These foes in the dress of friends further advise people to treat and use these as a useful item to its fullest. These Satan's in the dress of saints, foe in the dress of friends further advised people that it is a sign of strength to have animals and gold in one's custody, to use the environment for one's advantage, and whoever has more of these at their disposal will be the powerful lot. All these have brought in a paradigm shift in peoples thought process and consequential behaviour and action.

This idea of using the environment for individual advantage has caused enormous atrocities on animals, especially on the cow clan. Castration of bulls making them ox and using them as slave animals in farming has brought in the curse of the Bull and Cow in the entire food we eat and milk we drink.

It can be termed as the biggest surprise that how come entire communities have forgotten the basic fact that "it is the food/milk which decides the mood and the water which decide the voice" and got itself degraded/downgraded to the bottom, that too in countries like India which claims to have the largest and biggest wisdom in its courtyard. It is even more surprising that most of the new found religion in the last three thousand years which talks about elevating human consciousness kept silent on this very basic issue of drink and dine which alters the entire human psyche and its dynamics. Alas!

For India this utilitarian behaviour toward cow clan is more surprising that the majority of its people widely worship Nandi (Bull) in the temples of Shiva and Cow as mother. Further it looks very odd to appreciate that how come this real life atrocities and cruelty toward cow clans is ignored by scores of pundits, saints and sadhus who keep on chanting and speaking on mother cows and Lord Shiva and his courtiers. Disrespect to such preachers, poverty to such communities and slavery to such countries are natural consequences of ill-treatment toward the cow clan.

Those who are drinking cow milk and then eat beef can be said to have become insensitive like a machines and somewhere or the other they have also surrendered themselves to be used like machines and shouldn't be any surprise if these get turned toward fratricide and genocide.

Increased consumption of beef in countries having a hot desert or cold atmosphere of icy packed countries has prompted them to augment dairy business in countries like India through disbursing soft loans and other promotional schemes for larger use of dairy products so that the continuous demand of beef can be met with. Result of this can be witnessed in the increased consumption of tea and coffee added with milk and sugar. This has further compound the problem and accentuated the crime against cow clan and also resulted in utilization of twenty-five to thirty percent of most fertile land for cultivation of grass, sugar cane, tea and coffee, which can be said to be a major reason of deforestation and there upon climate change and all round misery.

Looking at above it can be said that reversal from this appearing to be an unending downturn is possible and the same can start with the simple correction in food we eat and liquid we drink.

In spiritual circles they say that the above can be said to be a mirage, a myriad or an effect of Maya otherwise how such a simple and small act could not have succeeded for so long. These in spiritual circle say that the dawn is about to come and this a time of prayer, self-correction, correction in one's drink and food, correction in our behavior toward all nature and then get prepare for churning so that the all that is folly can be rejected and all that is valuable can be accepted for our collective wellbeing.

(5.5.ii). Necessity of restoring the respect of ‘Bull (Nandi)-Cow’, while putting effort toward resurrection of dharma;

Below is dedicated discussion with masters and many others on “Bull (Nandi)-Cow, economy of beef and economics of cows and castrated Ox’ put up in the question answer form which highlights gravity of the issue for India as well as for the entire world and why restoring the respect of ‘Bull (Nandi)-Cow’ should be our immediate concern:

Question: How can one feel assured of the continuity of beef?

Answer: The Indian subcontinent, Latin America and African countries have enough Cows and buffaloes and they produce the beef in plenty and there is no need to worry about.

Question: that is ok, but one never knows, what if the supply of cows is reduced?

Answer: Though tea and coffee has to be taken plain, but the same is promoted mixing of milk and sugar in countries like India

In countries like India, plain tea and coffee means tea, which have tea leaves/granules, water, milk and sugar and special tea means adding Cardamom, Ginger, Basil, etc. in it, because of this very reason they will continue to have large requirement of milk which in turn means large number of Cows, Buffaloes goat etc., which means larger retirement of cows and Buffaloes making them available to fulfill the growing requirement of beef.

Further in order to ensure supply of beef to us we ensure that tea and coffee with milk only be advertised in these countries, then we provide soft loans to promote dairy industry, sugar industries, tea and coffee gardens, then we highlight how subsidies on sugar and dairy product is necessary, so that these products remain affordable to common men of these countries. Then to ensure fodder and grass for cows we promote agriculture, and we ensure that nobody makes much of the noise when forests are cut or forests get fire and reduce to ashes to increase land for agriculture and grassland.

Question: If it is so, then we are investing so much money just to have beef? Do we do anything to recount this money?

Answer: Oh! Yes. It is common that if one continues to have tea and coffee added with sugar and milk then one is definitely going to develop multiple health problems which begin with the deterioration of oral hygiene and digestion. These are the two areas in the body from where all diseases start. Hence it is certain that almost all consumers of tea and coffee added with milk and sugar are going to get health problems and will be visiting doctors and buying medicines. We at our end have acquired large ownership of pharmaceutical companies and opened up a chain of hospitals which provides us with a large profit much bigger than what we invest in promoting dairy and sugar business in countries like India.

Apart from it, we have invested sufficiently in Media (have enough shares of newspapers, news channels and social sites) so as to ensure that only our voice and sentiments are echoed and not there or anybody else's, which in turns made us sufficiently powerful in countries like India that we can continue to remain in a position to dictate not only our terms and conditions to Indian people through their government but earn money at the same time.

Question: it is heard that many in India regard cows as mothers, how is this issue being addressed?

Answer: We have promoted idea of mother dairy, and how it is good to drink at least one glass of milk daily, we do everything through our intelligentsia to keep them blind, timid, coward in the grab of their own scriptures and writings like, milk is nectar- Sudha, so they opened Sudha dairy, milk is priceless: Amulya – Amul dairy and suggested a slogan Amul milk- the taste of India, this is how they remain contented and contained.

You will be surprised that there are so called enlightened speakers who address Cow as their Mother (though they do not mentioned Bull, which is being prayed as Nandi in all the temples of Shiva) but forget the basics of that tea and coffee added with milk and sugar is the doorway of the beef and didn't mind sipping/taking tea/coffee (normal or Ayurvedic) added with milk and getting it served during their sermons.

When tea and coffee added with sugar and milk becomes a common as well as a welcome drink by females at home, workers and executives in industries,

clerks and officers in corporates, followers and leaders in public and religious preachers during their sermons then one can be assured of continuous supply of beef and all other benefits businessman can derive from it.

Question: It means one is earning also while securing continuity of beef, does it not sound like their smartness and sheer idiocy of people and leaders of countries like India?

Answer: ha ha,

Question: What if Indians realize the fact?

Answer: It is not that nobody realizes in India and country like India, but they are too less in number and every time they raise their voice they are being subdued by their own fellow being who got addicted to tea and coffee added with milk and sugar, who tested the profit from dairy besides, hospitals and pharmaceutical companies.

Supply of beef can't simply be removed, even if political leaders of countries like India feel like banning beef, then also they will not be able to do so, and this is just because we have sufficient mastery in meddling with internal affairs of countries and get whatever we want, which many leaders of these country knows, thus remain fearful of us and do not come in our way. For us inflicting abuses on leaders, provoking people and their groups to indulge in fights, clashes and wars are just a play.

Question: Can one cite any example of the tall claim made above?

Answer: Yes, they are there:

(a). For instance, through political circle, belief was circulated that it is the Muslims who are slaughtering the cows, and amongst Muslims that it is their fundamental right to do so, and thus there got a class divided on beef, whereas the fact remains that most of the automatic slaughterhouse supplying beef is operated and owned by non-Muslim community (including from the community which makes full voice/noise for non-violence in every norm and every form).

(b). The Supreme Court of India in its long hearing from 1998 to 2005 passed a verdict in 2005 to protect the cow but nobody in the government gave heed to it.

(c). The bill to ban has been brought out thrice in parliament but

- (i). at one instance government in the year around two thousand one presented the bill in the morning but withdrawn the same in the evening citing that it will be discussed later-on,
- (ii) at another instance, bill to ban beef was about to pass when one lady parliamentarian- (claims to be from Hindu community), said I eat beef, so if the bill is passed what will happen to my fundamental right to have food of my choice, and bill got dropped
- (iii). at third instance when bill was presented one leading journalist belonging to Hindu community from Kolkata (who once filed his candidate for the election for President of India) wrote that he eat beef and what will happen to him and person like him-this statement was supported by few personalities in film industries (all Hindu's) and bill again dropped. Since then, we hear few voices but nothing substantial is there for one to say that a bill to ban beef is going to be presented in Parliament.

(d). Spain has full-fledged bull fighting sessions but the same has been objected to by the media in Tamilnadu in India.

(e). We promote preaching on the glory of cow while maintaining silence on bull; nobody talks of growing population difference between cow and bull, buffalo and Buff, of killing of male offspring of cow and buffalo at young age by stopping food to them, of castration of Bull and Buff at young age, of injecting cow and Buffaloes for easy mulching, use of machines for mulching of cow and buffalo and of artificial insemination of Cows and buffaloes.

(f). Current government holding office since the year 2014 is keeping mum on all the issues related to Beef. Though this current government run by the political party who claimed itself to be savior of dharma, its leaders call Cow as their mother, they pay respect to Nandi(Bull) in the temple of Shiva, promote brigade to save the cow but do not utter a word even when the Beef export is increasing year after year. Surprisingly, it did come in the notice that Cow is slaughtered but declared as if Buffalo's or Buff got slaughtered, as there is no difference in the meat of Cow and Buffaloes so the issue gets diverted.

* As there is different nomenclature for chicken and mutton so it is obvious that there should be differentiation between the flesh of Buffalo and cow's, Beef can be fit name for the meat of Buffalo's but how it can be for the Cow clan?*

Question: Is it so? What kind of people are they?

Answer: You can draw your own conclusion, hypocrite or emotionally, morally, ethically living dead or whatever you want to.

It is said that these people got degraded since they start castrating most of the bull, leaving very little for progeny, then these people start using these castrated bull - named as ox in farming and transportation, which resulted in impotency, incest, hopelessness, helplessness amongst this class.

Further when few religions officially accepted eating of meat citing value of choicelessness and giving sermon that such disciples should not have any discretion to select his/her food, and another religion that one should keep away from direct killing however one can enjoy fruits of killing (like agriculture causes lot of violence hence keep away from agriculture but one can do business of agriculture) made these people more or less a utilitarian lot.

Question: There are two more questions one regarding the quality of beef we are getting and second will the ecological disturbance affect us which is caused by excessive cutting of tree to facilitate cultivation of sugarcane, tea, coffee, grass besides small quantity of ginger, cardamom which are needed for preparation of tea added with milk, sugar and spices in those country.

Answer: This is definitely a cause of concern for which we have promoted discussion on climate change and follow up actions, it is expected that some solution will emerge from this exercise, don't worry.

Question: How long are we going to have an edge on them?

Answer: This is the question they should be bothered more about. We are all humans and every race is almost equal in our Physical, mental, emotional and spiritual strength. Our edge on them is not because of our extra strength but it is more because of their weakness. It is simple if one is killing bulls, he/she will be bullied, if one is mercilessly castrating bulls then he/she will be treated mercilessly like an Ox and as such will become a coward and will not be in a position to counter. Look at the condition of those who use and abuse Bull and

cow, Buff and Buffaloes, how pathetic it is, whether they are farmers, milkmen or their priests, do you think will they ever have a mind to mend their ways? In a way they have annoyed the very god they pray. What else you want to listen regarding our edge on them.

Question: So, we can be assured of a continuous supply of beef?

Answer: Yes of course, till we maintain our hegemony, rest time is the master.

Question: One last question, as we are doing so much cruelty on the Cow clan and on other animals, will it not be proper to think that In return mankind must be getting cursed by all these animals. Can it not be concluded that all the milk and all the produce in the field made with the help of animals must have become cursed? Will drinking such cursed milk and eating such cursed food not make us an evil lot?

Answer: In a way you are right, maybe we have to search for a newer way of living?

Note

(i). Every religion in the world found to be having some connections with the Cow and Bull, few considered cow a necessary part of their sacrifice and cleansing process, whereas few other regard Cow and Bull as sacred, One religion says the present enlightened personalities would have been a cow in their previous births before liberating, hence, a cow will be worshiped in their religion after she sheds all karma and gets liberated,

A few religious people even add that cows and bulls in present incarnations are living a curse of the god and goddess. But one thing appears very saddening that, People of all these religions put together left no stone unturned to commit crime on cow and bull, which in reciprocity made not only the entire humanity a miserable lot but relegated the entire earth and its ecosystem.

ii. It is said that Maharishi Durvasa is the first who said Mother Cow and performed the prayer of Cow with that of Bull, the symbol of love and power. It is more so because by drinking Cow milk nature/character/DNA of the baby/person or whosoever drink it (whether baby of Dog, Cat, Lion, Elephant, Pig etc.) remains the same which otherwise not the case when one drink milk of the Buffalo, goat, Camel, Lioness etc. this is basic reason why still in India any

Baby deprived of its mothers milk (for whatever reason) is being suggested to offer the milk of cow and not even that of another woman maybe her being the relative of the baby.
