# Contentious issue in concurrent religions:

1. Why do religions appear to have failed and are becoming irrelevant? Because, when one has a problem and he/she goes to a religious place, he/she receives only sermons, sermons from priests either of his/her own creation or excerpts from some holy texts and matters end there, without any real and visible support. He/she has to come empty handed to face again the same situation whether it's of basic hunger, cloth or shelter or of needed support to find a peaceful environment away from one's home/house/neighbours or to have a place for expressing his/her creative pursuit.

Further, think of a situation wherein there triggers a casual clash/fight within a family, and if a person wishes to go out even for night/few days for the matter to cool down (if not settled) of its own accord? Alas! Currently there is no respectable place for a man to stay if he doesn't have money, and even more so for a woman.

Above can be summarized that we all are living in a world where insecurity of food, cloth and shelter in the mind of each human being is providing security to the system.

Can we call it a happy and healthy state of affairs? Can any religion justify such an insecure, unhealthy, unhappy state of affairs at least for its own followers, what to talk of a non-follower, an atheist or an agnostic or its disbeliever critic? Can in such a situation one will be able to maintain his/her religion/faith and willingly contribute toward maintenance of so-called religious institutions/faith centers?

2. Surprisingly every preacher and priest of each religion says that their god is Omnipotent, Omniscient, Omnipresent, Omni-powerful and is the supreme and an integral one, still such clerics/priests presume and assume that there so called god will not bless his/her neighbour who call this god with another name and pray in different style and format. Further such clerics/priests of every religion says with unfound confidence that their Omni god will certainly not reach their neighbours who do not respect, understand and obey to their version of god and certainly will not reach to that person and bless him who is unaware of their version of god.

Can any priest/clerics, be able to dwell on, how come their Omni god is so small that it is not able to penetrate its neighbour, who doesn't echo the same sentiments and such neighbour can be declared as atheist or non-religious or even Satan and deserves horrendous punishment? Does it make any sense?

**3.** All religious masters of every religion appears to have ignored the basics of Dharma, that faith/Dharma is foundation/base on which superstructure of Rajniti (Politics) is built and as such it is the basic responsibility of Dharma (Religion) to look after to all the basic requirement of Food, Water, Cloths, Shelter, Employment, Entertainment, Education, Health, local administration and justice.

All religious masters of each religion instead of providing these services to their clan, followers and supporters kept themselves busy in propagating dreams of life after death, inculcating fear amongst its followers, showcasing supremacy of their religion and inferiority of others and have generated more hate and enmity in society than peace and harmony. All these religious masters put together have shaken the faith and made life miserable of almost all of their individual followers as well as collectively of the entire society.

As Faith is innate and central (heart) to every living being, hence when faith is shaken then it is obvious that the heart will function erratically. If this condition persists for long it will eventually disturb inner balance and immunity of the

person which obviously leads to disturbed sugar level (diabetes), hopelessness (heart disease), helplessness (Cancer) and make him an easy prey to all kinds of other diseases.

As per Buddha, his religion will last for twenty five hundred year than he will get reincarnated and appear as Maitray, Christians discusses lot about doomsday, Paigamber Sahib though, many says him to be the last messenger but it is said that after fourteen hundred year two person (messenger) will appear who will establish peace in the world, Jews as per Torah (religious book) say that this is the last generation whereas Hindu's say that this is the time of transition towards the new era.

**4.** Severity of religious contentiousness cannot only be noted at world level by religious genocide in world war-II, but gravity of situation can also be recounted at regional level by many a incidents of religious hatred and consequential large scale killing even in Indian subcontinent as well. Separation of India, clashes and ethnic cleansing in Thailand, Sri-Lanka, Myanmar, Pakistan, Bangladesh and Afghanistan are few of spine chilling incidents in the Indian-subcontinent.

All these ethnic killings and cleansing are not a stray and stand-alone incidences but a culminating result of religious hatred purported by priests

themselves not only against another religion but also amongst different sects of their own religion—as a Racial and facial, Caste, Class and colour discrimination.

Those who says that Religion doesn't teach or preach or are involved in breeding of enmity even after witnessing current world wide scenario wherein many a religious preachers and priests are not only found to be involved in inducing fear and mongering hate but are actually involved in promoting crime against one religion or the other, can said to be living the life of an Ostrich.

Looking at the chaos it can easily be conceptualized that universality of dharma has slowly but steadily deteriorated first from Universality to Humanity, from Humanity to religiosity, from Religiosity to regional religiosity then to locality to lastly to individuality, which reflects that not only the fabrics of family, society have disappeared but the entire environment got topsy-turvy which has put questions even on our survival.

Looking at this scenario, what can be said, where are we heading?

- i. To another world war with genocides?
- ii. Toward the doomsday, or toward becoming a scapegoat of a situation planned by somebody to arrange doomsday and declare himself as Messiah.
- iii. Is it time to leave the earth and settle on Mars?
- iv. Is it a time for the end of evil and resurrection of righteousness?
- 5. It appears that all the religions have lost their relevance, which in a physical world has clearly been demonstrated during the Corona/Covid lock-down. Almost all the Religion appears to have succumbed to the onslaught of modern days diseases and consequently almost all centers of worship and their priests have surrendered to the dictates of the disease and left its followers to face the dance of death. Situation has become alarming when people find that many paramount places of prayer can also be put under lock-down and these too cannot console and provide solace during an urgency and emergency. When almost all centers of faith-worship along with centers like Vatican, Mecca-Medina, Jerusalem are found to be under lock and key, how come faith of an ordinary people will remain intact?

All these Temples-Mosques, Monasteries and Churches which have witnessed closure and put under lock and key basically sent in a message that these center of worship and its preacher cannot be relied upon, has become irrelevant and have put serious question mark not only on sanctity and continuity of all these centers but also in the continuance of these centers as well as mundane rituals these centers use to perform. In such a situation will it not be prudent for all of us to divulge on the issue with an open mind and big heart and decide whether such centers deserve to be abandoned or permanently closed or respectfully exterminated or let out for other purposes including museums for history and tourism.

In such a situation where every religion in its present form has proven to be incompetent enough to deal with recent situations, now it is useless and senseless of any one claiming himself to be its contractor and saying that his religion is best and risking their life or taking others life in its name.

Further, one gets surprised to see that now Jains and Buddhist are talking of arms and aggression, Muslims are talking of peace and tranquility, Jews and Hindu appear to have lost their traditional cool and appear to be going berserk.

As natures abhor vacuum, so even if business of religion has restarted as usual after lock-down, people have found out that prayer is personal and can be performed personally or with the family or online with the group in place of previous methods of community prayer. Whatever current situation appears to be precarious and calls for an early discussion in the society which is direct, straight and head-on about how in future people can maintain their faith and find solace in normal days as well as during urgency and emergency. #### 1. on Satan and Saints:

**Question**: It is in the open domain that so-called Satan's and Saints appear to be in agreement and are pointing toward the same situation, similar future, and which is alarming, turbulent and dangerous, which of course on-going world events do indicate?

The so-called Satan's say that the situation on earth has become unlivable and earth cannot sustain the burden of a seven hundred crore plus human population for long. If earth is to be maintained sustainable then at least ninety percent of the human population must be terminated, leaving only ten percent of the population that is approximately seventy crore people on the earth.

If this human species had intelligence, it would have controlled the population, but these people are crazy – their leaders are all crazy, they are increasing their population, and if the earth has to be saved, then these and other crazy people like them should be eliminated and only those who have money, who are connected to our system, who have achieved something in life, who are

capable, competent, have the right to survive, everyone else should die or be killed like insects, mosquitoes, fishes or chickens.

It is common among these global members of the inner world that earthquakes, volcanoes, storms, cyclones do not have any significant effect on the population and nuclear bombs can also pose a threat to us – that is why it is necessary to find such methods by which the majority of the people get killed.

Surprisingly every preacher and priest of each religion says that their god is Omnipotent, Omniscient, Omnipresent, Omni-powerful and is the supreme and an integral one, still such clerics/priests presume and assume that there so called god will not bless his/her neighbour who call this god with another name and pray in different style and format. Further such clerics/priests of every religion says with unfound confidence that their Omni god will certainly not reach their neighbours who do not respect, understand and obey to their version of god and certainly will not reach to that person and bless him who is unaware of their version of god and all such who doesn't echo the same sentiments can be declared as atheist or non-religious or even Satan and deserves horrendous punishment?

ii. Since the time immemorial it is a holy proverb and broad understanding that to survive in a healthy and happy way, "Surrender and pray to the god the way one wants, and love thy neighbour the way they deserve and you can oblige".

This understanding found-out to be so natural and common that it gained eternity/perpetuity (Sanatana in Sanskrit) and thus continues even today as

basic tenets of Dharma/ religion at least amongst Saints, Sadhus and common people.

iii. Problem started in this era (at the onset of Kalyuga itself) when variations in the basic tenets started taking place like; "Surrender to god, but by narrating the same name as has been told and perform the prayer in a same way as is being demonstrated by priest and then Love thy neighbours, if neighbour belongs to be following you i.e. taking same name and performing the same prayer (that means if person belongs to the same religion).

Further, in order to recognize fellow disciples, dressing with a special robe or getting completely disrobing, wearing a mask to cover mouth or going public with full face cover, bodily mark or unmark, tonsuring the head or not cutting the hair at all, special cap, turban became common for all these religions.

Further to it, since everyone is born with a purpose, a purpose to pray/submit to the god and love thy neighbour, hence it is duty as well as obligation on the part of followers to spread the love to thy neighbours.

If your neighbour is not your type, convert your neighbour to your type, by any means or all means, since loving thy neighbour is a religious commandment. This practice is started and is in place at least after Buddha if not earlier.

iv. Since in this small world everybody can be said to be the neighbour hence followers of the religion must spread the religion throughout the world. Since everything is fair in love and war so in order to obey the dictate of such god, i.e. to love thy neighbour one should not be worried about the tone and tenor, mores and methods, or clashes, fight or war it may require or of enslavement, forced begging and prostitution it may cause to make (convert) thy neighbour so that they become worthy of being loved. , even if it ask for abuses and causes,

v. Though these all religions talk of freedom, freedom so that they can convert and love their neighbours but these religions snatch the very freedom from its

own members and this they do out of fear so as to ensure that their own followers/members should not get converted.

These religions not only treat members of their own clan as puppet or pawn in the name of all pervasive, incomprehensible and invisible gods but also put sufficient code of conduct and blinders as if members of the religion are part of an army and on a secret mission on this earth.

Further, all these religions knowingly or unknowingly put sufficient divide between male and female in their own clan and not only put females on the lesser footage but professes that women can't afford freedom hence deserves to be kept under watch and can be treated that way.

In this scenario a problem is bound to arise when religions famous for loving their neighbours (of course after converting them to their religion) confront each other, of which verbal clashes, to fight to war and world war can said to be the obvious outcome, and at this stage these religions have become an easy tool of war lord and war industries, which the world have witnessed too.

# 3. Religions – Miscellaneous view:

- **3.A.** Further to it, all these religions at least from Buddhism onward appears to have got so busy in loving thy neighbour and other associated activities involved in this kind of love that these have forgotten or have not bothered to focus on the basic issues which life offer and demand one's attention, such as economy, employment, entertainment, energy, environment, ethics, etiquette, pollution, population, poverty, prostitution, cleanliness, hygiene and health, forced begging and slavery.
- **3.A.i.** Rather most of these religions themselves got involved in the unnatural act of curtailing growth of trees by making it Bonsai or castrating bull and making it ox, or castrating male and female (physically or Psychologically) and making them dwarf, transgender or celibate.

Further these religions got into the sacrificial ceremonies of goat, buffalo, heifer cow, Camel and human baby, forgetting the basic that an omnipotent and omniscient god knows the intent and can't be fooled by such sacrifices.

- 3. A.ii. When the ritualistic sacrifices of young babies were prevalent in few regions, a question arises how to save one's own-self as well as young babies from this type of sacrifice. Solution to this problem came from the main condition of such sacrifices that "the object of sacrifice should not have any bodily defect otherwise curses of the deity in place of expected pleasantries will follow", and as such started the circumcision in male and FGM-female genitalia mutilation in female (at present -year 2024, there are at least twenty crore female cases of FGM in the world]. Truthfulness of these acts [male circumcision and FGM (female genitalia mutilation) can be gauged from the fact that still today many a priests refused to perform prayers on behalf of such male and females saying that they are having bodily defects and so not fit for performance of prayer either self or by somebody else on their behalf.
- **3.B.** It may be surprising but fact remains that no religion from Hindus to Jews, from Buddhist to Jains, from Christians to Muslims, from Sikhs to Baha'i has talked about modes-operand of cleaning of common area and providence of cleaning in the community? No religion has deciphered on, "who will do the cleaning of the common area, why he/she will do it, what will be its wherewithal? What remuneration and respect will be attached with it? If physical cleaning is not proper, which is visible and somewhat easy to do then what can be said about the secondary cleaning and tertiary cleaning of mind and heart?
- **3.B.i.** With this type of shortcoming in all these religions, what happened was that its members became easy prey to the monsters of the market and masters of cunning art. Because of this basic shortcoming of all these religions, its members found to be easily usable or manipulated by market forces, hypocrites (fearful from inside but projecting to be bold) and lacking clarity. Though all these Religions have professed peace but ultimately became a partner in the crime of reducing humanity into more pieces than nature can afford.

**3.C.** Almost all the Religion appears to have succumbed to the onslaught of modern days diseases and couldn't sustain the onslaught of recent lockdowns, and let down its believer/follower by leaving them in lurch to find their own ways during difficult situations and left them alone to face the dance of death during an unparalleled crisis.

Situation has become alarming when people find that many paramount places of prayer can also be put under lockdown and these too cannot console and provide solace during an urgency and emergency. When almost all centres of faith-worship along with centers like Vatican, Mecca-Medina, Jerusalem are found to be under lock and key, how come faith of an ordinary people will remain intact?

These are the very religion who asks their followers to not only offer share in their income, but to wear special dress/uniform/robe, keep unique and easily identifiable/distinguishable facial and hair style (as if believers/followers are part of battalion or business outfit or children's school) but even to give their life to save name, place and pride associated with the religion they are associated with.

**3.C.i.** In such a situation where every religion in its present form has proven to be incompetent enough to deal with recent situations, now it is useless and senseless of any one claiming himself to be its contractor and saying that his religion is best and risking their life or taking others life in its name.

When we are witnessing preaching of all kinds of differentiation and divergence by almost all the religious rightists it becomes a big concern especially when the world is witnessing the turn of events at a very fast pace like few years back nobody in the entire world in their weirdest dream had ever thought of lockdowns and its follow up, hence if few amongst us are getting bizarre feel of repetition of genocide which took place during world war II and that it can be reactivated through initial sectorial, religious and regional riots, to a full-fledged deadly version of genocide, Ecocide (environmental killing), ethnocide (ethnic killing- in line with specific pesticide, insecticide and herbicide) or even

rumors of attacks from UFO, asteroids and aliens, is bound to create sufficient panic.

In this panicky situation will it not be prudent of us to come forward and collectively put our entire effort for resurrection instead of relying on these ill find religious mongers of fear, hate and breeders of enmity.

# 4. Religion – Indian Scenario:

**Question**: Since we are talking about religion in general and its assimilation in India in particular, so will you please let us have some vague idea so as to know where our efforts should be i.e. where we missed?

# Answer: Following is submitted:

i. In countless searches happiness is found to be the only life sustaining force and for happiness to remain a reality, safety and security has to be safe and secure. First and foremost security is physical, emotional, spiritual and Justice secondary security is of food, water, shelter and clothing, tertiary is of energy, entertainment, environment and health, and education, and then of remunerative employment and respectable engagement, India that is Bharat have missed to provide physical safety to its own people and those who were dependent on India.

On the religious front Bharat which used to follow the basic dharma which can be said to be eternal-perpetual in English or Sanatana/Shashwat in Sanskrit was/is and will remain as primal dharma.

Then these new found religions become able to brand Dharma the Sanatana (eternal/perpetual/Javed/Dwami] first as Sanatana dharma than as Hindu Dharma (even when there is no such mention in Gita and/or other scriptures) and then breed in enmity amongst followers of their version of religion with that of Dharma the Sanatana.

Enough mud has been thrown on India and enough hardship including slavery has been witnessed by India which unfortunately resulted in India's own children fighting amongst themselves as they are their enemy number one forgetting that they are their own brothers and sisters.

This internal bickering is helping war lords and war industries to earn their profit at our expenses and miseries, so what is needed by us (India) instead mudslinging (especially between Hindu's and Muslims) to primarily improve upon the physical security before anything else for which as submitted in detail in the book Alternate economy that one fourth population must look after the various facets of security out of which one fourth must be inducted into the providence of twenty four hour safety and security. This means that approximately eight crore youth (male and female) must be inducted by the society at the expense of society itself to provide security. As per basic mindset women can decide to be in charge of internal security whereas men can that of external security and get trained accordingly in martial arts and weaponries.

ii. So when the superstructure appeared to be getting dilapidated it remains the only option to visit the original-aboriginal-and once again take the clues/lead/direction from these that how these (tribes) have taken care of basic securities (physical security, food security and of shelter) and carry-out their administration, justice and maintain their clan, taking care of basic health, education, entertainment and environment protection along with doing their prayer which makes them perfect to sustain themselves from the ages.

To affect the long lasting change in the society, country and the world it will be prudent to open up dialogue and consequential actions therein on religion and natural laws between different masters of each field. Should we wait for some magic and miracle to happen or for some new god to descend from the sky and solve our problem? Or should we rise to the occasion and start working for the resurrection?

It is the time for saints and sages to contribute openly and try to heal the wounds inflicted upon by people and forces having a negative mind-set.

#### iii. India's overall scenario:

Following can be a few of the parameters by which any ordinary person can ascertain that ground reality of India, which of course is not in a good shape and require urgent healing:

- a. Prime minister office itself accepted that there are eighty crore (sixty percent population of India) people in India which are poor and deserves free ration, (As per: https://www.india.gov.in/spotlight/pradhan-mantri-garib-kalyan-package-pmgkp, india.gov.in, national portal of India). Further the government of India offers only approx. eight thousand rupees in four installments to four crore farmers which are considered poor as an honorarium in a country which claims it to be agrarian.
- b. There appears to be no social security; one can encounter countless beggars in any metro including India's capital Delhi.
- c. Lead time in delivery of justice, more than five crore cases are pending in different courts of India out of which eighty thousand plus are pending in Supreme Court of India. Further there remain no avenues to complain of exploitation and find solace (either by workforce or by owner or by relatives).

- d. Money spent on education, recovery from diseases and in getting justice from courts, is getting increased day by day, vis. a. vis. money spent on health and healthy habits, entertainment and celebrations?
- e. Condition of forest and water bodies, quality of fresh air and water getting deteriorated. Noise level has increased multifold to an unbearable level in the colonies, market and at religious places?
- f. Saints/Sadhus/Fakir, Masters and Priests, Elders and Leaders appeared to have lost faith in them, consequently lost respect in the society hence these are forced to accumulate wealth for their personal survival?
- **g.** There remains no availability of avenues to seek small favour (say money for travel expenses) in case of adversity at distant places away from one's home, similarly there remain no avenues to report for small exploitation and get immediate solace.
- h. Value of Indian currency vis. a vis. other currencies of the world are decreasing.
- i. leaders are observed to be frequently changing their stands.
- j. Meaning of basic words like, 'Family, Society, Yoga, Dharma-Nirpekshta, Secular, and world is a large family (Vasudhaiva Kutumbakam) have gone awry.
- k. There appears no guidance available at the local level on what, food we eat, liquid we drink, things we smoke and material we read and watch, which basically shape the citizens, their society and country..
- I. Their appear to be very lull in business activities in the area of hygiene and cleanliness, entertainment and recreation and teaching of ethics and etiquettes etc.
- m. There appears to be no effort and even proper discussion with regard to ending poverty, unemployment, loneliness, obesity and malnutrition etc.

n. Howsoever smartly one justifies his/her act and deeds on economy of war bound economics of hate, terror, rioting but the fact remains that all the destruction made by these war mongers and businessman of war have made the world inhabitable for birds and animals, flora and fauna, fishes and fisheries life and lastly these people with tinted business orientation are trying to make human like a living Robot.

iv. In such a situation what can society do to put checks and balances so that we all can live happily in a sustainable manner?

Spiritual Masters and people with greater introspective insight and prospective foresight, do suggests that a wider churning and "Resurrection of Dharma and Dharma Sansthan (Religion and religious institutions)" will be a viable alternative over and above forecast of Saints and fratricidal/suicidal actions of Satan's (power blocks).

That is, whenever there is a decline in religion on earth, the influence of the wicked and the arrogant starts increasing, to alleviate the suffering of the noble people, god the repository of compassion, takes incarnation in different forms according to time, period and circumstances. Now, according to various Saints, the process of freeing the world from the sins and sufferings and blessing the world has already begun.

iii. will be able to perform such task and how he/she will be treated, respected and rewarded.

Then almost all religion do not specify what this person's (or anyone) right and responsibility, share and contribution at different age in one's life, what one can expect from the society/government and what society and government can expect from him, then what will be one ones right and responsibility toward other animals, birds and fisheries, trees and plant, environment and nature at least with respect to maintain clean and hygienic environment, and as such all these religions has handicapped its own disciple, when followers/disciples have to deal with life in totality.

iv. It is argued that faith and procreation is innate in every being which is deep rooted and is central to every living being including humans, hence if we are witnessing dirt/filth/scavenge all around then it is certain that the faith of all section of people cutting across religion and region must have been shaken. \*[Entire world is one but a large family is the most basic understanding of Dharma, which hitherto many religions found to be reluctant to agree at first place unless they saw people of all creed and colour accept their version of religion. Now, an outbreak of disease and worldwide lockdown has proven beyond doubt that the world is one. Had the world been not one, how come one disease could have possibly been able to affect the entire fraternity on the earth?]\*

Dharma stands by the virtue of freedom and virtue of love. People like dharma and embrace dharma because Dharma offers all, with its complete magnanimity and not by inculcation of fear of ghosts and hell or by bullying in open and Punishment in jail among the masses which almost all concurrent religions and governing systems of societies and countries are practicing/doing.

Dharma is wholesome and provides holistic approach toward all transactions which life offers, it neither involves itself in business nor to support/favour business entities at the same time it does not become henchman, propagandists or frontal organisation of political or ruler or expansionists.

Dharma never asks anyone to castrate Bull and Buffalo or for male circumcision or mutilation of girls genitalia (FGM) for one reason or the other including forcing them to become celibate, or to safeguard them (boy and girls) from complete sacrifice by making and declaring them an entity which has already been symbolically sacrificed to the almighty.

Dharma also does not ask anybody to restrict growth of anybody be it human or tree and make them Dwarf and Bonsai. Dharma never asks to imprison anybody be it fishes in the Aquarium, Parrots in the cages and animals in the Zoo's.

Dharma simply asks us to celebrate life, maintain physical, mental and spiritual cleanliness and hygiene of self and that of the entire environment. Dharma simply allows every living being (including humans) to enjoy life and allow others to enjoy and eat that which maintains sanity of one's mood and drink that which maintains sobriety of voice.

Dharma never asks anybody to worship nor does dharma restricts anybody to worship in any way or any form (idol) or formless or even get one-self worshipped, dharma simply asks to follow the dictates of innate faith/consciousness and continue doing one's work-karma (one can also say; work is religion and work is worship).

When one is in doubt Dharma asks one to look toward Ocean and Forest, earth and sky and may try to appreciate how Dharma and larger order is being maintained in these places and followed by birds and animals, fishes and fisheries, flora and fauna etc. Still if one (religious masters) is in doubt then he/she can interact with Tribal/Aborigines/Aboriginals from where the entire

civilization is said to have evolved and appreciate the dynamics of life and dharma.

Still further, if one has more doubt than he/she can pray to the visible god the Sun, for guidance as the Sun is the only visible entity who knows all the form of Yoga and its complete vistas (It is said that at the beginning when time was not there than god thou self narrated yoga to Sun). Though people world-over when performing yogic exercise first thing they do is to do Surya namaskar (Salutation to sun) but unfortunately the basics of yoga has been forgotten for centuries together and what remains is only a form of exercise/ritual. Here respected masters, saints and sages may like to narrate the same again and resurrect the basic dharma for our collective happiness.

There is no exact word for Dharma in English; hence the word Dharma is used.

## i.a. Dharma (religion) concurrent understanding- an observation:

It is to my utter surprise that none of the scriptures of previous/bygone era available across the world specify/attach any name to Dharma that wherever faith is being referred to is narrated as Dharma only I e. no noun or brand name (like Sanatana, Hindu, Jews etc.) is appearing before Dharma.

However when the quality/characteristics of Dharma is being exemplified as Sanatana(i.e. eternal, perpetual, perennial, continual etc.) for example in Gita, if we see in its one of its most famous sloka/statement than one will appreciate that it mentions only Dharma (without any string/prefix or suffix attached to it) is being said in famous sloka In Sanskrit)

यदा यदा हि धर्मस्य ग्लानिर्भवति भारत।

अभ्यृत्थानमधर्मस्य तदात्मानं सृजाम्यहम्॥

Further, in many places in almost all texts of previous era one will appreciate the statement: "Dharma the Sanatana", but nowhere one will find writing like: Sanatana Dharma.

With the above it can be said that everybody is born with Dharma (Dharmic) which is Sanatana (perpetual, eternal etc.) in nature,

it basically later on when the deterioration started brand names(unnecessary baggage) started getting attached to it and problem start getting cropped up. The problem we are facing is because of the branding of Dharma, which now is being known as – 'Hindu, Jews, Buddha Jain, Christian, Islam, Baha' I, Sikhs etc.' is not going to be solved by any religious conversion, whatsoever, but by dropping/abandoning all these religion all together. When we are done with this dropping/abandoning/leaving, we all will come to our originality – a real Dharmic which is being characterised/described in different language by different words like: eternal, perpetual Sanatana, Javed, Dawami etc. Above is so simple but found out tough to get appreciation of.

ii. What is Dharma Sansthan (institutions for dharma)? Dharma-Sansthan is an institution which caters to the needs of the entire society in its entirety in a self-sustainable manner without any bias and prejudice. Such self-sustainable Dharma-Sansthan (Religious institutions) had been kept on working continuously (perennially) for ages.

In fact, because of the perpetual working of this system, this system itself has been assigned the name Sanatana. Further, because the working of these Sansthan is observed to be performed with full Dharmikta (with full religiousness) hence this has been nicknamed as Sanatana Dharma. However few say it is the other way round that because of the basic understanding of perpetuity these Sansthan could perform in a sustained manner.

Dharma Sansthan can said to be an institution which will offer food to hungry, water to thirsty, shelter to destitute, treatment to diseased, advice and justice to needy, help to helpless, employment to youth and respectable engagement to lonely and elders beside providing physical, financial, emotional security to all the individuals in its vicinity in a non-exploitable environment, so that there remains no destitution, forced begging and forced prostitution.

Due to obvious complacency which generally appears after a long term successful operation of institution and idiotic desire to improve upon even the perfection, society contributions in its own such institutions reduced thereby

slowly and slowly, such institutes found to have become non-existent in the last three thousand years.

These all religion- Hindus, Zoroastrians, Judaism, Buddhism, Jainism, Christian, Islam, Sikhism, Baha'i how so ever holistic each one claim it to be but the fact remains that none of these religion has been able to provide healthy and happy life style even to its disciples at equitable platform in a sustainable manner, hence resurrection of Dharma Sansthan can be said to be the only option so that the life on earth can find itself rejuvenated once again.

iii. What is Rajniti (ethics of governance as well as of keeping secrets – which in English known as Politics)? : Rajniti is an ethics of governance and also government functioning on the basis of ethics, whereas ethics is that which emanates from earth and its environment (नीति नियामक से आती है).

As the environment keeps on changing with the passage of time so the environment can say to a dynamic entity. Earth in comparison to the environment can be said to be a static entity. As Rajniti is firmly footed with Earth hence Rajniti can be said to be static but as Rajniti also reverberates with the environment hence Rajniti also becomes a dynamic.

In view of this mix, Rajniti is said to be an experience and its expression which is firmly footed yet flexible enough. In view of this definition it can be construed that Rajniti is not a Job/Profession but an engagement toward society for the collective good of society and its surrounding environment. Such Rajniti can be said to be performed by the persons whose basic family needs doesn't require his time and money i.e. at a time when his/her children got married, and involvement in such Rajniti can be continued till his/her children become available to take his/her place. This means the age for an active Rajniti (Voting as well as contesting an election) can be from fifty year to seventy five year approx. After the age of seventy five years such respected personalities generally would like to enter into educating and training the newcomers.

**Politics is a profession and politicians are professional** which definitely deserves equal treatment vis. a vis. other professions which hitherto required for smooth

functioning of country and society. Politics is basically policing on set rules and regulation devised in Scriptures of religion and/or Constitution of country. As the Constitution of the country is static (remains more or less same even with the change of scenario and time) hence the constitution is generally found to be inept in dealing with the issues which appear at different times.

There is no exact word for Rajniti in English; hence the word Rajniti is used.

**Question**: What lies ahead?

Answer: There is nothing new under the sun; whatever is placed herein or in the mentioned books was in vogue. It is said that with the passage of time it is usual that complacency crops up in the system and after a very long stint of smooth operation people start applying their mind and start fiddling/playing with the system on a pretext of useless logic that there remains always a scope for improvement.

A. What is practical: If you have done any practical in your life then will appreciate that for any practical, there is theory behind it, theory of cause and effect, theory of process and theory of interactions of various constituents and then following these theories one gets result which may be as expected or not or result may be a surprise – a brand new thing. if practical is bigger its result may take more time, space and energy like birth in different species (rat, cat, dog, human, elephant etc.) different time. Thus, to be practical, means that we will try certain things, we will follow certain systems and procedures and then what the result will be like, we will accept.

Whereas, things that are in practice are the result of earlier practical (conducted by someone else) and not a fresh one and has become routine, you can call it whatever you wish to. Generally, in day to day routine work theories are written for children to do and they call it a practical book, as for them it is a new thing and so they call it a practical way/option.

- **B.** What philosophical presentation is: As far as philosophical presentation is concerned, it is generally being prepared and presented in two formats:

#### C. Do list:

i. It can be said that with this little effort our entire system will be amended.

**Question:** will it not be too much of celebration that whoever comes includes him, and offers him Prasad and shelter?

**Answer**: if you want to be miser in celebration/enjoyment/party then it will be fair for you to live in a disturbance and problems, then why in the first place do you search for a solution?

**Question**: how long is this festival to be celebrated?

Answer: as long as you want to live happily, when you feel bored with happiness and you want to live unhappily, disturbed or you want to quarrel/clash with someone then you may stop celebration.

It's like this whenever there is a fragrance there would be happiness, where there is a foul/bad smell there will be a noise and bad mood. Festival is attached with enjoyment and dispute with restlessness.

Question: if we have to celebrate like this, constantly and continuously for a long time, then we have to make arrangements for staying, health, for security and cleanliness of these places, then will it not be like an alternative arrangement? How will it be managed, where from the money and other resources will come? When people will stay longer they will ask for jobs as well, then where from one will generate jobs for them?

**Answer**: Well, it will be an alternative arrangement in today's scenario but this was an arrangement, which can be said to be good.

As far as money is concerned, a person's income includes twelve point five percent (one by eight) for her mother, father, son, daughter, husband and government and also for society (Dharma/Religion), when this money which is part of society (religion) start flowing to society, then there shall be no shortage of money.

Besides this, when celebration shall be on continuous basis then lots of aged people and children will come then expenditure toward orphanage and old age homes shall get reduced. Then when we give a job to the person who will be staying here, then it will generate additional income to this place. New constructive work shall be made in this alternative arrangement which will be such wherein machine like cycle will suffice the purpose for commutation hence expenditure will also get reduced.

### C. A conversation with River Ganga,

Question: It is said that your great-self- Mother Ganga, since ages keeps on washing the sins of people; do you really do so?

Ganga: Oh! Yes.

Question: That's nice, then you must have accumulated scores of sins with you? What do you say?

Ganga: People find great difficulty in leaving anything and find very much ease in taking, so though the people come here to clean their sin but most people

instead of leaving their sin here they add in their kitty. in fact it is very rare to have one, who really feel like washing his/her sins.

Myself collect all such sins, take it with my flow and discharge it to the Ocean. Ocean, evaporate these sins to the cloud and then the cloud discharges these sins through rain. This is how myself, Ocean and clouds remain free from sin.

Pilgrims are also being undertaken by absconders and those who avoid taking sides even at the time of major conflict, dharma-Yuddha (By Balram During Mahabharata) but these are rare incidents.

They say that pilgrimages are mostly undertaken by the above two kinds of people, so to plan the entire infrastructure and support system for such persons and then thinking or to prepare the entire business model of a city or country on these lines cannot be appreciated.

Promotion of Religious and medical tourism can be said to be a sick and sadistic mentality, is a death centrist approach which is indicative of degradation of society, and as such cannot be considered a worthy proposition for society or country.

**E.** Tourism is mainly a pass time activity with a desire to get refuge at a better place at least for a short duration so as to escape from routine activity and/or

get rejuvenated. Generally tourism is supposed to be getting acquainted with new geography, new places, culture, traditions, people and their lifestyle either by traveling to different places or by attracting travellers from far flung areas.

To serve the above purpose, it is expected that Society will strive towards providing all kinds of infrastructural support, clean and green environment, a begging and cheating free ambience.

With this understanding, promotion of tourism, if any, needs more forest and forestry, than corporates and industries.

**F.** Being dependent on the income generated/received from the tourist can be a good proposition for priests in Churches, Mosques, temples and beggars sitting outside these institutions but not for any society or country.

Exotic beaches, refreshing wines, countryside cannabis and freshly fired fishes sounds good but many countries have very bad experiences out of this kind of tourism. Further, Economy based on tourism will always be dependent on others, it can never become self-sufficient.

Any tourism development based on religion, education, health/medical is bound to create a hypocritical society and such society and country are bound to generate either inferiority or superiority complexes in the locals along with the situation wherein begging and flash trade find space, whether it is Sarnath, Sri-Salem, Srinagar, Sri Lanka or Switzerland (which we currently are witnessing too).

# Something on what went wrong with India and the world

#### 1. Broader outline:

**Chief- Answer**: We import the same from the Indian subcontinent, Latin America and African countries and there is no need to worry, rather they like to export it in plenty.

**Question**: that is ok, but one never knows, what if the supply of cows is reduced, this will result in less production of beef, which at one hand will raise the price and at other may cause enhanced hunger for beef in our country, have we taken any step in this direction?

**Answer**: Though we take plain tea and coffee here, we have promoted mixing of milk and sugar in those countries. In countries like India, plain tea and coffee means tea, which have tea leaves/granules, water, milk and sugar and special tea means adding Cardamom, Ginger, Basil, etc. in it, because of this very reason they will continue to have large requirement of milk which in turn means large number of Cows, Buffaloes goat etc., When the milk supply dwindles, these pet-animals are forced to retire; these retired cows and Buffaloes are more than enough to fulfill the requirement of beef for us. instance, bill to ban beef was about to pass when one lady parliamentarian-( claims to be from Hindu community), said I eat beef, so if the bill is passed what will happen to my fundamental right to have food of my choice, and bill got dropped (iii) at third instance when bill was presented one leading journalist belonging to Hindu community from Kolkata (who once filed his candidate for the election for President of India)) wrote that he eat beef and what will happen to him and person like him-this statement was supported by few personalities in film industries (all Hindu's) and bill again dropped. Since then we hear few voices but nothing substantial is there for one to say that a bill to ban beef is going to be presented in Parliament. (d). Spain has fullfledged bull fighting sessions but the same has been objected by them in India in Tamilnadu in India. (e). We promote preaching on the glory of cow while maintaining silence on bull; nobody talks of growing population difference between cow and bull, buffalo and Buff, of killing of male offspring of cow and buffalo at young age by stopping food to them, of castration of Bull and Buff at young age, of injecting cow and Buffaloes for easy mulching, use of machines for mulching of cow and buffalo and of artificial insemination of Cows and buffaloes. There are many such examples.

Question: Is it so? What kind of people are they?

Answer: You can draw your own conclusion, hypocrite or emotionally, morally, ethically living dead or whatever you want to. 1. Conceptually it is a wrong assumption and presumption that India is a federal republic or union of state. Traditionally from the time immemorial this geographical area which has at its back the mighty Himalaya and being flanked by rivers Sindhu (Indu-Hindu) and Brahmaputra(Son of brahma/god), on one end and the Ocean on the other has been known as Hindustan or India and its children as Hindus and Brahmaputras. Further, because of the larger effort of people mostly belonging to this area to be the torch bearers to mankind, it has also earned the title of Bharat and then its inhabitants getting known as Bharti, Bharatiya.

In oldest literature this area is named as "Jammu dwipe) Bharat-khande (जम्मू द्वीपे भारतखंडे)" and it is said to be the oldest use of Bharat and the same is still being recited upon in special prayer to address the place, here too, this area has been treated as one and not a union of many areas/states. Further when a citizen of this land goes out to the other side of the globe, he/she is known only as the one from India and as Hindustani/Indian or from Bharat and as Bharatiya but not otherwise.

To say that Bharat is a federal republic appears to be more a design of few master of cunning art who knowingly or unknowingly working with a policy to keep this area divided on as many pretext as possible, so that their direct or indirect supremacy remains and they along with their disciples continue to draw benefits from this area.

- 2. During pre-independence days that is before 15.08.1947 the country had more than five hundred fifty princely states which almost all got merged by choice together to form India of present. If anybody during pre-independence days said that India is a union of princely states then it could have been appreciated, but not otherwise. It is Independent India which has created few states and union territories for various reasons and not because of dictates/wishes or the concurrence of these states that India came into existence and so obliged to declare it to be a federal republic.
- 3. Creation of the state on the basis of languages/ethnicity is the same type of mistake as that of creation of countries on the basis of religion (which India did witness during partition driven independence)].

Any division on the basis of region and religion, caste, creed and colour, language and script are blinders for the growth and development of the very people in whose consideration this division is being pursued (One can look back at the situation of Pakistan, Bangladesh etc. which got separated on the basis of religion vis. a vis. current India which has maintained Dharma-Nirpekshta (religious freedom) in its fold. Any division based is bound to bring negative results except those done for ease of connectivity and operability.

- 4. India's national scenario has become like torn pants and shirt, without banyan (vest), uncut hair, a lot of facial cream and of course gold and diamond jewellery with eyes of everyone wandering in awe such a mismatch has taken place because of this single factor of having state government (Country declared eighty crore of its people that is sixty percent population so poor that they deserves monthly free ration of approx. thousand rupees, and then the country is having four crore cases pending in different states).
- 5. Once a Prime minister (Shri Rajeev Gandhi) in his simplicity and decency has said that when we (center government) give one rupee to the public, only fifteen Paisa reaches to him. Everybody commented on it, some were in awe and some made mockery of him and some even branded his government to be a totally/fully a corrupt government without bothering to give a thought on it that where exactly this eighty five Paisa i.e. Eighty five percent public money goes to? Who all are there who eats up this money in the transactions?

On a simple observance it can be said that whenever Prime minister (center government) is supposed to extend direct cash subsidy or reward/livelihood allowance in the form of some schemes, give the money to the Chief Ministers

(state government) who (system of state government) eats up this eighty five Paisa (percent) money in process of getting it pass to the public. It also appears that the prime minister is aware of this fact but finds him unable/incapable of preventing it and so expresses his helplessness to do anything or to stop this wastage/loot.

Another Prime minister said that since eighty five percent money lost in the transaction (corruption) hence it will be proper for the centre government to bypass the state government and send center subsidies/reward/bonus etc. directly to the account of the beneficiary. This raises a basic question: if the state government and its system is the culprit, then what is the need of having a state government and so many constitutional bodies? Why should we not get rid of all these?

Why were these state governments there in the first place? There is no valid reason for the existence of these state governments. If a country wants that eighty five percent shouldn't continue to be lost in transactions then the country (India) has to get away from these all state governments.

6. We are observing that in India after independence there is tyranny of Indian rulers in place of foreign, this is more so because the structure of governance (Police and administration, Rules and regulation Judiciary system, education, health system and middleman) remained the same as that of pre-independence era with same or similar mind set under the state government.

It is an open secret that the cost of election for one MLA (Member of legislative assembly) is approx. 'fifty crore' (year 2023–24) which for four thousand plus MLA comes out to be two lac crore in every five year to the country and that too all in black. Do we really need to spend so much that too in black to keep the state government and its system?

There appears an urgent need to rationalize the number of constitutional bodies-may be would like to completely abandon many institutions e.g. all the state governments and legislative councils, Municipal corporations, Panchayat and that of government controlled cooperatives.

7. Paradigm shift is necessary, it appears that, it is time for society to rise up and take the responsibility in its hand. Society needs to take entire gamut of providence of local security, all type of justice (by system of Jury), employment, local Planning and partnership in national planning, Religious requirement, Health and education, Media and entertainment, Environment and local

economic activity, collection of taxes, partnership in running of industries in its vicinity and other local issues.

National government on the hand will restrict itself to handling of Constitutional court, Reserve police and army, national and international connectivity (Road, Rail, Water and Air on one hand and audio, Video and data on the other), disaster management and relief operation, national festivals and celebration, contribution in research and development, Foreign affairs and departments for international development, along with system for checks and balances, feedback and corrective mechanisms.

Country can very well be managed by the national government (through elected Member of Parliament) with few Zonally/branch-offices and Society driven district centers (comprising local facilitation cum resource centers).

8. It is said that with freedom comes the responsibility; it is rather the other way round, when one is responsible, then only one can afford the freedom. Let us be responsible and remain responsible for our every act (misdeed or deed) as an individual, as a family member, as a common citizen, as an economist, judge, teacher, politician etc. then only we can afford freedom and maintain freedom and remain healthy and happy.

In view of all the above, it can be said that the very existence of so many State governments in India is detrimental for the long-term growth of the people of that state and country as a whole and hence deserves to be dismantled and if Parliament does find itself to be competent enough to do so, then it is necessary that we (country) go for referendum.

It is the justice which determines whether a family, society, country and/or world are a hell or heaven or an abandoned lot. If justice in any place is denied or delayed or commercialized that place is bound to get degraded toward the abyss. Justice in countries like India has been relegated to the backburner since at least the last twenty five hundred years (if not more) and can be said to be a main reason for the downfall of India and our entire civilization.

## Following is submitted for deliberation:

- 1. "If anyone amongst us at any point of time/moment in our life becomes weak, being beaten, looted and then kicked out from our home/house and we become money-less and helpless, desolate and destitute what will be our expectation at that time from the society and/or government, if not free and fair and quick justice (which include providence of basic food, water, cloth, shelter, medical treatment, security etc. for intervening period i.e. till the justice is given?
- 2. Can debarring any person from availing rightful services of justice be considered a sign of a healthy and happy society? Can any demarcation in quality, quantity and timing in the providence of these three services because of availability or unavailability of finances with any citizen, guest or even visitor be justified? Will such demarcation not lead to formation of an unhealthy and unhappy society?

Unfortunately, at present almost all religions, all regions and all economic systems found to be either indifferent to the providence of rightful services of

justice or found to be submitting to the idea of profit from this most essential service. Few religions and few so-called leading economies even found to be utilizing judicial services to spread their prominence and got themselves officially involved in it, whereas so called backward and developing countries are still in awe of what to do and how to address this issue.

- 3. It is said that agencies involved in delaying the delivery of Justice are not only denying justice but can be said to be involved in future crime. Where justice is delayed (for whatever reason) people break the law with impunity and normal gentleness in the population becomes nonexistent. Where justice is delayed children become fearful in their own homes and all the people live a fearful life in their own society and combined these makes any country a miserable lot.

Chapter no-11, 'The Condition of India (Continued): Lawyers',

(Here Reader is implied as Question and Editor is Answer by Gandhi ji,)

**Reader**: You tell me that when two men quarrel they should not go to a law court. This is astonishing.

**Editor**: Whether you call it astonishing or not, it is the truth. And your question introduces us to the lawyers and the doctors. My firm opinion is that the lawyers have enslaved India, have accentuated Hindu-Mahomedan dissensions and have confirmed English authority.

Reader: It is easy enough to bring these charges, but it will be difficult for you to prove them. But for the lawyers, who would have shown us the road to independence? Who would have protected the poor? Who would have secured justice? For instance, the late Manomohan Ghose defended many a poor man free of charge. The Congress, which you have praised so much, is dependent for its existence and activity upon the work of the lawyers. To denounce such an estimable class of men is to spell injustice, and you are abusing the liberty of the Press by decrying lawyers.

**Editor**: At one time I used to think exactly like you. I have no desire to convince you that they have never done a single good thing. I honour Mr. Ghose's memory. It is quite true that he helped the poor. That the Congress owes the lawyers something is believable. Lawyers are also men, and there is something good in every man. Whenever instances of lawyers having done good can be brought forward, it will be found that the good is due to them as men rather than as lawyers.

All I am concerned with is to show you that the profession teaches immorality; it is exposed to temptation from which few are saved. The Hindus and the Mahomedans have quarreled. An ordinary man will ask them to forget all about it; he will tell them that both must be more or less at fault, and will advise them no longer to quarrel. But they go to lawyers. The latter's duty is to side with their clients and to find out ways and arguments in favour of the clients, to which they (the clients) are often strangers. If they do not do so, they will be considered to have degraded their profession. The lawyers, therefore, will, as a rule, advance quarrels instead of repressing them. Moreover, men take up that profession, not in order to help others out of their miseries, but to enrich themselves.

It is one of the avenues of becoming wealthy and their interest exists in multiplying disputes. It is within my knowledge that they are glad when men have disputes. Petty pleaders actually manufacture them. Their touts, like so many leeches, suck the blood of the poor people. Lawyers are men who have little to do. Lazy people, in order to indulge in luxuries, take up such professions. This is a true statement. Any other argument is a mere pretension.

It is the lawyers who have discovered that theirs is an Honourable profession. They frame laws as they frame their own praises. They decide what fees they will charge and they put on so much side that poor people almost consider them to be heaven-born. Why do they want more fees than common labourers? Why are their requirements greater? In what way are they more profitable to the country than the labourers?

Are those who do well entitled to greater payment? And, if they have done anything for the country for the sake of money, how shall it be counted as good? Those who know anything of the Hindu-Mahomedan quarrels know that they have been often due to the intervention of lawyers. Some families have been ruined through them; they have made brothers enemies. Principalities, having come under the lawyers' power, have become loaded with debt. Many have been robbed of their all. Such instances can be multiplied.

But the greatest injury they have done to the country is that they have tightened the English grip. Do you think that it would be possible for the English to carry on their Government without law-courts? It is wrong to consider that courts are established for the benefit of the people. Those who want to perpetuate their power do so through the courts.

If people were to settle their own quarrels, a third party would not be able to exercise any authority over them. Truly, men were less unmanly when they settled their disputes either by fighting or by asking their relatives to decide for them. They became more unmanly and cowardly when they resorted to the courts of law. It was certainly a sign of savagery when they settled their disputes by fighting. Is it any the less so, if I ask a third party to decide between you and me? Surely, the decision of a third party is not always right. The parties alone know who is right.

We, in our simplicity and ignorance, imagine that a stranger, by taking our money, gives us justice. The chief thing, however, to be remembered is that without lawyers courts could not have been established or conducted and without the latter the English could not rule. Supposing that there were only English judges, English pleaders and English police, they could only rule over the English. The English could not do without Indian judges and Indian pleaders.

How the pleaders were made in the first instance and how they were favoured you should understand well. Then you will have the same abhorrence for the profession that I have. If pleaders were to abandon their profession, and consider it just as degrading as prostitution, English rule would break up in a

day. They have been instrumental in having the charge laid against us that we love quarrels and courts as fish love water. What I have said with reference to the pleaders necessarily applies to the judges; they are first cousins; and the one gives strength to the other.

1. There was a serial named शक्तिमान (Shaktiman) aired on Doordarshan (India) it opening line was:

"अंधेरा कायम रहे, सम्राट किलविष की जय हो, उजाले का नाश हो, अँधेरे का राज हो ! ("Andhera kayam rahe, Samrat Kilvish ki jai ho, Ujale ka Nash ho, Andhere ka raj ho) :: "Let the darkness prevail, let Emperor Kilvish(killer with poison) be victorious, let the light be destroyed, let darkness reign."

It is unfortunate that Justice in India and internationally is being practiced as if it is supporting those who want to continue - "Let the darkness prevail, King Killers poison is great. Let the light vanish, Let the kingdom of darkness prevail). Alas! All this is in the name of law and order and providence of justice.

Currently in India (at present i.e. In 2024) five crore plus (5.1 Crores – 510, 00,000) cases are pending in different courts of India out of which eighty thousand plus (80,221) cases are in the Supreme Court of India. There are approx. one lakh eighty thousand (180,000) plus cases which are pending for the last thirty years. Beside this, a sufficient number of cases are pending in quasi-judicial court/agencies/tribunals etc. including CAT (central appellate tribunal).

Alas! Even with this large pendency there appears no botheration in the Supreme Court and government which can be said to be getting reflected by conference/seminars of wise one, discussion in the power corridor etc. One can easily check the concern toward solution and its whereabouts (if it's present in the system or not) with any senior lawyer, Judge, Member of parliament, Law minister and even if one has access to, then also with the Prime Minister. Does

this not prove the above saying and point out that the current judicial system is not able to impart justice?

2. There is a saying –कहावत है – "अंधेर नगरी, चौपट राजा–टके सेर भाजी, टके सेर खाजा, "Andher Nagri, Chaupat Raja–Take ser Bhaji, Take ser Khaja (Take ser = One paisa/rupees a kilo)" – इसका मतलब है कि जहां अन्याय होगा वहां किसी भी चीज़ की कोई कीमत नहीं होगी. This means that where there is injustice, nothing will have any value.

(Andher Nagari: This part translates to "dark city," symbolizing a place lacking clarity, justice, or order, the result is chaos and confusion in society, wherein sweets and vegetables will be sold at the same rate.

It also means: "an organization or a place with utterly 'suppressed/ repressed/ oppressed people who are gullible, yielding & non-reactive, virtually voiceless & gutless to even gross injustice; as if living in a veritable darkness & ignorance with an absurdly eccentric head/ruler with a paradoxical sense of weird justice/ given to doing travesty of justice"

Even today, if we look at the entire situation of the society and the country then it can very regrettably be said that the justice system is no different than how it has been described above, which categorically means that the judicial system is not healthy and not working primarily. If things are not going well, if gentlemen are not heard, the scoundrels have no fear, so called powerful can do whatever they want to, then it can be presumed that proper justice and maybe the proper system of deliverance of Justice is not in a place.

In the present system, the cost of approaching the court to get justice, uncertainty towards the time it will take to get the justice have become so much that the people started preferring to be with the injustice than go to the police station and complain. Because of this scenario, bribery by government officials (including Judges), extortion by police, and exploitation of people (work force) by manufacturing and service industries and house owners can be said to be rampant. Further, kidnapping, human trafficking, forced begging and prostitution are other activities which are flourishing because of improper justice delivery systems. Surprisingly, even in this scenario if one asks any

administrator they answer that the situation is under control and can say to be normal and everything seems to be going well?

3). It is saying that if the ruler becomes autocratic then the public automatically comes under control and remain so, this is was basic premises of governance by Ravan and Duryodhana, wherein few people used to be hanged regularly in full public presence which includes all relatives, even on any smaller activity which may appear (or can be interpreted) as action against the government to inculcate fear filled with terror amongst the public/citizens so that they remain obedient and subservient. This was the norm in India during British slavery.

Further, It is proven that if anyone desires to enslave the entire country for a long time then destroy the matrimonial religious sanctity and forces the entry of government machinery and its judicial system to intervene in it, that too in the name of its refinement, and the same was done in a much planned way in country like India. Present law to protect women sees women as sexual gratification objects and hence it is not taking care of sister, mother, daughter and other female relatives.

After independence, it can be said that due to multiple elections, consequential insecurity in the mind of each and every leader didn't allow these leaders to think of improving upon the judicial system of India as per its own tradition and testing (i.e. as per Dharma the Sanatana). Only thing the government in independent India has done is to put its seal on the slavery enhancing British rule under the local brand name e.g. Bhartiya Nyaya Sanhita etc.

Following is submitted: Submission includes –1. Toward actions for solution, 2. Different narratives/approaches toward providence of Justice (also education and health services), 3. What Dharma the Sanatana (Perpetual religion) devises,

#### 1. toward actions for solution:

- **1.A,** Surprisingly Tribal (Aadivasi-aboriginals) of India do not have any contention with regard to justice within their community and also in their dealing with other tribal communities. Maybe in place of condemning Tribal, we may like to relearn the lesson of Justice from them.
- 1.B), Deliverances of justice by government servants on the arguments of hired lawyers are a laughable stock and can only be appreciated for an enslaved country or for the country which wants to remain slave/subjugated or colonized. Business of justice and deliverance of justice on the basis of paper can be said to be the height of deterioration of any civilization.

At present (In 2024) as per the government of India the total number of pending cases of all types and at all levels stands at 5.1 Crores, (5,10,00,000) including over 180,000 court cases pending for more than 30 years in district and high courts and 80,221 cases are pending in the Supreme Court (January 2024). Alas! For such a large pendency of court cases nobody appears to have any clues of what to do or not to do? Does this not conclusively prove that the current judicial system is not able to impart justice?

If everybody is not only aware of the inefficacy of the country's judicial system but continuously suffering because of it, lost its cool, feeling helpless and hopeless, then is it not squarely/circularly the responsibility of the people who are supreme authority in the country (India) to get it corrected? As such this

These all countries (India Included where supposed to be parallel systems of freebee and chargeable are there in health, education and justice, appear to be diseased lot and their citizens and political leaders appear to be miserable, hopeless and helpless lot.

- (2.D), People by virtue of their basic faith want to be like that as enumerated above at (2.A), but currently obliged to follow the trend as mentioned at (2.B) and live like what is mentioned at (2.C), What is right or not will be a subject matter of individual judgments, but for entire society and country to choose and continue to follow these, we have to make conscious and collective decisions (either in line with our faith or in line with current market trends) which can best be taken not in parliament and court room but only by country wide referendum.
- 3. What Dharma the Sanatana (Perpetual religion) devises,
- (3.A), Faith/Dharma is the base on which any society, its structure or superstructure can be built and made sustainable. System and Practice which were made to sustain perpetually can say to be the foundation stone (basis) on which dharma Sansthan (religious institution) were made to function and carry on the activities of nature and human society (Problems in the society started when society neglected or ignored or omitted this basic premises that Faith/Dharma is the base and Rajniti (politics) is superstructure built on it. Over emphasis on GDP has given rise to increased imbalance, enhanced gap between poor and riches in society. Increase in theft and robbery, looting and naxalite activity etc. can be attributed to the excess importance of GDP. Such growth in ecology or economies is an indication of disturbance/imbalance. As such term GDP needs replacement with gross happiness ratio, where in GHR can be defined as a ratio

## Gross happiness ratio (GHR) = A/B

A: Total Expenditure on infrastructure, Strength building and maintenance, food, fitness, fashion and entertainment, reserve, research, development and decoration, benevolence etc.

**B**: Total expenditure on health, litigation, and so called moral preaching, crisis management and mortuary business.

Increased gross happiness ratio will provide a larger amount of life sustaining force to all of us.

When trends are upward, growth happens in infrastructure, food and fitness, diet and design, fashion and entertainment, reserve and research, development and decoration. When the trend is downward growth happens in health, litigation, and preaching and mortuary business.

**Question**: Why providence of social security is a must in any society and how can the same be ensured for every citizen of the country including its legitimate visitors and guests?

**Answer:** Following is submitted:

1. Whatever, whether it is true or just an apprehension but recent world-wide lockdown and havoc of pandemics has made one thing very clear, that even a single infected person can infect not only his/her family, but people in neighborhoods, then many in the locality, at their workplace, city and country. Further as there are no boundaries for flow of air and water hence a single person infected with virus living or dead has potential to spread the disease in the whole world.

Looking at this matrix, it has to be quite evident that if anybody wants to be healthy/disease free then it is in his/her own interest to ensure that all others in his/her house, building, neighborhoods, city, country and the whole earth should be healthy/disease free. In this way, it can be said that if one (individual, family, society, country etc.) is helping others in making them healthy and disease free then he/she is not obliging others but serving their own self – interest (and can be called even selfish society).

At this point it will not be an exaggeration to say that the understanding of the world is one like a large family has not come out of only because of magnanimity/compassion or benevolence but equally because of fear/danger/compulsion and thorough selfishness, so as to maintain oneself healthy and disease free.

2. Above scenario suggests that to ward off possible danger of spread of diseases we (society and government) must ensure providence of all the possible treatment along with other necessities like food, water, cloth and shelter to all the diseased irrespective of their credentials (like, one is citizen, guest or a visitor, have money/ resources/insurance or not etc.). This indicate that not only the treatment from diseases but all other things which can cause

one to lose immunity and fall sick or get diseased/infected like food, water, air, clothes, shelter, physical security, proper information, advice and guidance, entertainment, exercise cum fitness center and justice must be easily, timely and that of highest standard must be ensured to all without any precondition or post bindings.

3. Still further, it is a well-known and proven fact, that, birds and animals, fishes and fisheries, flora and fauna too can be a source of infection and consequential diseases, hence it is equally important that all the necessary life sustaining forces and sources like food and fodder, air and water for everyone along with facilities for treatment against any diseases and accidental injuries must be available to all the humans, birds and animals, fishes and fisheries, flora and fauna.

Looking at the above, it can be said that providence of the above is necessary and can only be provided by joint effort of society and government.

#### Annexure -C

Question: Many say that the problem we are facing in the country can be attributed to the basic understanding people/leaders have towards Rajniti (a Sanskrit word frequently used in India) vis. a vis. Politics (word of Latin origin frequently used in English speaking countries)? What can be its perspective for good governance?

#### Answer:

RAJNITI (POLITICS): The word politics has been taken from Greek, which means to police, basically a policing activity: It works under the set norms (law) finalized by some body, and even in difficulty hardly questions the sanctity of law. It is static in a dynamic world, or it is like running the government with a set of laws, which might have become dead. So called politics regards the law book as sacrosanct and in this working starts after taking oath of law book or constitution. In such a scenario the judiciary system feels handicapped or extra smart, and public; what to say-feels as heap of masses, unable to do anything, and passes their lives cursing everybody.

Rajniti, contrary to politics, is ethics of (Raj) government, and here ethics flows from ecology, environment, nature, (Niti, Niyamat se Aati Hai) and as such take natural action, remain dynamic, vibrant and lively.

We all understand that the word carries energy waves (Sabd word, is Brahm/world/cosmos) and we can attribute many ills of current politics on this very simple account

**Question**: What is Family? What is its significance in social and economic order? Where does the concept that the world is one large family come from?

**Answer:** Following is submitted:

**A.** Generally family is defined and accepted in many countries as a unit consisting of- Husband and wife with their unmarried son and daughter (up to age of twenty-five year).

**B.** In India they say that – People of blood relation (father, Uncles, grandfather, son and daughter, grand son and daughter) along with people of same clan which have participated in formation of blood relation (mother, grandmother, wife and daughter in law) whom one can see in his/her lifetime is called as Pariwar (Family).

Family is defined clearly in Ashram Vyavastha, It says that there are four ashrams of twenty-four years each in one's life (assuming human life to be of ninety-six years Say hundred) and so the total people one can see in his/her hundred years of life having blood relation and of same clan (Gotra) can be called Pariwar (family). To further elaborate it, at birth one can see/witness his blood relatives having age up to hundred years i.e. three generations before his parents (father of great grandfather) and then arriving at the age of hundred years the same person can see three generations (son/daughter of grandson) ahead of him. In this way people of seven generations, three before three ahead and one present generation of the person himself/herself constitute my Pariwar (family).

C. Along with it the relation formed by oath by me or my parents or my offspring are also part of my family e.g. sister, brother, son or daughter accepted by oath.

**D.** In India they say that members of my mother's parental home, my grandmother's parental home and members of my wife's parental home and so

on constitute a कुटुम्ब – (Kutumba – Larger Family). If we see this way, then we will find each of us are connected in some way or the other and so from here developed the concept and feeling of Vasudhaiva Kutumbakam – that the entire world is relative.

E. As per distribution of income/yield and corresponding responsibilities, it is said that out of earning of every hundred a youth earns, 25% belongs to parents (mother –father) as a repayment of finances and services they rendered during childhood and adolescent period, 25% to children's (Son and daughter), 25% to self (husband-wife) and 25% to society (local and national government) which inter alia will take care of grandparents beside taking care of basic requirement. Above distribution pattern is also applicable in case of adversities like absconding or death.

From above it can be inferred that, with the increment in either the number of constituents (like more children, multiple marriages, and more than two governing bodies) or share of any constituents (like more taxes) the fine balance of Pariwar/society/country gets disturbed and brings miseries.

**Question**: Can all the mess we are witnessing in the world be attributed to the failure of our basic understanding of economics? If it is so then why is it so? What all is needed to correct the same and How can a good economic system be built?

## Answer: following brief is submitted:

Can any economist of any country type, proponent of any economic model whatsoever, justify the presence of even a single slave, beggar, destitute and prostitute and then caging of birds and animals and then belittling growth of trees by making it a bonsai in any civilized society. Further, can any economists appreciate the depletion of forest cover, land filling of Water bodies and reduction in tree cover thereby increasing the pollution in Air and Water, affecting the purity of Food?

## Status of Economic theories in vogue:

All the economic theories so far known to have developed from the oldest 'Barter system' to Capitalism, to Communism, to Socialism, to Classical economic theory to the latest 'Neoclassical economic theory', couldn't sustain and have failed on one count or the other.

#### The reason for the failure of economics theories:

All these theories have failed, because none of these has taken care of basic tenets of Economy i.e. Eco system and its eternity/perpetuity.

## **Basic definitions of Economy:**

'Oxford Shorter' and Sanskrit dictionary gives the basic definition of the words: Eco, Nomy, Nomics, Economy, Economics, and in Sanskrit: Arth, Vyavastha, Shastra and Niti, Arth Shastra, Arthniti, and Arth – Vyavastha as given below:

Eco: Sound of environment or Ecology-Short form of Eco system.

Nomy: Laws, the natural law- which emanates from ecology. Nomics - Collection of methods, process, plan and results in writing.

Economy: Collection of Process, plan and methods of material (money) shifting in the environment.

Economics: is the science of the whole meaning-earning and ways of earning money and things which determines the value of an item or service makes it worthless, valuable or Invaluable.

Artha: i.e. means/method/process, meaning/relevance/purpose and money/material/wealth etc.

Niti (Ethics): Code of conduct, the Niti is that which comes from Niyamak (Nature), or like Ethics is that code of conduct which emanates from the environment/ecosystem.

Vyavastha: System of facilitation, management and administration by society or state.

Shastra: Collection of Path, Methods and result of its different transactions of a given time, space and energy, in writing as well as through Shruti and Smriti (saying and remembrance).

When one combines the above words it defines - Arthniti, Arth Shastra and Arth Vyavastha.

The great Chanakya defined Artha Shastra in sutra -15.1, as - The instinct of human beings is called -3<sup>2</sup> - Artha. Land united with humans is the Artha. The science that discusses the methods of its attainment and observance is called Arth Shastra.

The book/document: - "Alternate economy - Natural Systematic economy" can be said to be an economic treatise which suggests a future course of action taking care of all the ills of all these failed economic theories and have taken lead from the perpetual and sacred texts.

**Question**: What should be the pattern of distribution of Income, amongst members in family, country and society, which appears logical and fits well in long term rights versus responsible charts and can be a basis for a healthy, happy and sustainable social order?

## **Answer:** Following is submitted:

1. It is said that there is no free lunch in the world, and everybody has to pay for his/her lunch, either as postpaid, prepaid or against delivery to the service provider, which in this case is, select family members, Local Society and national government. Those who do not agree with this statement, question does arise, under what obligation, somebody else will pay for their lunch and that too for years together or for one's entire life? Question also arises: what can be the best system by which one can pay for his/her lunches of their entire life that is of childhood, adults, youth, senior citizens and of old age period?

As a common sense, it can be said that the amount of one's childhood period can only be paid in future, which will stay as a debt to the Parents (mother and father), society/religion/Dharma and government. Further the amount of old age can only be paid as an advance to family members, society and government. Still further, the amount incurred during adulthood/youth can be paid at the same time and moreover this is the period when one can pay his/her past payment (of childhood) to their family member and advance payment for his/her future lunches to family members (future generation – Son and daughter), society/religion (local government ) and national government.

2 Considering the above to be a guideline, and considering the average age of humans to be hundred years, what can be the best distribution patterns of money/services one receives or gives,' following which one can said to have paid for his/her lunches of entire life?

Can offering or having such a distribution system be not adored by religion/dharma or itself as per the dictates of Dharma?

It gives gender equality and equality to local management handled by society/religion and broader management by national government in shareholding. Does forgetting this distribution system is not an invitation to problems for all of us?

3. Calculation becomes easy if we take the optimum age of us to be a 100 years and then by taking this as percent wise than children (Son –Daughter) up to age of 25 years will receive 25%, of family income as a loan, Parents from age 51 – 75 will receive 25%, as loan repayment, self and spouse (26–50) 25%, and society and government as taxes 25% to take care of people of age 76 –100 years. (For details see chapter –17, Of Alternate economy).

**Question**: What can be the best economics to deal with the issues of providence of Health, Education and Justice in the society?

**Answer:** Following is submitted; submission is mainly in four parts – A, B, C and D.

**A.** "Everybody in his/her lifetime generally comes across a situation wherein he/she definitely needs rightful services of justice, health and guidance/education",

Recent outbreak of a worldwide pandemic and lockdown have made one thing very clear, that how a single patient can spread the disease not only in his/her family, immediate neighbours but also in entire country and maybe in the whole world, this suggests that if we want to live healthy and happy than it is necessary that country/society must ensures that all patients get (irrespective of their origin, caste creed, colour, gender, insured or uninsured, wealthy or poverty stricken, citizen or visitor etc.) timely and quality treatment.

If it is correct, then these services of best quality, if not kept fully free and easily accessible then chances cannot be ruled out that the needy and deserving candidate can get debarred from availing these basic services, which inter-alia cannot be considered a sign of a healthy and happy society and country. Similar is the case with the rightful services of Justice, Guidance/advice/education.

Above suggests that these services of the highest standard are required to be maintained round the clock at easily approachable places for everyone in the society including guests and visitors (without any ifs and buts).

This understanding combined/coupled with basic tenets of faith that "who so ever gives, begets) hence these three basic services of justice, health and education kept afloat from the funds contributed by society and post payment as a gesture of gratitude given by the beneficiary.

In the distant past these three (Justice, health and education) services were kept like this and were the norm of society not only in India but in most parts of the world.

**B.** There are also people who think that people give only when they need anything and when the needs become urgent and bigger people don't mind paying even higher.

Health, Guidance/education and Justice are considered to be basic three services which everybody will definitely need in his/her lifetime, hence, if anyone (individual group, society or country) wants to earn more money, then these three sectors can be said to be the best paymaster and profit earner.

This understanding coupled with basic doubt in everybody's mind that nobody comes back to pay, hence, these three services were commercialized.

**C.** There is still one more breed in the world, which claims to provide these services free to the needy and poor either through government support or through insurance but at the same time allowed business to run in these sectors and became a miserable, hopeless and helpless lot.

**D**. What is right or not can be a subject matter of individual judgment but for the country we have to make collective decisions may be by country wide voting.

**Question**: Does dharma (basic religion) offer a solution to the wide spectrum of problems we as mankind are facing?

## Answer: yes,

Following brief is submitted:

It says that Dharma is the only option. One can find all sorts of solutions in Dharma (basic, natural and perpetual religion, i.e. religion without any brand or prefixes and suffixes) and find solace from Dharma Sansthan(religious institutions) so created, as per the dictates of dharma. This is just because Dharma is the faith and faith is eternal.

Though the situation of Dharma and Dharma Sansthan has deteriorated but if one closely watches the surroundings then one can still find remnants (like praying in adversities, finding help in disaster) which point toward the fact that, Dharma is the only option available with mankind, only thing that, we have to resurrect the dharma and make dharma Sansthan operative.

it is being said that, if we are witnessing large-scale deterioration (in our day to day conduct with the self, with others and with nature) then one can be assured that large-scale churning/changes are about to come.

There should not be any iota of doubt in the mind of any one, with respect to the authenticity of the above statements as being said in "Gita" as below:

"यदा यदा हि धर्मस्य ग्लानिर्भवति भारत। अभ्युत्थानमधर्मस्य तदात्मानं सृजाम्यहम् ॥४-७॥ परित्राणाय साधूनां विनाशाय च दुष्कृताम् । धर्मसंस्थापनार्थाय सम्भवामि युगे युगे ।। ॥४-८॥" O' Bharat (Arjuna, the wise, the enlightened, entire world), whenever there is a ग्लानि (guilt/deterioration/melancholy/lassitude/remorse) of Dharma, I recreate myself for the restoration of dharma, for the protection of the sadhus (gentlemen), for the destruction of the wicked/evil doers and makes the establishment of religious institutions possible in ages.

Here one more thing can also be noted that sloka speaks of Dharma, without attaching any prefix or suffix (that is without any name attached to it like Hindu, Sanatana etc. which means basic dharma which is perpetual/eternal.

- 2. Faith/Dharma is innate and central to every being is being reflected by following words on our creation: –जन्म मृत्यु की परंपरा को बनाये रखने के लिए प्रत्येक जीव ममतामयी भवँर के गहरे गर्त में गिराया गया है , अध्यात्म रामायण –बाल्मीकि ", ("To maintain the tradition of birth and death, every living being has been thrown into the deep vortex of the affectionate world, "Valmiki- Adhyatma Ramayana".
- 3. What can be the best governing system? In an international conference on the subject, one eminent speaker opined: "If anyone out of us at any moment in our life becomes weak and helpless, destitute or desolate, what will be our expectation at that time from the government. Any government which is able to fulfill our expectations at that point of time can be said to be a good government.

In all practicality, it is observed that people in their deep desperation and helplessness remember the god. It is being said that if the government of that place is able to take entire care of that person then that government can say to be best, having godly (divine) having all the content of dharma in it. Above are excerpts from book: "Alternate Economy",

#### It is said:

When dharma is forgotten, ism arises.
When sages are ignored, celibacy arises,
When old and wise are sidelined, information arises,
When health is forgotten, medicine arises,
When synergy is broken, yoga arises,

When ethics is ignored, confusion and chaos arises,
When harmony and rhyme is broken, diplomacy and brevity arise,
And arise the bundles of loyal forces and minister,
Appearance of various qualities, is not the disappearance of larger order?

**Question**: We hear a lot of hue and cry for Rama Rajya (gods governance), especially in spiritual circles. It is being said that Ram Rajya (Governance of Rama, governance by Rama and governance like that of Rama) can be said to be best, if it is so, what is its broader perspective?

## **Answer:** Following is submitted:

1. It is said that when God deciphers then even the devil obeys. It is further said that when one wants to pray in a temple if having honest intention than even Satan suggests the route. There is nothing incidental, accidental or accidental in nature; everything is consequential.

Though, everybody will have their own story to narrate towards the establishment of Rama Rajya (gods' governance or divine aristocracy) but this can be said to be an outcome of our collective consciousness.

2. In this increasingly intertwined world it will be immature to say that any system more so that of like 'Ram – Rajya' can be established and allowed to work in isolation in only one country like that of India, which inter alia means that the system of Ram Rajya will simultaneously be implemented in most part of the world.

It is quite natural that such a system can be implemented only after the pacification of countless mafia groups (of media, arms, energy, Pharmacy, education, natural and renewable resources, religion, etc.) Operate under the guise of national and international power centers. Hence it is for sure that the first step towards the establishment of Ram Rajya will bring upheaval across the country and world, (whether one likes it or not).

3. What is so peculiar of Rama Rajya, that almost all the wise ones amongst old, then all Saintly and pious persons (male and female both) talk good of Ram Rajya and wish to have the same even now, hence the obvious question arises, whether it is the Rama himself as a King (Head of State/country) or it is system of governance, which is important?

**4.** Most important feature of the Ram Rajya was its system of distribution of income/yield [(amounting to 12.5% each) amongst family members (Son and daughter, self and spouse, mother and father) and amongst society (Dharma – Sansthan i.e. a center of local management) and kingdom/country (a center of national management)] and system of distribution work/responsibility in the family, society and country.

This feature brought gender equality, clear demarcation of work as per one's age and liking which is primary to any good governance, hence the Ram Rajya could establish itself as a model of best government, and one can think of, desire and aspire for.

- **5.** Above requires Resurrection of Dharma and establishment of Dharma Sansthan, which, with the completion of consecration ceremony of Rama can be expected to take place first in India and then the whole world.
- 6. In any resurrection known so far, first priority is being given to the initiation of providence of physical security of society by the society itself instead of police and Army only and that of national security, by society as well as by police and army (current security is quite inadequate, not even one percent of population as against six percent recommended by scriptures.

Basic details of this count, the direct employment it can generate to eight crore of youth in India with sufficient honorarium are given in the topic: Economics of War, economy because of war and economic warfare, of book – Alternate economy.

7. It is well known fact, that when we were weak, many a bacteria, viruses, looters, cheater, robbers, bully, attackers, kingdom expansionists and religious conversionist missionaries etc. take advantage of us, enslave us, and leave us divided and infighting on one reason or the other, like region, religion, caste, class, tribe, language, gender etc., so that they can continue to take advantage of us and misguide us so that we can ever become able to stand upright.

What is surprising here is that all of us know that foreigners, who attacked India, forcibly made few of its children as Christian and Mohammedan, and now instead of joining hands, finding ways and means for their common growth and happiness, are busy in extending jealousy, hatred and even infighting? Can erstwhile Britishers have a better proposition than this to safeguard themselves of revenge?

- **8.** It is said that as is the food so is the mood, and as is the water (liquid) so is voice and as is the intoxication so is one's condition. In the downfall of India, deterioration in the quality of its food, water and intoxicants played a major role and unfortunately are still allowed to play the negative role (For details, refer topic: Bullish economy of beef and economics of cow and castrated Ox).
- **9.** In the spiritual circle, it is being said that the current era is Kalyuga, which is also known as dark/black age like night wherein all the masters of cunning arts and black magic appears, hence it is always prudent to have optimum security at local as well as national level.

Now, as the foundation of resurrection of Dharma and establishment of Dharma Sansthan has already been laid down in Ajodhya, and lord Rama resumed his charge so there is nothing to be worried about, while performing our duties.

**Question**: From above question arises, if above can be said to be true, then do we need Resurrection of Dharma (basic religion) and Dharma Sansthan (religious institution)?

Answer: What each one of is missing in the society is the availability of basic social security, that is assurance of security by society even when one is left alone in a remote location, which comes when society is able to provide physical safety, security of food, water, shelter, clothing, health, guidance and justice etc. This is to say that the basic religion (Dharma) and its institution which is supposed to take care of basic needs of the society got defunct.

1. Few say that this deficiency in the availability of social security has started with the onset of this era itself and is its main characteristics; this is why it is known as 'dark age - black age - blind age or machine age or kala yug (typical feature of night).

It is said that, this era is about to complete and a new era of light is about to appear, hence there no need for much botheration, however leaders and warriors needs to be very careful to avert any chance of apocalypse, which can be wrongly be thought of by the current world powerful block. It is said in such scenario only those survive whose social security net is intact,

2. In addition to above it is also being said that every journey in each era/civilization begins from the religious corner or seed of any civilization can be seen in its religious upbringing, and as such this utter disregard to social security by one and all can be attributed to the deterioration of Dharma.

It can be easily observed that the current religious preachers, teachers in educational institutions and motivational speakers are found to be promoting individualism rather than of both that is individual participation and collective wellbeing.

3. If we look at India then as per its official figure eighty crore of its people found to be poor, receiving free ration from the Prime-minister Garib Kalyan yojna (PMGKY), On the other end, the situation of riches, royals and religious head tells a different story of their rise and fall, at one point they were found to be dictating terms to society and at another found to be either running away from the country, or dying in utter loneliness or suffering in jail.

Both the above indicate that the role of society and that of Dharma has been reduced to naught, hence it is in the interest of each one of us to come out and co-operate in the process of Resurrection of Dharma.

Above is submitted,

**Question**: How can we (Society and government) provide employment to all the youth and respectable engagement to all the elders, so as to solve the problem of unemployment as well as that of loneliness?

**Answer:** Following is submitted:

Providence of employment is the responsibility of the society and not that of government, as it is the societies which have evolved the formation of the government itself and not vice versa.

1. Problem in the society started when society neglected/ignored/omitted the Basic premises that faith (dharma) is the base, on which superstructure of Rajniti- governance is erected upon.

Since, Dharma is a base, hence, it is ought to be the dharma which has to take care of the entire basic and local work of the economy of the entire society in its entirety.

- 2. Paradigm shift is necessary, it is a time for the society to rise up and once again take up the responsibility in its hand. Country like India can very well be managed by the national government and Society driven/managed local government.
- 3. Following are few areas where in employment in large numbers can be generated:

**A.** Collection of remnants/wastage of pre-cooked food (of vegetables etc.) and remnants of cooked food after eating are basically food to animals and birds only if served to them within two - three hours otherwise it becomes garbage (only fit for flies, insects, mosquitos, bacteria and viruses.

This indicates that if we arrange a collection of remnants precooked and post cooked food three times a day from each house then we cannot only solve problems of accumulation and disposal of garbage but will also be able to arrange foods to pet animals, birds and fisheries to a very large extent. This will also improve cleanliness and hygiene and reduce the medical bills of any city.

This activity of collecting the pre-cooked and cooked three times a day will require additional manpower. Rough calculation suggests that if one person can collect food waste from two hundred houses, then for 130 crore Indians we will be requiring  $\sim$  population- 130/6 person per house  $\times$  200 (houses one person is sufficient) = 1.05 crore people will be required to cater this need on addition to what is available right now.

**B.** There is a real problem to find a clean and hygienic urinal, toilet and bathrooms for boys and girls, young male and women and senior citizens at any public place.

This issue can be sorted out by opening up of use and pay modeled society driven/maintained multilevel urinals, toilets and bathrooms in all these locations which may have facility of clock room, smoking room, fresh water for drinking, soaps for washing hand, sanitary napkin, towel etc. This area offers good business opportunities (even for big brands) and will generate sufficient employment.

C. As per Book "Alternate economy", topic –Economy of media and management of economy by media, it can be appreciated that in order to provide entertainment security in the society at least six percent of its people must be fully engaged in difference aspects of entertainment (singing, dance music, mimicry, management of place, logistics, other paraphernalia etc.), that means a direct engagement/employment to approx. eight crore people needs to be arranged by the society through its own resources (In India as per data's available in year 2024).

Entertainment security is needed to avoid dependence/addiction of entertainment through electronic media only.

- **D.** As per the topic Economics of eco system, it can be appreciated that in order to manage afforestation and tree cover and to offer security of drinking water in the society at least one percent of people must be engaged in these activity which means this area, which means society needs to arrange employment to one crore thirty lakh people (In India as per data's in year 2024) through its own resources.
- **E.** Providence of employment is the responsibility of the society and not that of government, as it is the society which forms the government and not vice versa.
- **E.1.** They says that business is nothing but a photocopying (of some original product, services and procedure developed by some agency). Generally it happens, when the business flourishes we forgot to take care of the originals and just because of this disregard to the original major problem arises when the business gets defaulted.

In such circumstances, it is advised to look into the originals and re-establish business instead of going berserk or closing down the business. Similar is the case with the society and its business and transactions.

**E.2.** When loan, mortgage, non-performing assets and insolvency are talked about in business and when prostitution, pornography, alcoholism, alms, charity, philanthropy and begging are talked about in society, then it can be said that society got tripped.

This situation is getting authenticated when India is bound to give monthly free ration to its sixty percent population (80 crore) from the Prime Minister garib kalyan yojna (PMGKY). Situation like this warrants us to look at the originals of society that how they designed the system.

- **E.3.** it is said that Tribal also known as aboriginals, aborigines are the original and civilized world is a superstructure built on it or built taking lead from these originals.
- **E.4.** It can be noted even today that though every tribe is trained to take care of entire work but work is broadly divided in four category (as per need of the tribe and interest of individual) which is further subcategories in four group as per the age of the person.
- **E.5.** Civilised society taking lead from here divided the societies work in four categories as safety and security, education and training, collection of material, its storage and distribution and all other work including support services to these three categories.

Further, looking at this, Civilised world (society), considering the average age of human to be of hundred years subdivided each group as per the age in four categories.

- **E.6.** If we take one example of security than it can be said that one fourth of India's population must be involved in the providence of safety and security and out of this one fourth must be given charge of field work that is like what police personnel do in the society, that is 1/16 of 130 cores people must be given employment in security.
- **E.7.** If we look at its financial side from the 22-23 budget of India, the parallel economy and salary of private security personnel then it comes out to be just 18.25% of the total expenditure country incurred in a year (for detail refer above link).

That is, employment to eight crore youths can easily be given (in India, in the year 2024).

F. Industrialization for the sake of industrialization has ruined many a country and deprived the humans from their basic activities and made them jobless and lonely at the lower income bracket of society, and at higher income bracket of

society it rendered people obese, unhealthy, crippled, lonely and even quarantined.

- **F.1.** There is a need for some basic and firm demarcation in the society, regarding the use of electrically/battery/gasoline operated machines, for example, for over all hygiene grinding, cutting, slicing of food items needs to be done by manual methods only and to be restricted/abandoned to be done by electrically/gasoline operated machines.
- **F.2.** Wisdom suggests, "Primary work has to be physical, secondary work has to be semi/partly mechanized, tertiary work has to be technologically driven and other advance stage to be automatic (food making for self and society, thread making for clothing is to be physical, processing of food to be semi mechanical, packing is to be technologically driven. Whereas any specialized and advanced testing e.g. soil testing), extraction, mixing, communication can be automated.
- **F.3.** It can be easily established that by our conscious and collective decision in selective restriction in the use of electrically and gasoline operated machineries, and by reopening the sectors for traditional methods, we can create a large number of employment for youth and respectable engagement for people suffering with loneliness.

**For example**: Basic calculation (for the year 2021–22) for Wheat flour –Atta, as per data's PTI dated 09.05. 22, indicates the following:

\*Government buying rate - Rs.19.75/Kg

\* The average price of Atta in market: Rs. 32.91 per kg, whereas maximum retail price of Atta stood at: Rs. 59/kg, (2021–22)

* Minimum difference ~ 32.92 - 19.75= Rs.13/
Max. Difference ~ 59 - 19.75 = Rs 39/
```

- \* Average quantity of wheat one can manually grind 20 kg per day by working five hours a day
- \* Average earning per person per month~ 20 kg imes 13 Rs imes 30 days = Rs 7800/

\*\*Wheat consumption in India –103.5 MMT, Man days required to grind 103.5 MMT ~103.5  $\times$  1000000  $\times$  1000 kg  $\div$ 20 kg  $\times$  365 days = 141780822 man days

# \* Monthly requirement of man power ~

141780822 man days  $\div 12 = 11815068$ /, That is a regular employment to one crore eighteen lakh plus people with an average income of Rupees seven thousand eight hundred per month/person can easily be given.

**F.4.** Besides employment, this switching over of grinding of wheat from electrically operated to manual grinding have multiple other health advantages to the doer as well as to the eater, just because of manual grinding to be a low pressure, low temperature and a low RPM grinding. Above is brief on employment.

**Question**: What can be guiding principles of Cleanliness and hygiene in good governance?

**Answer**: Following is submitted for perusal and possible actions by each one of us individually as well as collectively:

1. God resides in the heart of a clean and hygienic person, family, society, country is true but a half statement, another half is goodness keeps on abandoning, avoiding and escaping dirty and unhygienic surroundings(whether it is of an individual, family, country and society.

It can be said that, if one got faded up with the richness, luxuries, comforts of life, one can start discarding cleanliness and hygiene at personal level and accord cleanliness and hygiene a low key affair in the family and its surrounding, then diseases, discomfort followed by poverty and even slavery need not to be tried for, but will automatically arrive at.

- **3.** System of 5S which is "everything in its place and place for everything, each time and every time and its recorded standardization" need not to be restricted to the industrial world only, but deserve to be extended to our other deeds as well.
- **4.** In nature, the eagle eats the fresh whereas vulture eats the dead, the problem starts when vultures get eliminated and carcasses remain open to decompose.

It is said that Vultures got extinct/dead by eating flesh of dead buffaloes/cows whose flash got slowly poisoned because of overdoses of oxytocin( which generally every milkman inject while mulching cow clan.

- **5.** Everyone in nature when interacting with each other our prayer, thought and action supposedly to be directed towards our sustainability, for example: when we are drying out cloths, our prayer can be: "let the water of the river go into the river, let our clothes get dry", that is to say that "Healing the healer, by respecting five elements, i.e. space, water, air, fire and earth, will have to be our basis of interaction with environment and ecology.
- **6.** As the noise troubles the heart and blurs the mind, hence, the society has to keep check and balances of all the people and institutions creating noise.
- **7.** Society needs to ensure proper upkeep of the ecosystem and arrange for proper entertainment.

It is expected that by doing the above, society and country can march towards ensuring a clean and hygienic environment leading toward establishing good governance.

**Question:** What exactly can say to be the interpretation of the word "India – Hindustan – Bharat", what relevance these words/terms have for a good governance?

**Answer:** Following is submitted:

- 1. India, also known as Bharat, is a Sovereign Socialist Secular Democratic country with a parliamentary system of government.
- 2. In spite of the above broad description, we are witnessing sloganeering about India, either being a Credible and Incredible country, or of a Hindustan being a Hindu country or of Bharat that is fully religious (Dharma nirpeksh) country is and what it means to be.

All these slogans are putting question on our basic identity itself hence it will be prudent of us to forward this discussion with historical details rather than being whimsical and become partner in creating chaos in the country.

- **3.** Questions are being asked, Is Bharat an idea or is it just a land mass, or it signifies something else, or is it a blend of words, or is it an acronym or an adjective or a verb or Bharat is name given or it is the title earned or assigned to it?
- 3.1. The oldest reference to the term Bharat (which is still being recited upon today at the culmination of special prayer/Yajna) comes in the term "Jammu–dwipe:: Bharat–khande (जम्मू द्वीपे भारत–खंडे) and said to reflect entire earth to be Bharat.
- 3.2. Many in last few thousand years have appreciated "Hindustan Bharat as an area flanked by river Sindhu and Brahmaputra between Himalaya and Indian Ocean and referred this area as a Land of God or Gods land/land of Brahma and its children inhabitant as Hindus and Brahmaputra's (सिध्/हिन्दु एवं ब्रहमपुत्र).

- 3.3. It can be said that the Bharat is a title earned because of the work it has done to lighten the masses and enlighten the classes. The name "Bharat (Bha light and rat busy, भारत (भा = प्रकाश, रोशनी, ज्योति, रत= व्यस्त, संलग्न) प्रकाशित करने के कार्य में व्यस्त) has come because of it quality and its efforts to enlighten the mankind,
- 3.4. The name "Hindustan' and 'India' has been assigned to it by others from the common source 'Sindhu like: (1). 'Sindhu-Hindu Hindustan' (सिंधु-हिन्दू-हिंदुस्तान), (ii), 'Sindhu"– "Indu' 'India' (सिंधु-इदु-इंडिया),
- **3.5.** The word Bharat has also been referred in Gita in one of its most famous sloka-

यदा यदा हि धर्मस्य ग्लानिर्भवति भारत

(Yada yada hi dharmasya glanir bhavati Bharat,

Abhyutthanam dharmasya tadatmanam srijamayam), 4.7II

Here Bharat is being used to address wise/enlightened and world.

Here one more thing is to be noted that the great/Sacred texts speaks of Dharma) without attaching ant string to it (as prefix or suffix) including that of Sanatana or Hindu.

**4.** It is said that the "Hindi- Hindu and Hindustan are Apbhransh (corrupt version) of 'Sanskrit-Sanatana Dharma and Samsara/Bharat.

Even today every Indian associated himself mire with "Sanskrit, Sanatana Dharma and Bharat than the connotations like Hindi- Hindu and Hindustan".

Above is trouble, it may be because of our disconnection with our root that is basic religion or maybe not? Will it not be proper to have a broader discussion?
